

TRADE AGREEMENT BETWEEN THE GOVERNMENTS OF THE REPUBLIC OF SOUTH AFRICA AND SOUTHERN RHODESIA.

Negotiations have taken place between the Governments of the Republic of South Africa and Southern Rhodesia directed to the regulation of trade between the countries. The text of the Agreement is appended.

This Agreement was entered into on the 30th November, 1964, in terms of section *seventy-four* of the Customs Act, No. 55 of 1955, and shall come into force on 1st December, 1964.

HANDELSOOREENKOMS TUSSEN DIE
REGERINGS VAN DIE REPUBLIEK VAN
SUID-AFRIKA EN SUID-RHODESIË.

Onderhandelings het plaasgevind tussen die Regerings van die Republiek van Suid-Afrika en Suid-Rhodesië met die oog op die regulering van die handel tussen die Republiek en Suid-Rhodesië. Die Ooreenkomsteks is aangeheg.

Hierdie Ooreenkoms is op 30 November 1964 aangegaan kragtens artikel *vier-en-sewentig* van die Deceanwet, No. 55 van 1955, en sal op 1 Desember 1964 in werking tree.

TRADE AGREEMENT BETWEEN THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA AND THE GOVERNMENT OF SOUTHERN RHODESIA

The Government of the Republic of South Africa and the Government of Southern Rhodesia, recognising that it is desirable that trade between their respective countries should be as free and uninterrupted as possible and being desirous of continuing and improving the traditional trading relations between them, have agreed as follows:—

ARTICLE 1

In this Agreement, unless inconsistent with the context—

“ Republic ” means the Republic of South Africa and the territory of South West Africa;

“ Rhodesia ” means Southern Rhodesia;

“ party ” means a party to this Agreement, namely, the Government of the Republic or the Government of Rhodesia;

“ certificate ” means a document describing goods specified in Parts IV, V, VI and VII of Annexure B, stating their quantity and value, and signed or countersigned by or on behalf of the Secretary for Trade, Industry and Development of the Government of Rhodesia;

“ Column C rate ” means the rate of duty applicable to the goods concerned, from time to time, in terms of Column C of Part II of the Customs Tariff of Rhodesia;

“ Column D rate ” means the rate of duty applicable to the goods concerned, from time to time, in terms of Column D of Part II of the Customs Tariff of Rhodesia;

“ duty ” means any duty, other than a dumping duty or a countervailing duty, payable in the country of either party on goods imported into that country;

“ licence ” means a licence or permit, issued in writing by or on behalf of a party, giving conditional or unconditional authority to import goods into or export goods from the country of that party;

“ most favoured nation rate ” means the most favoured nation rate of duty applicable to the goods concerned, from time to time, in terms of the Customs Tariff of the Republic;

“ produced ”, in relation to goods, includes grown or manufactured;

“ rate of duty ” includes free of duty;

“ Rhodesian content ”, in relation to manufactured goods, means that portion of the factory or works cost of such goods which is represented by the cost of labour performed in Rhodesia or of the materials produced and labour performed in Rhodesia;

“ % ” means per cent. *ad valorem*;

and cognate expressions shall be construed accordingly.

ARTICLE 2

Except where otherwise provided, the provisions of this Agreement shall apply to goods produced in the country of either party and entered for consumption in the country of the other party on and after the date of coming into operation of this Agreement.

ARTICLE 3

Goods produced in the country of one party and specified in Annexure A shall not be imported into the country of the other party, except under import licence. When such goods are so imported, they shall, in accordance with the provisions of that Annexure, be admitted at the rate of duty specified in that Annexure.

ARTICLE 4

A total quantity of 2,000,000 pounds in weight of flue-cured Virginia-type leaf tobacco, sold on the tobacco auction floors in Rhodesia shall be admitted into the Republic free of duty during each calendar year.

ARTICLE 5

(1) Subject to the provisions of this Article and the conditions set out in Annexure B, goods produced in Rhodesia and specified in that Annexure shall be admitted into the Republic at the rate of duty specified for such goods in that Annexure:

Provided that, after not less than twelve months from the date of commencement of this Agreement, or when the manufacture of cellulosic staple fibre has commenced on a commercial scale in the Republic, whichever shall be the later, the Government of the Republic, after consultation with the Government of Rhodesia, may exclude textiles and clothing containing not less than twenty-five per cent. by weight of such fibre from the concessions provided in Annexure B.

(2) Goods produced in Rhodesia and specified in Parts IV, V, VI and VII of Annexure B shall not be admitted into the Republic at the rates of duty provided in those Parts before 1st January, 1965, and shall not be so admitted unless a certificate is produced to the authorities in the Republic in which a value not less than the value for duty purposes, and a quantity not less than the quantity, of the goods concerned, is specified.

HANDELSOOREENKOMS TUSSEN DIE REGERING VAN DIE REPUBLIEK VAN SUID-AFRIKA EN DIE REGERING VAN SUID-RHODESIË.

Aangesien die Regering van die Republiek van Suid-Afrika en die Regering van Suid-Rhodesië besef dat dit wenslik is dat die handel tussen hul onderskeie lande so vry en onbelemmerd as moontlik behoort te wees en aangesien hulle begerig is om die tradisionele handelsverhoudinge tussen hul onderskeie lande voort te sit en te bevorder, het hulle soos volg ooreengekom:

ARTIKEL 1

In hierdie Ooreenkoms, tensy onbestaanbaar met die samehang, beteken:

- „ Republiek ” die Republiek van Suid-Afrika en die gebied Suidwes-Afrika;
- „ Rhodesië ” Suid-Rhodesië;
- „ party ” ’n party by hierdie Ooreenkoms, naamlik, die Regering van die Republiek of die Regering van Rhodesië;
- „ sertifikaat ” ’n dokument waarin die goedere gespesifiseer in Dele IV, V, VI en VII van Aanhangaal B beskryf is, waarin die hoeveelheid en waarde daarvan aangetoon is, en wat deur of namens die Sekretaris van Handel, Nywerheid en Ontwikkeling van die Regering van Rhodesië onderteken of medeonderteken is;
- „ kolom C-koers ” die regkoers wat van tyd tot tyd ooreenkomstig kolom C van Deel II van die Doeane tarief van Rhodesië op die betrokke goedere van toepassing is;
- „ kolom D-koers ” die regkoers wat van tyd tot tyd ooreenkomstig kolom D van Deel II van die Doeane tarief van Rhodesië op die betrokke goedere van toepassing is;
- „ reg ” enige reg, behalwe ’n dumpingreg of ’n kontrareg, wat in die land van enigeen van die twee partye betaalbaar is op goedere wat in daardie land ingevoer word;
- „ licensie ” ’n skriftelike lisensie of permit, uitgereik deur of namens ’n party, waarin voorwaardelike of onvoorwaardelike magtiging verleen word om goedere in te voer in, of uit te voer uit, die land van daardie party;
- „ mees-begunstigde-nasiekoers ” die mees-begunstigde-nasiekoers wat van tyd tot tyd ooreenkomstig die Republiek se doeane tarief op die betrokke goedere van toepassing is;
- „ geproduseer ”, met betrekking tot goedere, ook gekweek of vervaardig;
- „ regkoers ” ook vry van reg;
- „ Rhodesiese inhoud ”, met betrekking tot vervaardigde goedere, daardie gedeelte van die fabrieks- of werkekoste van sodanige goedere wat verteenwoordig word deur die koste van arbeid in Rhodesië verrig of van die materiaal in Rhodesië vervaardig en van die arbeid aldaar verrig;
- „ % ” persent *ad valorem*;

en sal verwante uitdrukings dienooreenkomstig uitgelê word.

ARTIKEL 2

Uitgesonderd waar anders bepaal, is die bepalings van hierdie Ooreenkoms van toepassing op goedere geproduseer in die land van enigeen van die twee partye, en wat die land van die ander party op of na die datum waarop hierdie Ooreenkoms in werking tree, vir verbruik in daardie land binnekom.

ARTIKEL 3

Goedere geproduseer in die land van een party en gespesifiseer in Aanhangaal A mag, uitgesonderd kragtens invoerlisensie, nie in die land van die ander party ingevoer word nie. Wanneer sodanige goedere aldus ingevoer word, word dit ooreenkomstig die bepalings van daardie Aanhangaal toegelaat teen die regkoers in daardie Aanhangaal gespesifiseer.

ARTIKEL 4

In Totale hoeveelheid van 2,000,000 pond gewig oondgedroogde blaartabak van die Virginiese tipe wat op die tabakveilings in Rhodesië verkoop is, word gedurende elke kalenderjaar vry van reg in die Republiek toegelaat.

ARTIKEL 5

(1) Onderworpe aan die bepalings van hierdie Artikel en die voorwaardes vervat in Aanhangaal B, kom goedere wat in Rhodesië geproduseer en in genoemde Aanhangaal genoem is, die Republiek binne teen die regkoers wat in genoemde Aanhangaal vir sulke goedere gespesifiseer is:

Met dien verstande dat, na verloop van minstens twaalf maande na die datum van inwerkingtreding van hierdie Ooreenkoms, of wanneer ’n aanvang gemaak is met die vervaardiging in die Republiek van sellulosiese stapelvesel op ’n kommersiële skaal, watter datum ook al die laatste is, die Regering van die Republiek na oorlegpleging met die Regering van Rhodesië, tekstielstowwe en klerasie wat volgens gewig minstens vyf-en-twintig persent van sodanige vesel bevat, van die konsessies waarvoor in Aanhangaal B voorsiening gemaak is, kan uitsluit.

(2) Goedere geproduseer in Rhodesië en in Dele IV, V, VI en VII van Aanhangaal B gespesifiseer, mag nie die Republiek voor 1 Januarie 1965 teen die regkoers waarvoor in genoemde Dele voorsiening gemaak is, binnekom nie, en mag nie aldus binnekom nie, tensy aan die owerhede in die Republiek ’n sertifikaat getoon word waarin ’n waarde wat nie minder nie as die waarde vir regtedoeleindes, en ’n hoeveelheid wat nie minder nie as die hoeveelheid van die betrokke goedere moet wees, gespesifiseer is.

(3) In calculating a period of time mentioned in Parts IV, V, VI and VII of Annexure B, the first such period shall begin on 1st January, 1965, and each subsequent period shall begin on the day following that on which the preceding period ends.

ARTICLE 6

(1) With the exception of goods for which another rate of duty is provided in Article 3 or paragraphs 2 and 3 of this Article, goods produced in the Republic shall be admitted into Rhodesia at the Column C rate.

(2) Goods produced in the Republic and specified in Annexure C shall be admitted at the rate of duty specified in that Annexure, subject to the conditions set out therein.

(3) When piece goods produced in the Republic and specified in item 76 of Part II of the Customs Tariff of Rhodesia—

- (a) are entered under rebate granted, in terms of the Customs and Excise laws of Rhodesia, for the clothing manufacturing industry; and
- (b) are used in accordance with the terms of and for the purpose specified in the relevant rebate provisions of the Customs and Excise laws of Rhodesia; such piece goods shall be admitted at the rebated Column D rate.

ARTICLE 7

Rough and uncut diamonds produced in the Republic and exported to Rhodesia shall be free of export duty if certified as being for industrial use in Rhodesia by an official of the Government of Rhodesia.

ARTICLE 8

Subject to such other conditions as are provided elsewhere in this Agreement, manufactured goods shall be deemed not to fall within the terms of this Agreement—

- (a) in the case of clothing manufactured in Rhodesia and specified in Parts III and IV of Annexure B, unless the Rhodesian content of such clothing is not less than twenty per cent, and all the operations such as cutting and sewing required to manufacture such clothing from piece goods have been performed in Rhodesia; and
- (b) in the case of other goods manufactured in Rhodesia, unless the last process in the manufacture of such goods has taken place in Rhodesia and the Rhodesian content of such goods is not less than twenty-five per cent.; and
- (c) in the case of goods manufactured in the Republic, unless the last process of manufacture has been performed in the Republic and they—
 - (i) contain not less than such proportion of the material and labour or of the material or labour of the Republic; and
 - (ii) have been subjected to such process of manufacture in the Republic; as may be determined from time to time, for the purpose of the rebates provided in the Customs Tariff of Rhodesia for goods manufactured in the countries specified in paragraph 1 of Part III of that Tariff.

ARTICLE 9

(1) A party may impose dumping duties on goods produced in the country of the other party.

(2) A party may impose countervailing duties to offset subsidies granted, directly or indirectly, in respect of goods exported from the country of the other party.

(3) A party, when requested by the other party to assist in the investigation of an allegation of dumping, shall provide all possible assistance in such investigation.

ARTICLE 10

If a party introduces a duty of excise or surtax applicable only to goods produced in its country or increases a duty of excise or surtax already imposed only on goods produced in its country, it may simultaneously levy on similar goods, produced in the country of the other party, a duty equivalent to the new or increased duty of excise or surtax.

ARTICLE 11

The parties agree to adopt, as far as possible, similar customs measures and procedures to encourage tourism.

ARTICLE 12

Except as provided elsewhere in this Agreement, quantitative import and export restrictions other than those in force at the date of commencement of this Agreement shall not be imposed upon the movement between the countries of the parties of goods produced in those countries:

Provided that, after consultation between the parties, a party may impose—

- (a) import restrictions on agricultural or fisheries products, or on products which can be directly substituted therefor, necessary to the enforcement of governmental measures which operate—
 - (i) to restrict the quantities of the like domestic product permitted to be marketed or produced; or
 - (ii) to remove a temporary surplus of the like domestic product; and

(3) By die berekening van 'n tydperk genoem in Dele IV, V, VI en VII van Aanhangel B, begin die eerste sodanige tydperk op 1 Januarie 1965 en begin elke daaropvolgende tydperk op die dag na die datum waarop die voorafgaande tydperk eindig.

ARTIKEL 6

(1) Met uitsondering van goedere waarvoor 'n ander regkoers in Artikel 3 of paragrave 2 en 3 van hierdie Artikel voorgeskryf is, word goedere wat in die Republiek geproduseer is, Rhodesië teen die kolum C-koers binnegelaat.

(2) Goedere wat in die Republiek geproduseer en in Aanhangel C gespesifieer is, sal binnegelaat word teen die regkoers in daardie Aanhangel gespesifieer, onderworpe aan die voorwaardes daarin uiteengesit.

(3) Wanneer stukgoedere wat in die Republiek geproduseer en in item 76, Deel II, van die Rhodesiese doeannetarief gespesifieer is—

(a) ingeklaar word onder korting ingevolge die Doeane- en Aksynswette van Rhodesië aan die klerasievervaardigingsnywerheid toegestaan; en

(b) gebruik word in ooreenstemming met die bepalings van en vir die doel gespesifieer in die betrokke kortingvoorsienings van die Doeane- en Aksynswette van Rhodesië;

word sulke stukgoedere toegelaat teen die gekorte kolum D-koers.

ARTIKEL 7

Ru- en ongeslypte diamante wat in die Republiek geproduseer is en na Rhodesië uitgevoer word, is vry van uitvoerreg indien 'n beampte van die Regering van Rhodesië gesertifiseer het dat dit vir nywerheidsgebruik in Rhodesië bedoel is.

ARTIKEL 8

Onderworpe aan die ander voorwaardes wat elders in hierdie Ooreenkoms bepaal is, word vervaardigde goedere geag nie binne die bepalings van hierdie Ooreenkoms te val nie—

(a) in die geval van klerasie wat in Rhodesië vervaardig en in Dele III en IV van Aanhangel B gespesifieer is, tensy die Rhodesiese inhoud van sodanige klerasie minstens twintig persent is, en alle werksaamhede wat nodig is om sodanige klerasie uit stukgoedere te vervaardig, soos die sny en vasnaai daarvan, in Rhodesië verrig is; en

(b) in die geval van ander goedere wat in Rhodesië vervaardig is, tensy die laaste vervaardigingsproses in Rhodesië plaasgevind het en die Rhodesiese inhoud van sodanige goedere minstens vyf-en-twintig persent is; en

(c) in die geval van goedere wat in die Republiek vervaardig is, tensy die laaste vervaardigingsproses in die Republiek verrig is en genoemde goedere—

(i) nie minder as sodanige gedeelte van die materiaal en arbeid of van die materiaal of arbeid van die Republiek bevat nie; en

(ii) aan sodanige vervaardigingsproses in die Republiek onderwerp was; soos van tyd tot tyd bepaal kan word, vir die doel van die kortings waaroor in die Rhodesiese doeannetarief voorsiening gemaak is ten opsigte van goedere vervaardig in die lande wat in paragraaf 1 van Deel III van genoemde Tarief gespesifieer is.

ARTIKEL 9

(1) 'n Party kan dumpingregte hef op goedere wat in die land van die ander party geproduseer is.

(2) 'n Party kan kontraregtes hef om te vergoed vir subsidies wat regstreeks of onregstreeks toegestaan is ten opsigte van goedere wat uit die ander party se land uitgevoer word.

(3) Wanneer een party die ander party versoek om hulp te verleen by 'n ondersoek na beweerde dumping, moet die ander party alle moontlike hulp verleen by sodanige ondersoek.

ARTIKEL 10

Indien 'n party 'n aksynsreg of oorbelasting hef wat slegs op goedere wat in sy land geproduseer word van toepassing is, of 'n reeds bestaande aksynsreg of oorbelasting wat slegs van toepassing is op goedere wat in sy land geproduseer word, verhoog, kan die party terselfdertyd soortgelyke goedere wat in die land van die ander party geproduseer word, in reg ople wat gelyk is aan die nuwe of verhoogde aksynsreg of oorbelasting.

ARTIKEL 11

Die partye kom ooreen om sover moontlik ooreenstemmende doeannematreëls en -prosedures aan te neem ten einde toerisme aan te moedig.

ARTIKEL 12

Uitgesondert soos elders in hierdie Ooreenkoms bepaal, mag geen kwantitatiewe in- en uitvoerbeperkings, met uitsondering van dié wat ten tyde van die inwerkintreding van hierdie Ooreenkoms van krag is, gele word nie op die beweging, tussen die lande van die partye, van goedere wat in daardie lande geproduseer is:

Met dien verstande dat, na oorlegpleging tussen die partye, 'n party—

(a) invoerbeperkings kan lê op landbou- en visseryprodukte, of op produkte wat dit direk kan vervang, wat nodig is om regeringsmaatreëls toe te pas wat die uitwerking het—

(i) om die hoeveelhede van die ooreenstemmende binnelandse produk wat bemark of geproduseer mag word, te beperk; of
(ii) om aan 'n tydelike surplus van die binnelandse produk 'n einde te maak; en

- (b) export restrictions temporarily applied to prevent or relieve critical shortages of foodstuffs or other products essential to the exporting party; and
- (c) import and export restrictions necessary to the application of standards or regulations for the classification, grading or marketing of commodities; and
- (d) import and export restrictions undertaken in pursuance of obligations under any international trade or commodity agreement; and
- (e) import and export restrictions necessary for the better administration of this Agreement or designed to achieve its objectives.

ARTICLE 13

The parties shall make such regulations or other legal provision as may be necessary to give effect to this Agreement and for the proper administration of its provisions.

ARTICLE 14

The parties, having regard to the objectives of this Agreement and recognising that difficulties or problems may arise as a result of the operation of the Agreement, agree that—

- (a) a party which proposes to take or authorise action which it considers may affect any benefit accruing to the other party under this Agreement shall, whenever possible, consult in advance with, and give sympathetic consideration to any representations by, or proposals received from, that other party; and
- (b) a party shall be free at all times to approach the other party for consultations with a view to finding ways and means to solve any difficulty or problem in the operation of this Agreement; and
- (c) apart from any discussions which may take place under (a) and (b) above, the parties shall meet at intervals not exceeding fifteen months for formal discussion of the operation of this Agreement.

ARTICLE 15

This Agreement shall come into operation on 1st December, 1964, and shall remain in operation until 31st December, 1969, and, unless notice of termination is given by one party to the other party twelve months before the expiry of that period, it shall thereafter remain in force until the expiry of twelve months from the date on which notice of termination is given.

On the coming into operation of this Agreement, the provisions of all former agreements relating to trade between the countries of the parties shall cease to have force or effect.

Done at Salisbury in duplicate, in English and Afrikaans texts, each of which shall be of equal authenticity, this Thirtieth day of November, One thousand Nine hundred and Sixty-four.

ANNEXURE A (Article 3)

PART I

Goods produced in the country of one party and specified in this Part shall, when imported into the country of the other party under import licence, be admitted into that country free of duty.

SPECIFIED GOODS

Apples imported during the months of January, February, March or April.

Barley; barley malt.

Butter; cheese; ghee; cream other than sterilized cream; ice cream and ice cream mixes.

Cattle; beef, veal and other edible products produced from the carcasses of cattle, excluding meat extract, meat paste, meat powder, potted meat, tinned meat.

Citrus fruit imported during the months of June, July, August, September, October or November.

Compound products containing flour, meal, residues and other preparations of a kind suitable only for use as animal feedstuffs, excluding:

- (a) chemical additions to animal feedstuffs;
- (b) anti-biotic growth stimulants;
- (c) inert fillers;
- (d) trace elements;
- (e) synthetic animal feedstuffs;
- (f) mixed bird seed;
- (g) cat and dog foods;
- (h) salt lick for cattle.

Eggs of poultry, whether in shell, pulp or dried form.

Goats; goat meat and other edible products produced from the carcasses of goats, excluding canned products.

Grain sorghum (sorghum species); meal and malt thereof.

Grapes imported during the month of December.

Leguminous seeds, including groundnuts, dried or otherwise, whole, ground or split, excluding:

- (a) those which are tinned, bottled or preserved otherwise than by drying;
- (b) seed beans in quantities of less than 200 lb;
- (c) garden and maple peas.

- (b) uitvoerbeperkings kan ople wat tydelik toegepas word om ernstige voedseltekorte of tekorte aan ander produkte wat vir die uitvoerende party noodsaaklik is, te voorkom of te verlig; en
- (c) in- en uitvoerbeperkings kan ople wat nodig is vir die toepassing van standaarde of regulasies vir die klassifisering, gradering of bemarking van kommoditeite; en
- (d) in- en uitvoerbeperkings kan ople ten einde die nakoming van die verpligtings ingevolge enige internasionale handels- of kommoditeitsooreenkoms te bewerkstellig; en
- (e) in- en uitvoerbeperkings kan ople, wat nodig is vir die doeltreffender toepassing van hierdie Ooreenkoms, of wat beoog is om die doelstellings daarvan te verwesenlik.

ARTIKEL 13

Die partye moet die regulasies of ander wetlike bepalings instel wat nodig mag wees om uitvoering te gee aan hierdie Ooreenkoms en vir die behoorlike toepassing van die bepalings daarvan.

ARTIKEL 14

Die partye, met inagneming van die doelstellings van hierdie Ooreenkoms en in die besef dat moeilikhede en probleme mag opduik as gevolg van die werking van die Ooreenkoms, kom ooreen dat—

- (a) 'n party wat van voorname is om stappe te doen of te magtig wat hy beskou dat dit 'n uitwerking kan hê op enige van die voordele wat die ander party kragtens die Ooreenkoms toeval, wanneer ook al moontlik, vooraf oorleg sal pleeg met, en simpatieke oorweging sal skenk aan enige vertoe deur, of voorstelle wat ontvang word van, dié ander party; en
- (b) 'n party te alle tye vry sal wees om die ander party te nader vir raadpleging met die oog om middele te vind om enige moeilikhed of probleem in die werking van die Ooreenkoms op te los; en
- (c) afgesien van enige oorlegpleging wat ooreenkomsdig (a) en (b) hierbo mag plaasvind, die partye by tussenpose van hoogstens vyftien maande vir formele samesprekings in verband met die werking van die Ooreenkoms byeen sal kom.

ARTIKEL 15
