No. R. 2060.] [11 December 1964.
IMPORT CONTROL.

I, NICOLAAS DIEDERICHS, in my capacity as Minister of Economic Affairs and acting by virtue of the powers vested in me by section two of the Import and Export Control Act (Act No. 45 of 1963), do hereby prescribe the following in regard to the issue of import permits valid for 1965:—

Paragraph 1.—The goods mentioned in this paragraph in column (1) below and provided for in the respective customs tariff items, as shown in column (2), are hereby exempted from the provisions of Government Notice No. 1918, dated 6th December, 1957, and may be imported into the Republic of South Africa, from any country, without an import permit.

[Particulars in column (3) relate to the classification of the goods according to the Brussels Tariff Nomenclature (B.T.N.) and are furnished at this stage for guidance.]

Ek, NICOLAAS DIEDERICHS, in my hoedanigheid van Minister van Ekonomiese Sake en handelende kragtens die bevoegheid my verleen by artikel twee van die Wet op In- en Uitvoerbeheer (Wet No. 45 van 1963), skryf hierby die volgende voor met betrekking tot die uitreiking van invoerpermitte geldig vir 1965:—

Paragraaf 1.—Die goedere in hierdie paragraaf in kolom (4) hieronder genoem en waarvoor in die betrokke doeanetariefitems voorsiening gemaak is, soos aangedui in kolom (2), word hierby vrygestel van die bepalings van Goewermentskennisgewing No. 1918, gedateer 6 Desember 1957, en kan sonder 'n invoerpermit, uit enige land, in die Republiek van Suid-Afrika ingevoer word.

NOTE (1).—The articles appearing in paragraph 1 of this notice shall also be exempt from the production of permits when they are imported under rebate of customs duty under the Second or Third Schedule to the Customs Act, No. 55 of 1955, as amended.

NOTE (2).—The meaning to be ascribed to any description of articles in paragraph 1 of this notice shall be the meaning attached to similarly numbered items in the First Schedule to the Customs Act, No. 55 of 1955, as amended.

NOTE (3).—All goods mentioned in this paragraph shall include maintenance spares therefor provided such spares do not fall under the items in respect of which a specific permit is required in terms of paragraph 5 of this notice.

PARAGRAAF 2.—THE GOODS MENTIONED IN THIS PARAGRAAF MAY BE IMPORTED INTO THE REPUBLIC OF SOUTH AFRICA PROVIDED THE IMPORTER IS IN POSSESSION OF A SUITABLE VALID IMPORT PERMIT.

- (ii) in the case of manufacturers who—

 - (b) require such capital plant and equipment for their own use—their full requirements subject to availability from local sources of supply.

1. Raw materials, maintenance spares and consumable stores for—

- (i) industry;
- (ii) agriculture; and
- (iii) mining.

2. Capital plant and equipment and spares therefor.

(In all cases the items specifically listed in paragraph 5 of this notice are excluded.)

NOTE 1.—Manufacturers may apply for such import facilities at any time by submitting an application on form Excon 77 in respect of raw materials and on form Excon 75 in respect of capital plant and equipment. (Both forms are appended to this notice.)

NOTE 2.—In the case of merchants importing capital plant and equipment for stock purposes reasonable facilities will be granted on application.

NOTE 3.—In the case of merchants importing capital plant and equipment against a firm order application should be made on form Excon 75.

NOTE 4.—In all cases, however, both manufacturers and merchants are expected to obtain their requirements of the goods and capital plant and equipment covered by this paragraph from local sources whenever it is possible to do so.

NOTE 5.—Initial allocations in respect of merchant importers of raw materials are now in course of preparation and will be posted before the 14th December, 1964. Thereafter application for additional facilities should be made in conformity with such additional quotas as may be authorised from time to time.

- (v) mopeds and auxiliary engines, including outboard motors,
- (vi) pedal cycles,
- (vii) C.K.D. material for motor vehicles and
- (viii) maintenance spares and accessories for the above.

Import permits will be issued to individuals to provide for the importation of built-up motor vehicles on the following basis:—

- (a) In the case of motor vehicles with an f.o.b. cost not exceeding R1,900—provided the motor vehicle has been used by the applicant for a period of not less than two (2) calendar months outside the Republic of South Africa and has been registered in the name of the applicant during that period, and
- (b) in the case of motor vehicles with an f.o.b. cost exceeding R1,900—at any time on application.

PARAGRAAF 4.—QUOTAS FOR THE IMPORTATION OF THE GOODS ENUMERATED IN THIS PARAGRAAF WILL BE DETERMINED FROM TIME TO TIME, AND THE RELEVANT IMPORT PERMITS WILL BE ISSUED IN ACCORDANCE WITH SUCH QUOTAS TO REGISTERED IMPORTERS.

- Government Notice No. R. 1905 dated 6th December, 1963, applies to 1964 import permits, and the notice now published above applies to 1965 import permits.
- The distinction between Group A and Group B consumer goods now falls away. The majority of the goods previously grouped under Group A consumer goods have now been included under paragraph 1 of this notice (the free list) and may therefore be imported without an import permit. Those Group A consumer goods not included under the free list of imports will now be classified as general merchandise falling under paragraph 4 of this notice. Importers of such goods may apply for their general merchandise quotas to be reviewed.
- The following goods have now been deleted from the restricted list:—

- Importers are reminded of the following:—
 - Import permits are issued to enable importers to carry on their normal business and to enable them to import the same types of goods which were previously imported by them.
In cases where an importer wishes to change the nature of goods imported, written application should be made to the Director of Imports and Exports.
 - Goods should not be shipped unless the importer is in possession of a suitable valid import permit. Goods which arrive at ports in the Republic of South Africa and for which the importer cannot produce a valid import permit, will be deemed to be imported in contravention of the Import Control Regulations.
 - Import permits may not be negotiated, sold or used to the benefit of any firm not named in the import permit without the prior written approval and consent of the Director of Imports and Exports. Any import permits which appear to have been used in this manner will be cancelled and withdrawn forthwith.
