MEALIE AND KAFFIRCORN CONTROL SCHEME.

PRODUCERS' PRICES OF MEALIES.

In terms of sub-section (1) of section twenty-nine of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Mealie Industry Control Board, referred to in section 3 of the Mealie and Kaffircorn Control Scheme, published by Proclamation No. R. 113 of 1961, as amended, has, in terms of section 27 of that Scheme, with my approval and with effect from 1st May, 1965, imposed the prohibitions mentioned—

- (a) in Schedule A hereto in connection with the sale of mealies by producers of mealies in area A; and
- (b) in Schedule B hereto in connection with the sale of mealies by producers of mealies in area B; and I do hereby further make known that the said prohibitions shall remain in force until the 30th April, 1966, unless amended at an earlier date.

Definitions.

For the purposes of this Government Notice—

- (a) "area A" shall mean the area comprising the Provinces of Transvaal and the Orange Free State and the Magisterial Districts of Mafeking, Taung, Vryburg and Warrenton in the Cape Province;
- (b) "area B" shall mean the area comprising the Magisterial Districts of Aliwal North, Bellville, Cape Town, East London, Kimberley, King

PRODUSENTEPRYSE VAN MIELIES.

Kragtens subartikel (1) van artikel nege-en-twintig van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, maak ek, DIRK CORNELIS HERMANUS UYS, Minister van Landbou-economie en -bemarking, hierby bekend dat die Raad van Beheer oor die Mielienywerheid, genoem in artikel 3 van die Mielie- en Kafferkoringsreeling-skema, gepubliseer by Proklamasie No. R. 113 van 1961, soos gewysig, kragtens artikel 27 van daardie skema, met my goedkeuring en met ingang van 1 Mei 1965 die verbodsbeplings genoem—

- (a) in Bylae A hiervan in verband met die verkoop van mielies deur produsente van mielies in gebied A; en
- (b) in Bylae B hiervan in verband met die verkoop van mielies deur produsente van mielies in gebied B opgelê het en ek maak hierby verder bekend dat die genoemde verbodsbeplings van krag bly tot 30 April 1966 tensy vroeër gewysig.

Woordomskrywing.

Vir die doeleindes van hierdie Goewermenskennisgewing—

- (a) beteken „gebied A”, die gebied bestaande uit die Provincies Transvaal en Oranje-Vrystaat en die landdrosdistrikte Mafeking, Taung, Vryburg en Warrenton in die Kaapprovinsie;
- (b) beteken „gebied B”, die gebied bestaande uit die landdrosdistrikte Aliwal-Noord, Bellville, Kaapstad, Kimberley, King William's Town, Matatiele, Mount

William's Town, Matatiele, Mount Currie, Port Elizabeth, Uitenhage, Umzimkulu and Worcester of the Cape Province; those portions of the Magisterial Districts of Gordonia, Hay, Kenhardt and Prieska of the Cape Province situated in a strip 30 miles north and 30 miles south of the Orange River between Boegoeburg Dam and a point on the Orange River directly north of Noudonsies; and the Magisterial Districts of Bergville, Camperdown, Dundee, Durban, Estcourt, Helpmekaar, Ixopo, Klip River, Kranskop, Lion's River, Msinga, Newcastle, New Hanover, Nqutu, Paullpietersburg, Pietermaritzburg, Pinetown, Port Shepstone, Umvoti, Utrecht, Vryheid and Weenen of the Province of Natal;

- (c) "bag" in relation to mealies shall mean 200 lb. net weight: Provided that the net weight of mealies contained in a bag shall be determined by deducting 3 lb. tare plus the weight represented by moisture in excess of 12½ per cent (if the moisture content of the mealies concerned exceeds 12½ per cent by weight) from the gross weight;
- (d) "classes and grades of mealies" shall mean the classes and grades defined in the Schedule to Government Notice No. R. 632 of 27th April, 1962, as amended;
- (e) "new or good second-hand grain bags" shall mean jute bags or bags manufactured from jute and phormium tenax with a superficial measurement of not less than 1,160 and not more than 1,250 square inches that have been woven with porter and shot (warp and weft threads) of not less than 8 by 8 (as determined by a porter measure) and that are sound, clean, unstained and free of holes but darned with twine, the tensile strength of which shall be not less than 9 lb., or patched where necessary: Provided that—

(i) (a) each of the darns shall not exceed four square inches and that such darns shall overlap the small holes on all sides by at least $\frac{1}{2}$ inch;

(b) the darns shall be cross-stitched by hand with jute twine or machine-darned in such a manner that the darns correspond in closeness to the weave of the bag and that the material of the bag is not pulled together, thereby causing the snapping or displacement of the strands of the bag or the darns when the bag is filled with grain;

(ii) except for not more than two patches (one on each side) of not more than 4½ inches by 10 inches each allowed at the mouth of the bag to cover cuts and affixed as provided in paragraph (iv) of this proviso, all the other patches shall not exceed six square inches;

(iii) patches, whether stitched or affixed with an adhesive, shall not overlap;

(iv) patches shall be properly hand-sewn to the bag with jute twine or properly machine-darned over the entire surface of the patch with twine, the tensile strength of which shall be not less than 9 lb.;

(v) patches affixed with a patching compound shall be properly affixed and will not be allowed to be closer than six inches to the mouth of the bag.

For the purposes of this definition—

"sound" shall mean that the grain bag is strong enough for the conveyance of 200 lb. of grain and is not so weathered and/or worn that it will break during normal handling or, when empty, will tear if one end is held down with the flat heel and the other end pulled by hand;

- (c) beteken „sak”, met betrekking tot mielies, 200 lb. netto gewig: Met dien verstande dat die netto gewig van mielies in 'n sak bepaal moet word deur 3 lb. tare plus die gewig verteenwoordig deur vog bo 12½ persent (indien die voggehalte van die betrokke mielies 12½ persent volgens gewig oorskry) van die bruto gewig af te trek;
- (d) beteken „klasse en grade mielies”, die klasse en grade wat in die Bylae van Goewermentskennisgowing No. R. 632 van 27 April 1962, soos gewysig, omskryf word;
- (e) beteken „nuwe of goeie tweedehandse graansakke”, jutesakke of sakke vervaardig van jute en phormium tenax met 'n vlaktemaat van minstens 1,160 en hoogstens 1,250 vierkant duim wat geweef is met skering- en inslagdrade (porter and shot) van minstens 8 x 8 (soos met 'n portermeter bepaal) en wat sterk, skoon, ongevlek en sonder gate is, maar gestop met gare waarvan die breekkrag nie minder as 9 lb. is nie, of gelap waar nodig: Met dien verstande dat—

(i) (a) die stopplekke elk nie vier vierkantduim mag oorskry nie en strek tot minstens 'n halfduim aan alle kante van die gaatjies; en

(b) die stopplekke op so 'n wyse met die hand met jutegare oorkruis gestop of met 'n masjiem gestop moet wees dat die stopplekke net so dig is as die weefsel van die sak en die materiaal van die sak nie ingertek word en veroorsaak dat die drade van die sak verskuif of die stopplekke of drade van die sak breek wanneer die sak met graan gevul word nie;

(ii) behalwe by die bek van die sak waar hoogstens twee lappe (een aan elke kant) van 1½ duim by 10 duim vir die bedekking van snye, en aangebring soos bepaal in paragraaf (iv) van hierdie voorbehoudsbepaling, toegelaat word, alle ander lappe elk nie ses vierkantduim mag oorskry nie;

(iii) lappe, hetsy aangesrik of met 'n kleefstof aangebring, nie mekaar mag oordek nie;

(iv) lappe behoorlik met jutegare met die hand aangewerk moet wees of behoorlik met 'n masjiem oor die hele oppervlakte vasgestop moet wees met gare waarvan die breekkrag nie minder as 9 lb. is nie;

(v) lappe wat met 'n kleefstof aangeplak is, behoorlik aangeplak moet wees en slegs toelaatbaar is mits dit verder as ses duim van die bek van die sak aangebring is.

Vir die doeleindes van bostaande omskrywing beteken—

„sterk”, dat die graansak sterk genoeg is vir die vervoer van 200 lb. graan en nie sodanig verweer en/of verslyt is dat dit met normale hantering of wanneer die sak leeg is en die een punt daarvan met die plat hak vasgetrap en die ander punt met die hand getrek word, sal skeur nie;

"unstained" shall mean that the material from which the bag was manufactured, has not been discoloured and impregnated by a pigment or any liquid capable of imparting stains to such material, excluding trade marks or normal discoloration due to exposure to the sun;

(f) "mealies delivered in bulk" shall mean mealies delivered to a buyer who receives the mealies without bags;

(g) "railing point" shall mean any railway station or siding, including a private siding, to which a train service is conducted;

(h) "buyer" shall mean any person who purchases mealies from a producer of mealies and includes an agent of the Mealie Industry Control Board who purchases mealies from producers on behalf of the said Board;

(i) "sell" shall have the meaning assigned thereto in the Marketing Act, 1937 (Act No. 26 of 1937), as amended; and

(j) "weevily mealies" shall mean mealies infested with live weevils or other live insects injurious to stored grain, irrespective of whether such insects are present in the mealies or on the containers of the mealies.

SCHEDULE A.

Producers' Prices of Mealies in Area A.

1. (1) No producer of mealies in Area A shall sell—

(a) mealies in quantities of 200 lb. net weight or more—

(i) of one or other of the classes and grades mentioned in Table A hereunder, excluding mealies intended for seed purposes and weevily mealies, at a price other than the price specified in column 1 of that table for mealies of that class and grade if such mealies are delivered in new or good second-hand grain bags;

(ii) of one or other of the classes and grades mentioned in Table A hereunder, at a price higher than the price specified in column 1 of that table for mealies of that class and grade if such mealies are weevily and are delivered in new or good second-hand grain bags: Provided that if such mealies are delivered in quantities of more than 206 lb. gross weight per grain bag, the price payable to the producer shall be calculated as if only 206 lb. gross weight per bag was delivered;

(iii) of one or other of the classes and grades mentioned in Table A hereunder, at a price other than the price specified in column 2 of that table for mealies of that class and grade, if such mealies are delivered in bulk and are weighed by the buyer before having been cleaned;

(iv) of one or other of the classes and grades mentioned in Table A hereunder, at a price other than the price specified in column 3 of that table for mealies of that class and grade, if such mealies are delivered in bulk and weighed by the buyer after having been cleaned, in which case any screenings removed in the process of cleaning remain the property of the producer.

(f) beteken „mielies in massa gelewer”, mielies gelewer aan 'n koper wat die mielies sonder sakke ontvang;

(g) beteken „versporingspunt”, enige spoorwegstasie of -halte, met inbegrip van 'n private sylyn, waarheen 'n treindiens ingestel is;

(h) beteken „koper”, enige persoon wat mielies van 'n produsent van mielies koop en sluit in 'n agent van die Raad van Beheer oor die Mielienywerheid wat mielies ten behoeve van genoemde Raad van produsente koop;

(i) het „verkoop”, die betekenis wat in die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, daaraan geheg word; en

(j) beteken „kalanderbesmette mielies” mielies wat met lewende kalanders of ander lewende insekte wat skadelik is vir opgebergde graan, besmet is, ongeag of sodanige insekte in die mielies of op die houers van die mielies voorkom.

1. (1) Geen produsent van mielies in gebied A mag—

(a) mielies in hoeveelhede van 200 lb. netto gewig of meer—

(i) van die een of ander van die klasse en grade in Tabel A hieronder genoem, uitgesonderd mielies bestem vir saaddoeleindes en kalanderbesmette mielies, teen 'n ander prys as die prys in kolom 1 van daardie tabel genoem, vir mielies van daardie klas en graad, verkoop nie, indien sodanige mielies gelewer word in nuwe of goeie tweedehandse graansakke;

(ii) van die een of ander van die klasse en grade wat in Tabel A hieronder genoem word, teen hoér prys as die prys in kolom 1 van daardie tabel genoem vir mielies van daardie klas en graad, verkoop nie, indien sodanige mielies kalanderbesmet is en gelewer word in nuwe of goeie tweedehandse graansakke. Met dien verstande dat indien sodanige mielies gelewer word in hoeveelhede van meer as 206 lb. bruto gewig per graansak, die prys aan die produsent betaalbaar, bereken moet word asof slegs 206 lb. bruto gewig per sak gelewer is;

(iii) van die een of ander van die klasse en grade in Tabel A hieronder genoem, teen 'n ander prys as die prys in kolom 2 van daardie tabel genoem vir mielies van daardie klas en graad, verkoop nie, indien sodanige mielies in massa gelewer en deur die koper geweeg word voor dat dit skoongemaak is;

(iv) van die een of ander van die klasse en grade in Tabel A hieronder genoem, teen 'n ander prys as die prys in kolom 3 van daardie tabel genoem vir mielies van daardie klas en graad, verkoop nie, indien sodanige mielies in massa gelewer en deur die koper geweeg word nadat dit skoongemaak is in welke geval enige sifselfs wat in die skoonmaakproses uit die mielies verwijder word, die eiendom van die produsent bly.

(v) at a price of less than 315 cents per 200 lb. net weight if such mealies are intended for seed purposes;

(vi) at a price higher than 315 cents per bag if such mealies are sample grade mealies;

(b) mealies in quantities of less than 200 lb., excluding mealies intended for seed purposes—

(i) at a price other than 12½ cents per 10 lb. if such mealies are of the grades WD1, WD2, YF1, YF2, YD1, YM1 and YM2 mentioned in the table above;

(ii) at a price other than 12 cents per 10 lb. if such mealies are of the grades WD3, WF1, WF2 and YM3 mentioned in the table above;

(iii) at a price higher than 12½ cents per 10 lb. if such mealies are sample grade mealies.

(2) The prices mentioned in paragraph 1 (b) do not include the value of a container and if the mealies are delivered in a container, the producer and the buyer shall determine the price of the container by mutual agreement.

(v) teen 'n laer prys as 315 sent per 200 lb. netto gewig verkoop nie, indien sodanige mielies vir saaddoeleindes bestem is;

(vi) teen 'n hoër prys as 315 sent per sak verkoop nie, indien sodanige mielies monstergraad mielies is;

(b) mielies in hoeveelhede van minder as 200 lb. uitgesonderd mielies bestem vir saaddoeleindes—

(i) teen 'n ander prys as 12½ sent per 10 lb. verkoop nie, indien sodanige mielies van die grade WD1, WD2, YF1, YF2, YD1, YM1 en YM2 in die tabel hierbo genoem is;

(ii) teen 'n ander prys as 12 sent per 10 lb. verkoop nie, indien sodanige mielies van die grade WD3, WF1, WF2 en YM3 in die tabel hierbo genoem is;

(iii) teen 'n hoër prys as 12½ sent per 10 lb. verkoop nie, indien sodanige mielies monstergraad mielies is;

(2) Die prysse genoem in paragraaf 1 (b) sluit nie die waarde van 'n houer in nie en indien die mielies in 'n houer gelewer word, moet die produsent en die koper deur onderlinge ooreenkoms die prys van die houer bepaal.

2. In the calculation of the price payable in accordance with clause 1, any fraction of a cent, if less than a half cent, may be regarded as a half cent and, if more than a half cent, as a cent.

3. The prices for the respective classes and grades of mealies mentioned in clause 1 shall apply in respect of mealies delivered—

(1) at the premises of the buyer or any premises indicated by the buyer if such premises are not situated more than five miles from the buyer's nearest railing point: Provided that if the mealies are delivered at premises which are situated more than five miles from the buyer's nearest railing point, the price shall be reduced by cost of transport calculated at Railway Road Motor Transport Tariff from the premises where the mealies are delivered to the buyer's nearest railing point; or

(2) at any railing point indicated by the buyer for despatch by rail to a destination other than the buyer's premises or to an elevator in respect of which the in-transit rates, described in clause 277 (2) of the Official Railway Tariff Book (No. 28, dated 14th July, 1963), apply.

4. For the purpose of these regulations, the net weight of mealies of which the moisture content exceeds $12\frac{1}{2}$ per cent by weight, shall be calculated on a basis of $12\frac{1}{2}$ per cent moisture content.

SCHEDULE B.

Producers' Prices of Mealies in Area B.

1. (1) No producer of mealies in area B shall sell—

(a) mealies in quantities of 200 lb. net weight or more—

(i) of one or other of the classes and grades mentioned in Table B hereunder at a price less than the price specified in column 1 of that table for mealies of that class and grade, if such mealies are delivered in new or good second-hand grain bags: Provided that if such mealies are delivered in grain bags of a quality inferior to that of a good second-hand grain bag, the said price shall be reduced by five cents in respect of each such grain bag: Provided further that in respect of such mealies delivered in quantities of more than 206 lb. gross weight per grain bag, the price payable to the producer shall be calculated as if only 206 lb. gross weight per bag was delivered;

(ii) of one or other of the classes and grades mentioned in Table B hereunder, at a price less than the price specified in column 2 of that table for mealies of that class and grade, if such mealies are delivered in bulk and weighed by the buyer before having been cleaned;

(iii) of one or other of the classes and grades mentioned in Table B hereunder, at a price less than the price specified in column 3 of that table for mealies of that class and grade, if such mealies are delivered in bulk and weighed by the buyer after having been cleaned, in which case any screenings removed in the process of cleaning remain the property of the producer.

2. By die berekening van die prys betaalbaar ooreenkomsdig klosule 1, mag enige breuk van 'n sent, indien minder as 'n halfsent, as 'n halfsent en indien meer as 'n halfsent, as 'n sent beskou word.

3. Die pryse vir die onderskeie klasse en grade mielies genoem in klosule 1, geld vir mielies gelewer—

(1) op die perseel van die koper of enige perseel deur die koper aangedui, mits sodanige perseel nie verder as vyf myl van die koper se naaste versporingspunt geleë is nie: Met dien verstande dat indien die mielies gelewer word op 'n perseel wat verder as vyf myl van die koper se naaste versporingspunt geleë is, die prys verminder moet word met vervoerkoste bereken teen Spoorwegpadmotorvervoertarief vanaf die perseel waar die mielies gelewer word, tot by die koper se naaste versporingspunt; of

(2) by enige versporingspunt deur die koper aangedui vir versporing na 'n ander bestemming as die koper se perseel of na 'n graansuier ten opsigte waarvan die deurvoertariewe, soos omskryf in klosule 277 (2) van die *Offisiële Spoorwegtariefboek* (No. 28, gedateer 14 Julie 1963), van toepassing is.

4. Die netto gewig van mielies waarvan die voggehalte hoër as $12\frac{1}{2}$ persent volgens gewig is, moet vir doeleindes van hierdie regulasies bereken word op basis van 'n voggehalte van $12\frac{1}{2}$ persent.

(a) mielies in hoeveelhede van 200 lb. netto gewig of meer—

(i) van die een of ander van die klasse en grade in Tabel B hieronder genoem, teen 'n laer prys as die prys in kolom 1 van daardie tabel genoem vir mielies van daardie klas en graad, verkoop nie, indien sodanige mielies gelewer word in nuwe graansakke of goeie tweedehandse graansakke: Met dien verstande dat indien sodanige mielies gelewer word in graansakke van swakker gehalte as goeie tweedehandse graansakke, die genoemde prys met 5c ten opsigte van elke sodanige graansak verminder moet word: Met dien verstande verder dat indien sodanige mielies gelewer word in hoeveelhede van meer as 206 lb. bruto gewig per graansak, die prys aan die produsent betaalbaar bereken moet word asof slegs 206 lb. bruto gewig per sak gelewer is;

(ii) van die een of ander van die klasse en grade in Tabel B hieronder genoem, teen 'n laer prys as die prys in kolom 2 van daardie tabel genoem vir mielies van daardie klas en graad, verkoop nie, indien sodanige mielies in massa gelewer en deur die koper geweeg word voor dat dit skoongemaak is;

(iii) van die een of ander van die klasse en grade in Tabel B hieronder genoem, teen 'n laer prys as die prys in kolom 3 van daardie tabel genoem vir mielies van daardie klas en graad, verkoop nie, indien sodanige mielies in massa gelewer en deur die koper geweeg word nadat dit skoongemaak is, in welke geval enige sifselfs wat in die skoonmaakproses uit die mielies verwijder word, die eiendom van die produsent bly.

SCHEDULE.

DEFINITIONS.

1. For the purpose of this Government Notice—

- (i) the maize products referred to shall be the products to which Government Notice No. R. 607, dated the 30th April, 1965, relates;
- (ii) "nearest railway station" shall mean the nearest railway station or siding, including any private siding, to which a train service is conducted;
- (iii) "supply point" shall mean the manufacturer's nearest railway station or any other premises which are not situated on a railway line and from which maize is supplied to the manufacturer;
- (iv) "bleached kraft bags" shall mean single-walled paper bags manufactured from bleached kraft with minimum substance weight of 100 grammes per square metre per wall or double-walled paper bags manufactured from bleached kraft with a minimum substance weight of 50 grammes per square metre per wall; and
- (v) "unglazed sack kraft bags" shall mean three or four or five ply paper bags manufactured from pure unglazed sack kraft with a minimum substance weight of 80 grammes per square metre per ply.

MILLERS' PRICES FOR MAIZE PRODUCTS.

2. Subject to the provisions of clauses 4, 5 and 6 hereof, no person shall sell any maize product, specified in Tables A, B, C, D, E, F, G and H hereunder and manufactured by himself or on his behalf, in any quantity mentioned in the said tables and contained in the containers specified therein, at a price in excess of the price specified in the relevant table in respect of that maize product.

Subject to the provisions of clauses 4, 5 and 6 the price for a maize product which is sold in a container containing any quantity less than 90 lb. for which no price is prescribed in Tables B, C, D, E, F, G and H, shall be calculated in proportion to the price specified in the said tables for the relevant maize product packed in the relevant container and for the specified weight immediately higher than the actual weight of the maize product thus sold.

4. The prices for the respective maize products mentioned in clause 2 and the prices calculated in terms of clause 3 may be increased—

(a) in respect of white maize products and yellow maize products sold by the manufacturer thereof, if the premises on which such maize products were manufactured, are situated in any one of the magisterial districts or townships mentioned in column 1 of the table hereunder—

- (i) by the amounts shown in column 2 and column 3 of the said table in respect of white and yellow maize products respectively, for that district or township;
- (ii) by cost of transport calculated at railway road motor transport tariff from the manufacturer's premises to his nearest railway station if such premises are situated more than ten miles from the nearest railway station: Provided that, in the case of white maize products, the price may be so increased by cost of transport only if an increase in the price of white maize products is shown in column 2 of the said table for that district or township, and, in the case of yellow maize products, the price may be so increased only if an increase in the price of yellow maize products is shown in column 3 of the said table for that district or township:—

(b) in respect of maize products sold by the manufacturer thereof, if the premises on which such maize products were manufactured, are situated in the Magisterial Districts of Kuruman or Vryburg and are more than ten miles from the nearest railway station, by cost of transport calculated at Railway Road Motor Transport tariff from the supply point to the manufacturer's premises;

(c) by an amount not exceeding 7 cents per 180 lb. net weight when the total quantity of maize products sold to one person at one and the same time is 1,800 lb. or less;

(d) by 2 cents per 180 lb. net weight in respect of every month or part thereof after the end of the month which immediately follows the month during which delivery or despatch of such maize product was effected and during which the price remains unpaid.

5. The prices calculated in terms of clauses 2, 3 and 4 above, apply in respect of maize products delivered at the manufacturer's premises on which such product was manufactured and may, in respect of maize products delivered at any other place, be further increased—

(a) by the actual railage or Railway Road Motor Transport charges paid by such manufacturer on maize products delivered by rail or Railway Road Motor Transport;

(b) by an amount mutually agreed upon between the manufacturer and the buyer in respect of cost of delivery by road transport other than Railway Road Motor Transport.

6. In the calculation of the price of any maize product in terms of the foregoing provisions, an amount of less than half a cent may be increased to half a cent.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Banana Control Board referred to in section 3 of the Banana Scheme published by Proclamation No. R. 254 of 1962, has, under the powers vested in it by section 15 of the said Scheme and with my approval, imposed a special levy on bananas as set out in the Schedule hereto.

And I hereby further make known that the said special levy shall come into operation on the 3rd May, 1965, in substitution for the special levy made known by Government Notice No. 549 of the 7th April, 1961.

SCHEDULE.

1. There is hereby imposed a special levy at the rate of six per cent of the selling price of—

- (a) all bananas produced in any production area referred to in section 2 of the Banana Scheme published by Proclamation No. R. 254 of 1962 and sold outside any such area; and
- (b) on all bananas imported into the Republic and sold outside any such production area.

2. For the purposes of this special levy, "selling price" shall mean—

- (i) in the case of bananas sold through the Banana Control Board, referred to in section 3 of the said Scheme, the gross price realised by the said Board for such bananas; and
- (ii) in the case of bananas sold otherwise than through the said Board, the average price realised by the Board for all grades and sizes of bananas sold through the said Board.

BYLAE.

- (a) op kafferkoerigmout wat deur of ten behoeve van 'n produsent daarvan verkoop word of deur hom aangewend word vir enige ander doel as vir verbruik deur homself of vir verbruik deur lede van sy huisgesin of vir die voer van sy lewende hawe; en
- (b) op kafferkoerigmout wat in die Republiek ingevoer word.
