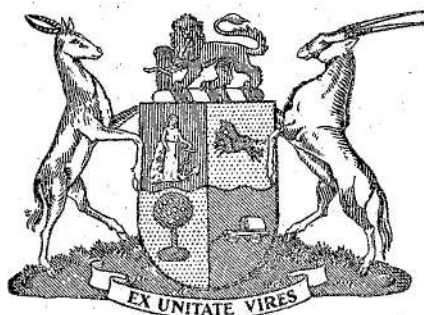

PRYSBEHEER.

MAKSIMUM PRYSE VAN SUIKER.

Ek, Heinrich Rudolph Philip August Kotzenberg, Prys-kontroleur, handelende kragtens die bevoegdheid my verleen by artikel vier van die Wet op Prysbeheer, 1964 (Wet No. 25 van 1964), wysig hierby Goewermenskennisgewing No. R. 1470 van 11 September 1962 deur die bestaande paragraaf 3 deur die volgende nuwe paragraaf te vervang:—

„3. Behoudens die bepalings van die Eerste Bylae hiervan, is die maksimum pryse waarteen meulverpakte suiker in houers van minder as 25 lb. deur enigeen aan iemand anders verkoop mag word, die pryse wat gespesifiseer word in, of berekenbaar is ooreenkomstig die bepalings van die Derde Bylae hiervan, *plus* 'n halfsent per lb., op voorwaarde dat meulwit of geraffineerde suiker wat nie aldus verpak is nie, in voorraad gehou word en aan enigiemand wat dit wil koop, ingevolge die bepalings van paragrafe 1 en 2 verkoop word.”

OPMERKING.—Die uitwerking van hierdie kennisgewing is dat die pryse van meulverpakte suiker teen 'n halfsent per lb. bo die pryse van suiker wat nie aldus verpak is nie, vasgestel word.

PRICE CONTROL.

MAXIMUM PRICES OF SUGAR.

I, Heinrich Rudolph Philip August Kotzenberg, Price Controller, acting under the powers vested in me by section four of the Price Control Act, 1964 (Act No. 25 of 1964), hereby amend Government Notice No. R. 1470 of 11th September, 1962, by substituting the following new paragraph for the existing paragraph 3:—

“3. Subject to the provisions of the First Schedule hereto, the maximum prices at which mill-packed sugar in containers of less than 25 lb. may be sold by any person to any other person, are the prices specified in, or determinable in accordance with the provisions of the Third Schedule hereto, *plus* half a cent per lb., on condition that mill white or refined sugar not thus packed shall be stocked and sold in terms of the provisions of paragraphs 1 and 2 to any person who wishes to purchase it.”

NOTE.—The effect of this notice is to fix the prices of mill-packed sugar at half a cent per lb. above the prices of sugar not thus packed.
