BY THE STATE PRESIDENT OF THE REPUBLIC OF
SOUTH AFRICA.

SEA FISHERIES ACT, 1940.

CLOSED SEASONS AND SANCTUARIES.

Under the powers vested in me by section 4 (1) of the Sea Fisheries Act, 1940 (Act No. 10 of 1940), I hereby amend Proclamation No. R 37 of 1965, by the substitution of the following paragraph for paragraph (3):—

“(3) No person on any fishing boat licensed or required to be licensed to catch anchovies, pilchards, maasbanker or mackerel for the purpose of—

- (i) canning or the production of fish meal, fish oil or fish fertilizer; or
- (ii) sale to any person for the purpose of canning or the production of fish meal, fish oil or fish fertilizer,

shall capture, attempt to capture, disturb or remove any anchovy, pilchard, maasbanker or mackerel during the period from the first day of September to the thirty first day of December in any year, both days inclusive.”
