SALE OF MEALIES AND MEALIE PRODUCTS BY PRODUCERS OF MEALIES.

In terms of section 29 (1) of the Marketing Act, 1937 (No. 26 of 1937), I, Dirk Cornelis Hermanus Uys, Minister of Agriculture hereby make known that the Mealie Industry Control Board, referred to in section 3 of the Mealie and Kaffircorn Control Scheme, published by Proclamation No. R. 113 of 1961, as amended, has, in terms of section 26 of that Scheme, with my approval and with effect from 1 May 1968, imposed the prohibitions set out in the Schedule hereto in substitution for the prohibitions published by Government Notice No. 667 of 1 May 1964, as amended.

BYLAE.

1. By die toepassing van hierdie verbodsbepalings—

Ixopo, Kranskop, Lions River, Mooi River, Msinga, New Hanover, Nqutu, Pietermaritzburg, Pinetown, Port Shepstone, Umvoti and Weenen in the Province of Natal;

(c) "Board" means the Mealie Industry Control Board referred to in section 3 of the Mealie and Kaffir-corn Control Scheme, published by Proclamation No. R. 113 of 1961, as amended;

(d) "Mealies" shall mean the classes and grades of mealies complying with the requirements for white dent, white flint, yellow flint and yellow flint-and-dent defined in Government Notice No. R. 602 of 28 April 1967, including mealies that should be graded as sample grade mealies in terms of the provisions of regulation 2 (3) of the said Government Notice No. R. 602;

(e) the word "producer" shall have the meaning assigned thereto in the Mealie and Kaffir-corn Control Scheme, published by Proclamation No. R. 113 of 1961, as amended; and

(f) the word "sell" shall have the meaning assigned thereto in the Marketing Act, 1937 (No. 26 of 1937).

2. Except under the authority of a permit issued by the Board in terms of section 26 of the Mealie and Kaffir-corn Control Scheme, published by Proclamation No. R. 113 of 1961, as amended, and subject to the conditions specified in such permit—

(a) no producer of mealies in area A, shall sell mealies or mealie products except to or through the Board or an agent of the Board;

(b) no producer of mealies in area B, shall sell mealies or mealie products to any person other than the Board or a person registered in terms of section 28 (1) (a) of the said Scheme.

DEFINITION OF AREA FOR PURPOSES OF CERTAIN REGISTRATIONS WITH THE MEALIE INDUSTRY CONTROL BOARD.

In terms of section 19 (1) of the Marketing Act, 1937 (Act No. 26 of 1937), I, Dirk Cornelis Hermanus Uys, Minister of Agriculture, hereby make known that the Mealie Industry Control Board, referred to in section 3 of the Mealie and Kaffir-corn Control Scheme, published by Proclamation No. R. 113 of 1961, as amended, has, in terms of section 28 (1) (a) of that Scheme with my approval and with effect from 1 May 1968, defined the area, in which no person dealing in the course of trade with mealies or mealie products shall, either on his own behalf or on behalf of any other person, purchase mealies (excluding hybrid mealies) or mealie products from a producer of mealies unless he has been registered with the Board, as comprising the Magisterial Districts of Alexandria, Aliwal North, East London, Kimberley, King William's Town, Kuruman, Matatiele, Mount Currie, Port Elizabeth, Queenstown, Uitenhage, Umzimkulu of the Cape Province, those portions of the Magisterial Districts of Gordonia, Hay, Kenhardt and Prieska of the Cape Province situated in a strip 30 miles north and 30 miles south of the Orange River between Boegoeberg Dam and a point on the Orange River directly north of Noudonsies and the Magisterial Districts of Camperdown, Durban, Hlabisa, Ixopo, Kranskop, Lion's River, Mooi River, Msinga, New Hanover, Nqutu, Pietermaritzburg, Pinetown, Port Shepstone, Umvoti and Weenen of the Province of Natal.

Kranskop, Lion's River, Mooirivier, Msinga, New Hanover, Nqutu, Pietermaritzburg, Pinetown, Port Shepstone, Umvoti and Weenen van die Provinsie Natal.

REGULATIONS RELATING TO THE GRADING, PACKING AND MARKING OF MAIZE PRODUCTS.—AMENDMENT.

The State President has, under the powers vested in him by section 43 of the Marketing Act, 1937 (No. 26 of 1937), further amended the regulations relating to the grading, packing and marking of maize products published by Government Notice No. R. 607 of 30 April 1965, as amended, as set out in the Schedule hereto.

SCHEDULE.

The regulations published by Government Notice No. R. 607 of 30 April 1965, are hereby amended by the substitution in regulation 2 for Tables I and IV of the following Tables respectively:—

(i) at a price other than 14 cents per 10 lb if such mealies are of the grades WD1, WD2, YF1, YM1 and YM2 mentioned in the table above;

(ii) at a price other than 13.5 cents per 10 lb if such mealies are of the grades WD3, WF1, WF2 and YM3 mentioned in the table above;

(iii) at a price higher than 14 cents per 10 lb if such mealies are sample grade mealies.

(2) The prices mentioned in paragraph 1 (b) do not include the value of a container and if the mealies are delivered in a container, the producer and the buyer shall determine the price of the container by mutual agreement.

2. In the calculation of the price payable in accordance with clause 1, any fraction of a cent, if less than a half cent, may be regarded as a half cent and, if more than a half cent, as a cent.

3. The prices for the respective classes and grades of mealies mentioned in clause 1 shall apply in respect of mealies delivered—

(1) at the premises of the buyer or any premises indicated by the buyer if such premises are not situated more than 5 miles from the buyer's nearest railing point: Provided that if the mealies are delivered at premises which are situated more than 5 miles from the buyer's nearest railing point, the price shall be reduced by cost of transport calculated at Railway Road Transport Tariff from the premises where the mealies are delivered to the buyers nearest railing point; or

(2) at any railing point indicated by the buyer for despatch by rail to a destination other than the buyer's premises or to an elevator in respect of which the in-transit rates apply.

4. For the purpose of these regulations, the net weight of mealies of which the moisture content exceeds $12\frac{1}{2}$ per cent by weight, shall be calculated on a basis of $12\frac{1}{2}$ per cent moisture content.

PRICES FOR MAIZE PRODUCTS.

In terms of section 29 (1) of the Marketing Act, 1937 (No. 26 of 1937), I, Dirk Cornelis Hermanus Uys, Minister of Agriculture, do hereby make known that the Mealie Industry Control Board, referred to in section 3 of the Mealie and Kaffircorn Control Scheme, published by Proclamation No. R. 113 of 1961, as amended, has, in terms of section 27 of that Scheme, with my approval and with effect from 1 May 1968, imposed the prohibitions set out in the Schedule hereto in substitution of the prohibitions published by Government Notice No. R. 706 of 12 May 1967, as amended.

SCHEDULE.

Definitions.

1. For the purposes of this notice—

(i) "maize products" means the maize products to which the regulations published by Government Notice No. R. 607, dated 30 April 1965, as amended, relates;

(ii) "nearest railway station" means the nearest railway station or siding, including any private siding, to which a train service is conducted;

(iii) "supply point" means the manufacturer's nearest railway station or any other premises which are not situated on a railway line and from which maize is supplied to the manufacturer;

(iv) "bleached kraft bags" means single-walled paper bags manufactured from bleached kraft with minimum substance weight of 100 grammes per square metre per wall or double-walled paper bags manufactured from bleached kraft with a minimum substance weight of 50 grammes per square metre per wall; and

(v) "unglazed sack kraft bags" means 3- or 4- or 5-ply paper bags manufactured from pure unglazed sack kraft with a minimum substance weight of 80 grammes per square metre per ply.

Millers' Prices for Maize Products.

2. Subject to the provisions of clauses 4, 5 and 6 hereof, no person shall sell any maize product specified in Tables A, B, C, D, E, F, G and H hereunder and manufactured by himself or on his behalf or acquired by himself or on his behalf, in any quantity mentioned in the said tables and contained in the containers specified therein, at a price in excess of the price specified in the relevant table in respect of that maize product: Provided that any of the said maize products which is of a class and grade that are not manufactured by himself or on his behalf but which have been obtained by himself or on his behalf, shall be excluded from this prohibition.

Subject to the provisions of clauses 4, 5 and 6 the price for a maize product which is sold in a container containing any quantity less than 90 lb for which no price is prescribed in Tables B, C, D, E, F, G and H, shall be calculated in proportion to the price specified in the said tables for the relevant maize product packed in the relevant container and for the specified weight immediately higher than the actual weight of the maize product thus sold.

(b) by an amount not exceeding 7 cents per 180 lb net weight when the total quantity of maize products sold to one person at one and the same time is 1,800 lb or less;

(c) by 2 cents per 180 lb net weight in respect of every month or part thereof after the end of the month which immediately follows the month during which delivery or despatch of such maize product was effected and during which the price remains unpaid.

5. The prices calculated in terms of clauses 2, 3 and 4 above, apply in respect of maize products delivered at the manufacturer's premises on which such product was manufactured and may, in respect of maize products delivered at any other place, be further increased—

(a) by the actual railage or railway road transport service charges paid by such manufacturer on maize products delivered by rail or railway road transport service;

(b) by an amount mutually agreed upon between the manufacturer and the buyer in respect of cost of delivery by road transport other than railway road transport service.

6. In the calculation of the price of any maize product in terms of the foregoing provisions, an amount of less than a half cent may be increased to half a cent.
