**ADMISSION OF PERSONS TO THE UNION  
REGULATION ACT, 1913**

**REGULATION**

The State President has, in terms of section 26 of the Admission of Persons to the Union Regulation Act, 1913 (Act 22 of 1913), as amended, been pleased to make the following regulations in substitution for regulation 20 (1) and 20 (6) promulgated by Government Notice 491, published in *Government Gazette Extraordinary* 761 dated 3 April 1964:—

"20. (1) A temporary permit which may be issued to a prohibited person under subsection (1) of section twenty-five of the Act shall be in the form set out in Annexure 5, or Annexure 5 (a) or Annexure 5 (b) to these regulations, and shall entitle the holder to enter

"20. (6) Ten opsigte van elke permit in die vorm soos voorgeskryf in Aanhangel 5, moet 'n bedrag van twee rand betaal word, en ten opsigte van elke permit in die vorm soos voorgeskryf in Aanhangel 5 (b), moet 'n bedrag van 50c betaal word, en die paspoortbeheerbeampete kan voorts na sy goedvinde van die houer van sodanige permit verlang om 'n bedrag van hoogstens R1,000 te deponeer as waarborg dat die houer die voorwaardes, gemeld in die permit, sal nakom of om dié sekerheid wat die paspoortbeheerbeampete voldoende ag, vir die betaling van sodanige bedrag in plaas van sodanige deposito te stel. Die deposito word terugbetaal alleenlik nadat daar aan dié voorwaardes voldoen is en wanneer so 'n persoon die Republiek of die provinsie, na gelang van die geval, binne die tydperk waarvoor die permit uitgereik is, verlaat of wanneer die houer nie meer 'n verbode persoon is nie. Ten opsigte van 'n permit in die vorm soos voorgeskryf in Aanhangel 5 (a), word geen bedrag betaal of deposito vereis nie."

## WET OP VREEMDELINGE, 1937

## REGULASIE

Dit het die Staatspresident behaag om kragtens artikel 11 van die Wet op Vreemdelinge, 1937 (Wet 1 van 1937), soos gewysig, die Regulasies afgekondig by Goewerments-kennisgewing R. 337, gepubliseer in *Buitengewone Staatskoerant* 739 van 6 Maart 1964, te wysig—

(a) deur regulasie 6 (3) deur die volgende regulasie te vervang:—

"6. (3) Die Paspoortbeheerbeampete kan, na goeddunke, van die houer van 'n tydelike permit wat kragtens subartikel 1 van artikel vyf van die Wet uitgereik mag word, vereis om 'n bedrag van hoogstens eenduisend rand (R1,000) as sekuriteit te deponeer vir die nakoming deur die houer van die voorwaardes in die tydelike permit vermeld, of om enige sekuriteit te stel wat die paspoortbeheerbeampete voldoende ag vir die betaling van sodanige bedrag in plaas van sodanige deposito. Die deposito word terugbetaal slegs wanneer die vermelde voorwaardes nagekom is en wanneer sodanige houer die Republiek of Suidwes-Afrika verlaat binne die tydperk waarvoor die permit uitgereik is.";

## WET OP GRENΣBEHEER, 1967

Dit word vir algemene inligting bekendgemaak dat ingevolge die bepalings van die Wet op Grensbeheer (Wet 61 van 1967) is die "Wet tot Regeling van de Toelating van Personen tot de Unie, 1913," (Wet 22 van 1913), soos gewysig, en die Wet tot Reëling van Vertrek uit die Unie, 1955 (Wet 34 van 1955), soos gewysig, met ingang 1 Februarie 1969 onder andere, in die volgende opsigte gewysig:—

(a) Niemand mag die Republiek of die Gebied Suidwes-Afrika binnekomm of verlaat behalwe by 'n toegangspoort nie, tensy magtiging aan hom deur die Minister van Binne-landse Sake of 'n paspoortbeheerbeampete, soos omskryf in die "Wet tot Regeling van de Toelating van Personen tot de Unie, 1913," verleen is om die Republiek of die Gebied Suidwes-Afrika by 'n ander plek as 'n toegangspoort binne te kom of te verlaat.

the Republic or any particular province or to reside temporarily in the Republic or any particular province or portion of a province for some approved purpose."

"20. (6) In respect of each permit in the form set out in Annexure 5 a fee of two rand shall be paid, and in respect of each permit in a form set out in Annexure 5 (b) a fee of 50c shall be paid, and the Passport Control Officer may, further, in his discretion, require the holder of any such permit to deposit a sum not exceeding R1,000 as security for the observance by the holder of the conditions mentioned in the permit, or to furnish any security which the Passport Control Officer deems sufficient, for the payment of such sum, in lieu of such deposit. The deposit shall only be refunded upon the fulfilment of those conditions and upon such person leaving the Republic or the province (as the case may be) within the period for which the permit is issued or when the holder ceases to be a prohibited person. In respect of any permit in a form set out in Annexure 5 (a), no fee shall be paid nor shall any deposit be required thereon."

## ALIENS ACT, 1937

## REGULATION

The State President has, in terms of section 11 of the Aliens Act, 1937 (Act 1 of 1937), as amended, been pleased to amend the regulations as promulgated by Government Notice R. 337, published in *Government Gazette Extraordinary* 739 dated 6 March 1964 as follows:—

(a) The substitution of regulation 6 (3) by the following regulation:—

"6. (3) The Passport Control Officer may, in his discretion, require the holder of any temporary permit issued under subsection 1 of section five of the Act, to deposit a sum not exceeding one thousand rand (R1,000) as security for the observance by the holder of the conditions mentioned in the temporary permit or to furnish any security which the Passport Control Officer deems sufficient for the payment of such sum in lieu of such deposit. The deposit shall be refunded only upon fulfilment of the said conditions and upon such holder leaving the Republic or South West Africa within the period for which the permit is issued."

## BORDER CONTROL ACT, 1967

It is hereby notified for general information that in terms of the provisions of the Border Control Act, 1967 (Act 61 of 1967), the Admission of Persons to the Union Regulation Act, 1913 (Act 22 of 1913), as amended, and the Departure from the Union Regulation Act, 1955 (Act 34 of 1955), as amended, are amended with effect from 1 February 1969 in the following respects:—

(a) No person shall enter or depart from the Republic or the Territory of South West Africa except through a port of entry, unless authority has been granted to him by the Minister of the Interior or a Passport Control Officer, as defined in the Admission of Persons to the Union Regulation Act, 1913, to enter or depart from the Republic or the Territory of South West Africa at a place other than a port of entry.

(b) Vir doeleindes van die "Wet tot Regeling van de Toelating van Personen tot de Unie, 1913," soos gewysig, en die Wet tot Reëling van Vertrek uit die Unie, 1955, beteken 'n "hawe" of "toegangspoort"—

(i) enige plek aan die kus van die Republiek of die Gebied Suidwes-Afrika; of

(ii) enige spoorwegstasie of plek in die Republiek of die gebied Suidwes-Afrika aan of by die grense; of

(iii) enige lughawe of vliegveld,

waar 'n paspoortbeheerbeampte gestasioneer is.
