In terms of section 79 (1) (b) of the Marketing Act, 1968 (No. 59 of 1968), I, Dirk Cornelis Hermanus Uys, Minister of Agriculture, hereby make known that the Canning Apricot and Peach Board, referred to in section 3 of the Canning Apricot and Peach Scheme, published by Proclamation R. 224 of 1966, as amended, has, in terms of section 19 of that Scheme, with my approval and, with effect from the date of publication hereof, imposed the prohibitions set out in the Schedule hereto, in substitution of the prohibitions published by Government Notice R. 2192 of 29 November 1968, which is hereby repealed.

PRICE CONTROL

MAXIMUM PRICES OF ADMISSION TO BIOSCOPES, DRIVE-IN AND CINEMA THEATRES

I, Gabriel Joseph Johannes Fourie Steyn, Price Controller, acting under the powers vested in me by sections 4 and 9 of the Price Control Act, 1964 (Act 25 of 1964), do hereby prescribe as follows:—

1. The maximum prices of admission to bioscopes, drive-in and cinema theatres which exhibited motion pictures before or on 21 November 1969 shall be the prices ordinarily charged by such bioscopes, drive-in and cinema theatres on the said date.

2. No person shall exhibit any motion pictures in bioscopes, drive-in and cinema theatres which on or before 21 November 1969 did not exhibit motion pictures unless he has obtained my prior written approval for the maximum admission fees which he may charge in respect of the exhibition of motion pictures in such bioscopes, drive-in and cinema theatres.

3. This notice shall apply in the Republic.

4. Government Notice R. 2014, dated 15 December 1966, is hereby repealed.

2. Place your own address on the back of the envelope or wrapper.
3. Do not enclose coins or other hard objects in letters.
4. Send remittances by Postal Order or Money Order.
5. Pack parcels properly, using strong containers and heavy paper. Tie securely.
6. Prepay postage fully.
7. Place postage stamps in the upper right hand corner of the envelope or wrapper.
8. Insure your parcels and register valuable letters. Documents which can only be replaced at considerable cost should preferably be insured.
9. Post early and often during the day. Mail held until the last moment may cause delay.
10. Give your correspondents your correct post office address including your box number where applicable.
