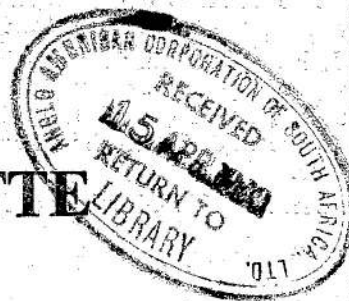

LEVY ON WOOL

In terms of section 14 (2) of the Wool Act, 1967 (No. 59 of 1967), I, Dirk Cornelis Hermanus Uys, Minister of Agriculture, hereby make known that the South African Wool Board, referred to in section 2 of the said Act, has in terms of section 14 (1), with my approval and with effect from 1 July 1970, imposed a levy of two cent (2c) per kilogram on all wool, including Karakul wool, produced, sold or processed in or exported from the Republic, in substitution for the levies made known by Government Notice R. 877 of 30 May 1969, which is hereby repealed.

EMPLOYEES' PROVIDENT FUND REGULATIONS

The following corrections are to be made in the English text of Government Notice R. 3938, dated 12 December 1969, published in *Government Gazette* 2579 (Regulation Gazette 1208), dated 12 December 1969:

1. In paragraph 1 thereof, under the definition "full benefit", for paragraph (b) substitute the following new paragraph:

"(b) an amount which—

(i) in the case of a benefit which became payable before 1 April 1969, shall be calculated at two per cent of the amount determined in terms of paragraph (a); and

(ii) in the case of a benefit becoming payable on or after that date, shall be calculated at $2\frac{1}{2}$ per cent of the amount determined in terms of paragraph (a),

and which shall be payable in respect of every completed year of the period in which the member concerned actually contributed to the Fund [including a period included in his contributory service in terms of regulation 9 (2)] and which is calculated and payable in respect of a portion of a year in such period at a percentage of the amount determined in terms of paragraph (a), which bears the same ratio to two per cent or $2\frac{1}{2}$ per cent, as the case may be, as the number of days in such period bears to three hundred and sixty-five;"

2. In paragraph 2 thereof, for the words "at least" where they appear in the new regulation 7 (5) (a) substitute the words "the last".
