REPEAL OF THE PROHIBITION OF GOLD AND FOREIGN EXCHANGE TRANSACTIONS AND OF TRANSACTIONS IN STOCKS AND SHARES

Under the powers vested in me by section 9 of the Currency and Exchanges Act, 1933 (Act 9 of 1933), as amended, I hereby repeal with effect from 21 December 1971, regulation 2, and with effect from 22 December 1971, regulation 1, promulgated by Proclamation 288 published in *Regulation Gazette* 1551, dated 20 December 1971.

ESTABLISHMENT OF A NEW PARITY FOR THE RAND AND A NEW STATUTORY GOLD PRICE

Under the powers vested in me by section 9 of the Currency and Exchanges Act, 1933 (Act 9 of 1933), as amended, I hereby make the following regulations:

(1) As from the twenty-first day of December 1971, the par value of the Rand shall be 1,09135 gram of fine gold.

(2) As from the same date R28,30 per ounce of fine gold shall be deemed to be the statutory price of gold for the purposes of the said Currency and Exchanges Act, 1933.
