

PRICE CONTROL

MAXIMUM PRICES OF CERTAIN GOODS

I, Gabriël Joseph Johannes Fourie Steyn, Price Controller, acting under the powers vested in me by sections 4, 11 and 15 of the Price Control Act, 1964 (Act 25 of 1964), do hereby prescribe as follows:

1. The maximum prices at which any person may sell the goods specified in the Schedule hereto, to any person, is the price at which he ordinarily would have sold such goods on 1 November 1971.

2. If the cost of the goods specified in the Schedule hereto has increased or increases after 21 December 1971, any manufacturer, importer or dealer who sells any such goods, the cost of which has so increased, may increase his selling price of those goods by the same percentage as that by which the cost of the goods concerned has increased, provided that any such price increase shall not be put into operation before 30 days have expired from the date on which he has, in writing, by express registered mail advised the Price Controller, Private Bag 84, Pretoria, of full particulars of any such increases in the cost of the goods concerned as well as of the increases in his selling prices which he intends to put into operation, and provided further that the Price Controller has not, before the expiry of the 30 days from the date upon which he had been thus advised by the manufacturer, the importer or the dealer concerned, directed that manufacturer, importer or dealer to postpone or amend his intended price increases.

3. In this notice "cost" shall mean cost as prescribed in Government Notice R. 1532 of 2 October 1964.

4. These regulations apply in the Republic.

MAKSIMUM PRYSE VAN SEKERE GOEDERE

Ek, Gabriël Joseph Johannes Fourie Steyn, Pryscontroleur, handelende kragtens die bevoegdheid my verleen by artikels 4, 11 en 15 van die Wet op Prysbeheer, 1964 (Wet 25 van 1964), bepaal hierby soos volg:

1. Die maksimum pryse waarteen iemand die goedere wat in die Bylae hiervan aangegee word, aan iemand anders mag verkoop, is die pryse waarteen hy sodanige goedere gewoonlik op 1 November 1971 verkoop het.

2. Indien die kosprys van die goedere wat in die Bylae hiervan aangegee word na 21 Desember 1971 gestyg het of styg kan 'n vervaardiger, invoerder of handelaar wat enige sodanige goedere waarvan die kosprys aldus gestyg het, verkoop, die verkoopprijs van die betrokke goedere met dieselfde persentasie as dié waarmee die kosprys van die betrokke goedere gestyg het, verhoog, met dien verstande dat enige sodanige prysverhoging nie in werking gestel word voor die verloop van 30 dae vanaf die datum waarop hy die Pryscontroleur, Privaatsak 84, Pretoria, skriftelik per aangetekende spoedpos van volledige besonderhede van enige sodanige stygings in die kospryse van die betrokke goedere asook van die verhogings in sy verkoopprijs wat hy van voorneme is om in werking te stel, in kennis gestel het nie, en mits die Pryscontroleur nie voor die verloop van 30 dae vanaf die datum waarop hy deur die betrokke vervaardiger, invoerder of handelaar aldus in kennis gestel is, daardie vervaardiger, invoerder of handelaar gelas om sy voorgenome prysverhogings af te stel of te wysig nie.

3. In hierdie kennisgewing het "kosprys" die betekenis soos bepaal in Goewermenskennisgewing R. 1532 van 2 Oktober 1964.

4. Hierdie regulasies is in die Republiek van toepassing.

1. Alle soorte elektriese en nie-elektriese huishoudelike toerusting en onderdele daarvan.

- 2. Radios, radiograms, high-fidelity sets, gramophones, sound recorders and reproducers, record players, tape and wire decks, loud speakers and amplifiers and accessories therefore.
- 3. Photographic and cinematographic cameras, enlargers and reducers, projectors, sound recorders and reproducers including any combination of these articles, and accessories for such articles.
- 4. Jewellery and parts thereof including clocks and watches.
- 5. Agricultural machinery, implements and equipment and parts thereof.

- 2. Radio's, radiogramme, klanktroue toestelle, grammofoon, klankopnemers en -weergewers, platespelers, band- of draadeenhede, luidsprekers en klankversterkers en bykomende benodigdhede vir hierdie artikels.
- 3. Fotografiese en kinematografiese kameras, vergroters en verkleiners, projektors, klankopnemers en -weergewers en enige kombinasie van hierdie artikels met inbegrip van bykomende benodigdhede daarvoor.
- 4. Juweliersware en onderdele daarvan met inbegrip van uurwerke en horlosies.
- 5. Landboumasjinerie, -implemente en -toerusting en onderdele daarvoor.
