### REGULASIE 10

1. Vervang subregulasie (6) deur die volgende subregulasie:

### SCHEDULE

### REGULATION 10

1. Substitute for sub-regulation (6) the following sub-regulation:

“(6) (a) Subject to the provisions of sub-regulations (1) and (3) any person, except an officer or employee referred to in sub-regulation (1), who possess, carry or use an arm as defined in section 1 of the Arms

Wapens en Ammunisie, 1969 (Wet 75 van 1969) of enige voorwerp, behalwe 'n wapen, wat waarskynlik ernstige liggaaamlike letsel sal veroorsaak indien dit gebruik sou word om 'n aanranding te pleeg (hier-na genoem 'n gevaaarlike wapen) buite die grense van die erf, perseel of terrein waarop hy woon, besit, dra of gebruik, skuldig aan 'n misdryf.

- (b) Die Minister kan van tyd tot tyd by kennisgewing in die *Staatskoerant* die distrik Ovamboland of enige deel van die distrik Ovamboland uitsluit van die bepalings van hierdie subregulasie en kan enige kennisgewing deur hom uitgereik, intrek of wysig.
- (c) Enigets wat na 3 Februarie 1972, maar voor die afkondiging van hierdie paragraaf gedoen is en wat wettiglik kragtens hierdie subregulasie gedoen kan word, word geag wettiglik gedoen te wees."

and Ammunition Act, 1969 (Act 75 of 1969) or any object, other than an arm, which is likely to cause serious bodily injury if it were used to commit an assault (hereinafter called a dangerous weapon), beyond the boundary of the erf, allotment or site upon which he resides, shall be guilty of an offence.

- (b) The Minister may from time to time by notice in the *Gazette* exclude the district of Ovamboland or any part of the district of Ovamboland from the provisions of this sub-regulation and may withdraw or amend any notice issued by him.
- (c) Anything done after the 3rd of February, 1972, but prior to the publication of this paragraph, which can lawfully be done under this sub-regulation shall be deemed to have been lawfully done."
