EXPORT CONTROL

I, Stefanus Louwrens Muller, Minister of Economic Affairs, acting by virtue of the powers vested in me by section 2 of the Import and Export Control Act, 1963 (Act 45 of 1963), hereby amend Government Notice R. 637, dated 23 April 1971, as follows:

1. By the addition of the words "G. The Secretary for Health, Private Bag X88, Pretoria." at the end of paragraph 2 (i); and

2. by the addition of the words—

(a) "Human blood and preparations of human blood as described in Part I, paragraph 2 (2) (a) and (b) of the Regulations for the Control of Blood Transfusion Services as promulgated by Government Notice R. 1950 of 30 November 1962, . . . GIE."; and

(b) "Fish, canned . . . N", at the end of Group 8 of Schedule I.

(b) "Vis, ingemaak . . . N".
