HIRE PURCHASE ACT, 1942

1. I, Abraham Hermanus du Plessis, Deputy Minister of Economic Affairs, do hereby, on behalf of the Minister of Economic Affairs, prescribe in terms of section 2bis (1) (a) of the Hire Purchase Act, 1942 (Act 36 of 1942), that at least one quarter of the cash price of goods of the class or group of movable goods set out in the Schedule hereto shall be paid in a cash amount or in goods before an agreement in respect of the sale of such goods shall be of force or effect.

2. Government Notice R. 1005 of 7 July 1965 is hereby withdrawn.

CLASS OR GROUP OF GOODS
