PRICE CONTROL

CONDITIONS OF SALE.—TELEVISION SETS AND ACCESSORIES THEREFOR

1. I, Gabriël Joseph Johannes Fourie Steyn, Price Controller, do hereby by virtue of the provisions of section 9 of the Price Control Act, 1964 (Act 25 of 1964), prohibit the sale of television sets and accessories therefor subject to conditions in terms of which—

(a) such goods will be supplied to the purchaser more than 30 days after the sale is effected; and

(b) payments under the agreement are to be made to the seller in respect of the goods before they are delivered to the purchaser.

2. For purposes of this notice the expression "sale" shall, in addition to the meaning it has in terms of section 1 of the above-mentioned Act, include any disposal of television sets or accessories therefor by way of lease-lend or lease, or any offer, invitation or agreement, whether orally, in writing or by way of advertisement, in terms of which any person may obtain the possession, use or enjoyment of a television set or accessories therefor and in consideration of which the said person is required to pay another person or his successors in title any amount in cash or in kind.

VERKOOPVOORWAARDES.—TELEVISIESTELLE EN TOEBEHORE DAARVOOR

1. Ek, Gabriël Joseph Johannes Fourie Steyn, Prys-kontroleur, verbied hierby kragtens die bepalings van artikel 9 van die Wet op Prysbeheer, 1964 (Wet 25 van 1964), die verkoop van televisiestelle en toebehore daarvoor op voorwaardes waarvolgens—

(a) sodanige goedere meer as 30 dae na die verkoop aangegaan is, aan die koper verskaf sal word; en

(b) betalings ingevolge die ooreenkoms aan die koper ten opsigte van die goedere voordat hulle aan die koper afgelewer is, gemaak moet word.

2. By die toepassing van hierdie kennisgewing beteken die uitdrukking "verkoop" benewens die betekenis wat dit ingevolge die omskrywing daarvan in artikel 1 van genoemde Wet het, ook 'n beskikking oor televisiestelle of toebehore daarvoor by wyse van 'n bruikleen- of huur-ooreenkoms, of 'n aanbod, uitnodiging of ooreenkoms, hetsy mondeling, skriftelik of by wyse van advertensie, waarvolgens 'n persoon die besit, gebruik of genot van 'n televisiestel of toebehore daarvoor kan verkry en as teenprestasie waarvoor van genoemde persoon vereis word om aan 'n ander persoon of sy opvolgers in titel 'n bedrag in geld of in goedere te betaal.
