#### ROAD TRAFFIC ORDINANCE, 1966.—REGISTERING AUTHORITY FOR THE AREA OF THE MACHANGANA LEGISLATIVE ASSEMBLY AND THE ASSIGNMENT OF REGISTRATION MARKS

The Executive Council for the area for which the Machangana Legislative Assembly was established herein-after called the Area) acting under and by virtue of the powers vested in it by sections 2 (1) and 8 (1) of the Road Traffic Ordinance, 1966 (Ordinance 21 of 1966) (Transvaal), read with section 21 of the Bantu Homelands Constitution Act, 1971 (Act 21 of 1971)—

(a) hereby designate with effect from 1 January 1973, the Magistrates in the Area as registering authorities in respect of their respective districts or areas;

(b) hereby designate with effect from 1 January 1973, to each registering authority in the Area a combination of letters as registration mark in accordance with the accompanying Schedule.

### WYSIGING VAN DIE REGULASIES VIR DIE SUID- AFRIKAANSE POLISIE

Dit het die Staatspresident behaag om kragtens artikel 33 van die Polisiewet, 1958 (Wet 7 van 1958), sy goedkeuring te heg aan onderstaande wysigings van die Regulasies vir die Suid-Afrikaanse Polisie, soos gepubliseer by Goewermentskennisgewing R. 203 in *Buitengewone Staatskoerant* 719 (*Regulasiekoerant* 299) van 14 Februarie 1964, en later gewysig:

(1) *Regulasie 1 (1).*—Vervang die woordomskrywing van "diens" deur die volgende:

"'diens' enige ononderbroke voltydse Regeringsdiens in enige hoedanigheid en by die toepassing van hierdie omskrywing word 'n lid geag diens te doen terwyl hy—

(a) in sy amp geskors is;

(b) deelneem aan enige amateursport, oefening vir ontspanningsdoeleindes, opvoering, wedstryd of kompetisie in regulasie 4A bedoel; of

(c) deelneem aan 'n werksaamheid, plig of diens in regulasie 77 bedoel."

(2) *Regulasie 4.*—Voeg die volgende nuwe regulasie 4A in na die bestaande regulasie 4:

#### "DEELNAME AAN SPORT EN ONTSPANNING

4A. (1) Die Kommissaris kan magtiging verleen vir die instelling vir die Mag as geheel of op 'n plek wat hy geskik ag, van 'n sport- of ontspanningsklub (hierna 'n klub genoem) vir lede van die Mag en hulle gesinne, en hy wys 'n lid van die Mag aan om die besteding van geld te beheer wat vir hierdie doel deur die Parlement bewillig is of wat by wyse van ledegeld, wat onderworpe aan die Kommissaris se goedkeuring, by wyse van aftrekking van hulle salarisse van lede van die klub geïn kan word, of wat die klub op enige ander wyse mag toeval.

(2) Iedere lid van die Mag kan lid word van 'n klub wat aldus ingestel is, en kan deur bermiddeling daarvan deelneem aan enige sportsoort wat die Kommissaris vir dié doel goedgekeur het en waarvoor sodanige lid volgens die oordeel van sy bevelvoerder, in oorleg, waar hy dit nodig ag, met 'n distriksgenesheer of ander mediese praktisyen, liggaamlik geskik is: Met dien verstande dat

### SPECIAL LEVY ON MAIZE AND MAIZE PRODUCTS EXPORTED.—AMENDMENT

In terms of section 79 (a) of the Marketing Act, 1968 (No. 59 of 1968), I, Hendrik Stephanus Johan Schoeman, Minister of Agriculture, hereby make known that the Maize Board, referred to in section 2A of the Maize and Grain Sorghum Scheme, published by Proclamation R. 113 of 1961, as amended, has in terms of section 23 of that Scheme, with my approval and with effect from the date of publication hereof, further amended the special levy on maize and maize products, published by Government Notice R. 3285 of 12 September 1969, as amended, as set out in the Schedule hereto.

### AMENDMENT TO THE REGULATIONS FOR THE SOUTH AFRICAN POLICE

The State President has been pleased, under section 33 of the Police Act, 1958 (Act 7 of 1958), to approve the following amendments to the Regulations for the South African Police as published under Government Notice R. 203 in *Government Gazette (Extraordinary)* 719 (*Regulation Gazette* 299) of 14 February 1964, and subsequently amended:

(1) *Regulation 1 (1).*—Substitute the definition of "service" by the following:

"Service" means any continuous full-time Government service in any capacity, and for the purpose of this definition a member shall be deemed to be on duty while—

(a) suspended from office;

(b) participating in any kind of amateur sport, exercise for recreational purposes, performance, contest or competition referred to in regulation 4A; or

(c) performing a function, service or duty referred to in regulation 77."

(2) *Regulation 4.*—Add the following new regulation 4A after the existing regulation 4:

#### "PARTICIPATION IN SPORT AND RECREATION

4A. (1) The Commissioner may authorise, for the Force as a whole or at such place as he may deem fit, the establishment of a sport or recreational club (hereinafter called a club) for members of the Force and their families and shall appoint a member of the Force to control the spending of moneys voted by Parliament for this purpose, or received as membership fees, which may, subject to the Commissioner's approval, be deducted from salaries of members of the club, or which may accrue to the club in any other way.

(2) Every member of the Force may become a member of a club so established, and may, through its instrumentality participate in any amateur sport which has been approved by the Commissioner for that purpose, and for which such member, in the opinion of his commander, in consultation, where the said commander may deem this

(a) as deelnemer met staats- of ander vervoer soos deur die Kommissaris goedgekeur, na of van 'n oefening, opvoering, vertoning of wedstryd of kompetisie in 'n goedgekeurde sportsoort reis; of

(b) aan 'n oefening, opvoering, vertoning, wedstryd of kompetisie as 'n verteenwoordiger van die klub in 'n goedgekeurde sport deelneem;

(c) as lid of beampte van 'n ander sportklub soos in subregulasie (2) bedoel aan 'n goedgekeurde sportsoort deelneem, daarvoor oefen of daarby optree of met staatsvervoer deur die Kommissaris goedgekeur of ander vervoer na of van sodanige oefening, wedstryd of kompetisie reis; of

(d) as 'n beampte optree by, of met staats- of ander vervoer soos deur die Kommissaris goedgekeur, reis na of van 'n oefening, opvoering vertoning, wedstryd of kompetisie soos in paragraaf (a) bedoel.

(4) Ondanks die bepalings van subregulasies (1), (2) en (3), word 'n lid van die Mag wat aan 'n goedgekeurde sportsoort deelneem as lid of beampte van 'n span wat op streeks-, provinsiale of nasionalevlak gekies is, ten opsigte van enige besering wat hy in die loop van 'n wedstryd, kompetisie of oefening opdoen as lid of beampte van sodanige span, vir die toepassing van regulasie 53 (1) (a) geag op amptelike diens te wees".

necessary, with a district surgeon or other medical practitioner, is physically fit: Provided that wherever a club cannot be economically established or facilities cannot be provided for members to participate in an approved amateur sport, the Commissioner may permit such members to become members of any other club, and to that end, and for the application of this regulation, such other club shall be deemed to be a club.

(3) Subject to subregulations (1) and (2), a member of the Force shall be deemed to be on official duty during any period in which he—

(a) travels as a participant, by Government or any other transport approved by the Commissioner, to or from an exercise, performance, display, contest or competition in an authorised sport; or

(b) takes part in any exercise, performance, display, contest or competition as a representative of the club in an authorised sport;

(c) as a member or official of another club referred to in subregulation (2), officiate at or participate in any authorised exercise or sport or travels by Government transport approved by the Commissioner, or any other transport to or from such exercise or competition; or

(d) as an official officiates at, or travels by Government or other transport approved by the Commissioner, to or from such exercise, performance, display, contest or competition referred to in paragraph (a).

(4) Notwithstanding the provisions of subregulations (1), (2) and (3), a member of the Force who participates in an authorised sport as a member or official of a team selected at regional, provincial or national level, shall in the case of any injury sustained as a member or official in the course of such competition, contest or exercise, for the purpose of regulation 53 (1) (a) be deemed to be on official duty".

This amendment shall come into operation as from 14 February 1964.
