PRICE CONTROL

MAXIMUM PRICES OF PIPE TOBACCO

I, Gabriël Joseph Johannes Fourie Steyn, Price Controller, do hereby, in terms of section 4 of the Price Control Act, 1964 (Act 25 of 1964), prescribe, with effect from 28 March 1973, as follows:

1. The maximum price at which any person may sell pipe tobacco by retail is the price at which he ordinarily sold such pipe tobacco on 27 March 1973 plus one cent per 25 gram.

2. These regulations apply in the Republic.

3. Paragraph 60 of the Schedule to Government Notice R. 547 of 7 April 1972 is hereby withdrawn.

PRICE CONTROL

MAXIMUM PRICES OF CIGARETTES

I, Gabriël Joseph Johannes Fourie Steyn, Price Controller, acting under the powers vested in me by section 4 of the Price Control Act, 1964 (Act 25 of 1964), do hereby prescribe, with effect from 28 March 1973, as follows:

1. The maximum prices at which any person may sell cigarettes by retail are the prices at which he ordinarily sold such cigarettes on 27 March 1973 plus one cent per 10 cigarettes.

2. This notice applies in the Republic.

3. Government Notice R. 580 of 7 April 1971 is hereby withdrawn.
