SCHEDULE

1. In this notice, unless inconsistent with the context, any word or expression to which a meaning has been assigned in the South African Citrus Scheme, published by Proclamation R. 121 of 1964, as amended, shall have a corresponding meaning, and—

“carton” and “wirebound box” have the same meanings assigned thereto in the regulations published by Government Notice R. 549 of 3 April 1970, as amended.

2. A special levy of 0,83c per carton or wirebound box is hereby imposed on citrus fruit exported from the Republic excluding Valencia oranges, and of 3,83c per carton or wirebound box in the case of Valencia oranges.

3. A special levy is hereby imposed on citrus fruit sold through the Board in the Republic at the rate of 1c per 10 kg in the case of citrus fruit, excluding naartjies, Seville oranges, limes (Tahiti and West Indian) and grapefruit, and at the rate of 1c per 8,2 kg in the case of grapefruit: Provided that the mass of citrus fruit packed into a pocket measuring 710 mm long and 305 mm wide, shall be deemed to be 10 kg in the case of citrus fruit, excluding naartjies, Seville oranges, limes (Tahiti and West Indian) and grapefruit, and 8,2 kg in the case of grapefruit.

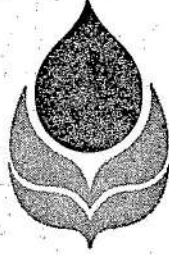
