**ACT 2 OF 1973 (VENDA ROAD TRAFFIC
AMENDMENT ACT, 1973)**

The State President has been pleased, under and by virtue of the powers vested in him by section 3 (2) of the Bantu Homelands Constitution Act, 1971 (Act 21 of 1971), to approve the following Act:

**VENDA ROAD TRAFFIC AMENDMENT ACT, 1973
(ACT 2 OF 1973)**

ACT

TO AMEND THE ROAD TRAFFIC ORDINANCE, 1966 (ORDINANCE 21 OF 1966) (TRANSVAAL), IN SO FAR AS IT APPLIES IN THE AREA FOR WHICH THE VENDA LEGISLATIVE ASSEMBLY HAS BEEN ESTABLISHED

Be it enacted by the Venda Legislative Assembly, as follows:

Amendment of section 1 of Ordinance 21 of 1966 (Transvaal)

1. Section 1 of the Road Traffic Ordinance, 1966 (Ordinance 21 of 1966) (Transvaal) (hereinafter referred to as the Ordinance), is hereby amended by the substitution for the definition of "registering authority" of the following definition:

"'registering authority' means the registering authority referred to in section 2;".

Substitution of section 2 of Ordinance 21 of 1966 (Transvaal)

2. The following section is hereby substituted for section 2 of the Ordinance:

"2. The Director of Justice shall be the registering authority for the area, as defined from time to time, for which the Venda Legislative Assembly has been established."

Daar word bepaal deur die Venda- Wetgewende Vergadering, soos volg:

Wysiging van artikel 1 van Ordonnansie 21 van 1966 (Transvaal)

1. Artikel 1 van die Ordonnansie op Padverkeer, 1966 (Ordonnansie 21 van 1966) (Transvaal) (hieronder die Ordonnansie genoem), word hierby gewysig deur die woordskrywing van "registrasie-owerheid" deur die volgende woordskrywing te vervang:

"'registrasie-owerheid' die registrasie-owerheid in artikel 2 bedoel;".

Vervanging van artikel 2 van Ordonnansie 21 van 1966 (Transvaal)

2. Artikel 2 van die Ordonnansie word hierby deur die volgende artikel vervang:

"2. Die Direkteur van Justisie is die registrasie-owerheid vir die gebied, soos van tyd tot tyd omskryf, waarvoor die Venda- Wetgewende Vergadering ingestel is."

Adaptation of Ordinance 21 of 1966 (Transvaal)

3. Any reference in the Ordinance to—

(a) the Administrator shall be construed as a reference to the Executive Councillor for Justice; and

(b) the *Provincial Gazette* shall be construed as a reference to the *Government Gazette* as defined in section 38 (1) of the Bantu Homelands Constitution Act, 1971 (Act 21 of 1971).*Short title and commencement*

4. This Act shall be called the Venda Road Traffic Amendment Act, 1973, and shall be deemed to have come into operation on 1 January 1973.

4. Hierdie Wet heet die Venda-wysigingswet op Padverkeer, 1973, en word geag in werking te getree het op Januarie 1973.
