PRICE CONTROL

MAXIMUM PRICES OF MILK

I, Tjaart Francois van der Walt, Deputy Price Controller, acting by virtue of the powers conferred on me by the Price Controller under section 3 of the Price Control Act, 1964 (Act 25 of 1964), do hereby amend, in terms of section 4 of the said Act, with effect from the date of publication hereof, Government Notice R. 321 of 2 March 1973, as amended, as set out in the Schedule hereto.
