#### PRICE CONTROL

#### MAXIMUM PRICES OF SUGAR

By virtue of the powers conferred on me by the Price Controller under section 3 of the Price Control Act, 1964 (Act 25 of 1964), I, Elias George de Beer, Deputy Price Controller, do hereby under section 4 of the said Act amend Government Notice R. 2014 of 1 November 1974 as follows:

1. The First Schedule is hereby amended by the addition in paragraph 1 (d) after the definition of the Magisterial District of Ganyesa 2, of the following:

“Hartswater 1” is that part of the Magisterial District of Hartswater bounded by the Magisterial Districts of Christiana, Taung and Warrenton.

“Hartswater 2” is that part of the Magisterial District of Hartswater bounded by the Magisterial Districts of Christiana, Schweizer-Reneke and Taung.”

2. The Second Schedule is hereby amended by—

(a) the substitution in paragraph 1 (a) of the coin pack wholesale prices by the following prices:

“50-pack bale of 5-cent mill packed coin packs, white refined, per two bales.....	4,45
25-pack bale of 10-cent mill packed coin packs, white refined, per two bales.....	4,45
25-pack bale of 10-cent mill packed coin packs, brown, per two bales.....	4,45
20-pack bale of 20-cent mill packed coin packs, brown, per one bale.....	3,55”

(b) the substitution of the figure “30” wherever it appears in paragraphs 1 (a) and (b) by the figure “31”, and the substitution of the figure and words “3c per kg” in paragraph (b) of the Afrikaans text by “3c per 25 kg.”;

(c) the substitution of the last sentence of paragraph 2 (a) by the following:

“When the sale is ex seller’s store and the sugar is railed on to the purchaser a further 3c per 25 kg unit may be added.”.

3. The Third Schedule is hereby amended by—

(a) the addition of the words “and Umlazi” to the word “Umbumbulu” in paragraph 1;

Kragtens die bevoegdheid my deur die Pryskontroleur verleen by artikel 3 van die Wet op Prysbeheer, 1964 (Wet 25 van 1964), wysig ek, Elias George de Beer, Adjunk-pryskontroleur, hierby ingevolge artikel 4 van genoemde Wet Goewermenskennisgewing R. 2014 van 1 November 1974 soos volg:

1. Die Eerste Bylae word hiermee gewysig deur in paragraaf 1 (d) na die definisie van die landdrostdistrik Ganyesa 2 die volgende in te voeg:

“Hartswater 1” is die deel van die landdrostdistrik Hartswater begrens deur die landdrostdistrikte Christiana, Schweizer-Reneke en Taung.

“Hartswater 2” is die deel van die landdrostdistrik Hartswater begrens deur die landdrostdistrikte Christiana, Schweizer-Reneke en Taung.”.
