## CONDITIONS OF SERVICE OF EMPLOYEES

By virtue of the powers vested in me by section 42 of the National Welfare Act, 1965 (Act 79 of 1965), read with section 21 (1) (c) of the Republic of South Africa Constitution Act, 1961 (Act 32 of 1961), I, Hendrik Hanekom Smit, Deputy Minister of Social Welfare and Pensions, do hereby amend the Regulations regulating the Registration of Social Workers, promulgated by Government Notice R. 1363 of 10 August 1973, as set out in the Schedule hereto.

## SCHEDULE

1. Regulation 11 is hereby amended by—

(a) the substitution for subregulation (1) of the following subregulation:

“(1) The commission may on the application of a person whose name has been removed from the register, made in the form of Schedule D, if it is satisfied that it is just that the name of such person be restored to such register, order that his name be so restored.”;

(b) the deletion of subregulation (2).
