**PRODUCER PRICES FOR OFFAL IN CONTROLLED
AREAS.—AMENDMENT**

In terms of section 79 (b) of the Marketing Act, 1968 (No. 59 of 1968), I, Hendrik Stephanus Johan Schoeman, Minister of Agriculture, hereby make known that the Livestock and Meat Industries Control Board, referred to in section 3 of the Livestock and Meat Control Scheme, published by Proclamation R. 200 of 1964, as amended, has under the powers vested in it by section 15 (w) of the said Scheme, with my approval and with effect from 5 April 1976, further amended the determinations published by Government Notice R. 1299 of 30 July 1971, as amended, as set out in the Schedule hereto.

SCHEDULE

The Minister of Health has, by virtue of the powers vested in him by section 44 of the Atmospheric Pollution Prevention Act, 1965 (Act 45 of 1965), made the following regulations:

- (1) (a) The form of an application for a registration or provisional registration certificate shall be as prescribed in the First Schedule to these regulations.
- (b) The application as contemplated in paragraph (a) shall be accompanied by plans and specifications which clearly illustrate appliances and processes employed and the location of the plant and appliances.
- (2) The form of the registration certificate shall be as prescribed in the Second Schedule to these regulations.
- (3) The form of the provisional registration certificate shall be as prescribed in the Third Schedule to these regulations.

AMENDMENT OF SCHEDULES 1 TO 9 TO THE MEDICINES AND RELATED SUBSTANCES CONTROL ACT, 1965 (ACT 101 OF 1965)

The Minister of Health has, by virtue of the powers vested in him by section 37A of the Medicines and Related Substances Control Act, 1965 (Act 101 of 1965), and on the recommendation of the Medicines Control Council, amended Schedules 1 to 9 to the said Act as indicated hereunder. This amendment shall come into force immediately after the date of its publication in the Gazette, except in the case of barbituric acid, its derivatives and salts thereof which have been amended in Schedule 1 and Schedule 5, and barbiturates which have been added to Schedule 2 and amended in Schedule 6, which will come into force six months after the date of the publication of this notice in the Gazette.

SCHEDULE 1

AMENDMENT TO WAGE DETERMINATION 326.—
COFFIN MANUFACTURING INDUSTRY, PRINCIPAL AREAS

(b) in the Magisterial Districts of the Cape, Wynberg [including that portion of the Magisterial District of Somerset West which, prior to 9 March 1973 (Government Notice 173 of 9 February 1973), fell within the Magisterial District of Wynberg] Simonstown, Goodwood and Bellville, in those portions of the Magisterial Districts of Malmesbury and Stellenbosch which, prior to the publication of Government Notices 171 of 8 February 1957 and 283 of 2 March 1962, respectively, fell within the Magisterial District of Bellville and in that portion of the Magisterial District of Kuils River which, prior to the publication of Government Notice 661 of 19 April 1974, fell within the Magisterial District of Stellenbosch but which, prior to 2 March 1962, fell within the Magisterial District of Bellville.

(2) Notwithstanding the provisions of subclause (1) (a), the terms of this Agreement shall—

(a) apply to apprentices only in so far as they are not inconsistent with the provisions of the Apprenticeship Act, 1944, or any conditions fixed thereunder;

(b) apply to "trainees" only to the extent to which they are not inconsistent with any provisions of the Training of Artisans Act, 1951, or any conditions prescribed in terms thereof;

(c) not apply to employers and employees engaged or employed in the Electrical Contracting Section of the Industry.
