PRICE CONTROL

MAXIMUM PRICES OF CIGARETTES

I, Elias George de Beer, Deputy Price Controller, acting under the powers assigned to me by the Price Controller in terms of section 3 of the Price Control Act, 1964 (Act 25 of 1964), do hereby, under section 4 of the said Act, prescribe, with effect from 2 April 1976, as follows:

1. The maximum prices at which any person may sell cigarettes by retail are the prices at which he ordinarily sold such cigarettes on 30 March 1976 plus 2c per 10 cigarettes.

2. This notice applies in the Republic.

3. Government Notice R. 650 of 4 April 1975 is hereby withdrawn.

PRICE CONTROL

MAXIMUM PRICES OF COAL

I, Elias George de Beer, Deputy Price Controller, acting under the powers assigned to me by the Price Controller in terms of section 3 of the Price Control Act, 1964 (Act 25 of 1964), do hereby amend, in terms of section 4 of the said Act, Government Notice R. 1030 of 23 May 1975, by substituting the following for regulation 4 thereof:

"4. Except as provided in regulation 3 hereof, the maximum price at which any person (other than a producer of coal) may sell coal to any other person, is the price ordinarily charged by the seller during March 1976

MAKSIMUM PRYSE VAN STEENKOOL

Ek, Elias George de Beer, Adjunk-pryskontroleur, handelende kragtens die bevoegdheid my deur die Prys-kontroleur verleen by artikel 3 van die Wet op Prysbeheer, 1964 (Wet 25 van 1964), wysig hierby ingevolge artikel 4 van genoemde Wet, Goewermentskennisgewing R. 1030 van 23 Mei 1975 deur regulasie 4 daarvan deur die volgende te vervang:

"4. Behoudens die bepalings van regulasie 3 hiervan, is die maksimum prys waarteen enigeen (uitgesonderd 'n steenkoolprodusent) steenkool aan enigiemand anders mag verkoop, die prys wat die verkoper gewoonlik gedurende

for such coal, or, if during the said period the seller did not sell coal, the maximum price at which he may sell coal, is the price ordinarily charged during the said month in the same or nearest locality, plus, in either case, 70 per cent of the additional railage resulting from the increase in the railage rate which became effective on 1 April 1976; provided that the price per bag in the case of sales by the bag may be rounded off to the next higher half cent".

PRICE CONTROL

MAXIMUM PRICES OF PIPE TOBACCO

I, Elias George de Beer, Deputy Price Controller, acting under the powers assigned to me by the Price Controller in terms of section 3 of the Price Control Act, 1964 (Act 25 of 1964), do hereby, under section 4 of the said Act, prescribe, with effect from 2 April 1976, as follows:

1. The maximum price at which any person may sell pipe tobacco by retail is the price at which he ordinarily sold such pipe tobacco on 30 March 1976 plus 2c per 25 gram.

2. This notice applies in the Republic.

3. Government Notice R. 1011 of 14 June 1974 is hereby withdrawn.
