

**PRODUCER PRICES FOR OFFAL IN CONTROLLED
AREAS.—AMENDMENT**

In terms of section 79 (b) of the Marketing Act, 1968 (No. 59 of 1968), I, Hendrik Stephanus Johan Schoeman, Minister of Agriculture, hereby make known that the Livestock and Meat Industries Control Board, referred to in section 3 of the Livestock and Meat Control Scheme, published by Proclamation R. 200 of 1964, as amended, has under the powers vested in it by section 15 (w) of the said Scheme, with my approval and with effect from 14 June 1976, further amended the determinations published by Government Notice R. 862 of 21 May 1976, as amended, as set out in the Schedule hereto.

SCHEDULE

The Schedule to Government Notice R. 862 of 21 May 1976, as amended, is hereby further amended by—

(a) the substitution for the tariffs for the calculation of the producer prices for sound offal for the controlled areas of Bloemfontein and Kimberley, as specified in Part 1 of the Annexure thereto, of the tariffs as set out in Part 1 of the Annexure hereto; and

(b) the substitution for the tariff for the calculation of the producer price for detained cattle offal for the controlled area of Kimberley, as specified in Part 2 of the Annexure thereto, of the tariff as set out in Part 2 of the Annexure hereto.

MENTAL HEALTH ACT, 1973

AMENDMENT OF THE GENERAL REGULATIONS

The Minister of Health has, in terms of the provisions of section 77 (1) of the Mental Health Act, 1973 (Act 18 of 1973), amended the General Regulations made in Government Notice R. 565, dated 27 March 1975, by the addition of the following subregulation (6) to General Regulation 6:

“(6) In cases where a person who is, with reference to a charge of murder or culpable homicide or a charge involving serious violence, considered to be a danger to himself and other persons, and is in terms of any law to be referred by a court of law for observation, he shall be observed in an institution to be determined in consultation with the Secretary for Health.”

WYSIGING VAN DIE ALGEMENE REGULASIES

Die Minister van Gesondheid het kragtens die bepalings van artikel 77 (1) van die Wet op Geestesgesondheid, 1973 (Wet 18 van 1973), die Algemene Regulasies, uitgevaardig by Goewermentskennisgewing R. 565 van 27 Maart 1975, gewysig deur die byvoeging van subregulasie (6) by Algemene Regulasie 6:

“(6) In gevalle waar iemand wat, met betrekking tot 'n aanklag van moord of strafbare manslag of 'n aanklag waarby ernstige geweld betrokke is, as gevaarlik vir homself en vir ander beskou word en ingevolge 'n wet deur die hof vir waarneming verwys moet word, word die inrigting waar hy waargeneem word in ooreenstemming met die Sekretaris van Gesondheid bepaal.”
