FOURTEENTH AMENDMENT TO THE STATE
AIRPORT REGULATIONS, 1963

The Minister of Transport has, under the provisions of section 22 of the Aviation Act, 1962 (Act 74 of 1962), amended the regulations as promulgated under Government Notice R. 1974 of 20 December 1963—

(1) by the insertion in regulation 2 in the definition of "airport" of the words "the S.W.D. Aerodrome (George)" after the words "the B. J. Vorster Aerodrome (Kimberley)";

(2) by the substitution in regulation 2 in the definition of "airport" for the words "the S.W.D. Aerodrome (George)" of the words "the P. W. Botha Aerodrome (George)";

(3) by the insertion in regulation 13A (2) and (3) of the words "S.W.D. (George)" after the words "J. G. H. van der Wath (Keetmanshoop)";

(4) by the substitution in regulation 13A (2) and (3) for the words "S.W.D. (George)" of the words "P. W. Botha (George)";

(5) by the substitution in regulation 13A (2) for "R1,50" of "R1,80";

(6) by the substitution in regulation 13A (3) for "R1,00" of "R1,20" and for "R1,25, R1,50 and R2,00" of "R1,50, R1,80 and R2,40", respectively;

(6) deur in regulasie 13A (3) "R1,00" deur "R1,20" te vervang en "R1,25, R1,50 en R2,00" onderskeidelik deur "R1,50, R1,80 en R2,40" te vervang;
