**BYLAE**

Die Piesangskema, afgekondig by proklamasie R. 109 van 1976, word hierby gewysig deur—

(a) subartikel (2) van artikel 36 deur die volgende subartikel te vervang:

"(2) Elke hoeveelheid piesangs aan die Raad vir verkoop gelewer, moet deur die Raad geklassifiseer word volgens die graad en groottegroep waartoe dit na bevinding van die Raad behoort, en vir rekening van die produsent deur wie dit aldus gelewer is, in bedoelde graad en groottegroep in die pool toegewys word.”;

(b) subartikel (3) van artikel 36 te skrap;

(c) subartikel (7) (b) (ii) van artikel 36 te skrap; en

(d) subartikel (9) van artikel 36 te skrap.

**BANANA SCHEME.—AMENDMENT**

Whereas the Minister of Agriculture has, under section 9 (2) (c), read with section 15 (3) of the Marketing Act, 1968 (No. 59 of 1968), accepted the proposed amendment set out in the Schedule hereto, to the Banana Scheme, published by Proclamation R. 109 of 1976, and has, under section 12 (1) (b) of the said Act, recommended the approval of the proposed amendment;

Now therefore, under the powers vested in me by section 14 (1) (a), read with the said section 15 (3) of the said Act, I do hereby declare that the said amendment shall come into operation on 6 March 1977.

**SCHEDULE**

The Banana Scheme, published by Proclamation R. 109 of 1976, is hereby amended by—

(a) the substitution for subsection (2) of section 36 of the following subsection:

"(2) Each quantity of bananas delivered to the Board for sale, shall be classified by the Board according to the grade and size group to which it belongs in the opinion of the Board, and be assigned to the pool in the said grade and size group for the account of the producer by whom they were so delivered.”;

(b) the deletion of subsection (3) of section 36;

(c) the deletion of subsection (7) (b) (ii) of section 36; and

(d) the deletion of subsection (9) of section 36.

**WYSIGING VAN DIE STATUUT VAN DIE UNIVERSITEIT VAN FORT HARE**

Paragraaf 45 (vii) word hierby gewysig deur die volgende grade by te voeg:

"In Bosbou:

Baccalaureus in Bosbou: B. Bos.

Baccalaureus Scientiae in Bosbou: B.Sc. (Bosbou)".

**WYSIGING VAN DIE REGULASIES VIR DIE SUID-AFRIKAANSE POLISIE**

Dit het die Staatspresident behaag om kragtens artikel 33 van die Polisiewet, 1958 (Wet 7 van 1958), sy goedkeuring te heg aan onderstaande wysiging van die Regulasies vir die Suid-Afrikaanse Polisie, soos gepubliseer by Goewermenskennisgewing R. 203 in *Buitengewone Staatskoerant* 719 (*Regulasiekoerant* 299) van 14 Februarie 1964, en later gewysig.

*Regulasie 32.*—Vervang subregulasies (3) A en (4) deur die volgende:

(4) Ondanks die bepalings van subregulasie (3), kan die Kommissaris goedkeuring verleen dat die geneeskundige/tandheelkundige behandeling in regulasies 32 en 33 bedoel, verskaf word aan die kind van 'n geskeide lid, indien sodanige lid, benewens enige bedrag vir onderhoud, deur 'n bevoegde hof gelas is om ook die volle mediese onkoste van sodanige kind te dra.

(5) Vir die toepassing van hierdie regulasie word 'n vroulike lid geag ongetroud en kinderloos te wees: Met dien verstande dat indien sodanige lid 'n weduwee of 'n geskeide vrou is aan wie 'n bevoegde hof die sorg van haar kind toegeken het en sodanige lid haar kind versorg, hierdie regulasie op sodanige lid van toepassing is met betrekking tot sodanige afhanglike kind asof die lid getroud is.

(6) Vir die toepassing van hierdie regulasie is 'n ondersoek of behandeling deur 'n gemagtigde geneesheer, tandarts of spesialis afdoende bewys dat dit 'n ondersoek of behandeling was soos in hierdie regulasie bedoel.

**AMENDMENT OF THE STATUTE OF THE UNIVERSITY OF FORT HARE**

The Minister of Bantu Education has, by virtue of the powers vested in him by section 33 (2) of the University of Fort Hare Act, 1969 (Act 40 of 1969), approved the following further amendment to the Statute published under Government Notice R. 2001, dated 5 November 1971, as framed by the Council of the University of Fort Hare in terms of section 33 (1) (a) of the said Act:

Paragraph 45 (vii) is hereby amended by the addition of the following degrees:

"In Forestry:

Bachelor of Forestry: B. For.

Bachelor of Science in Forest Science: B. Sc. (Forest Science)".

**AMENDMENT OF THE REGULATIONS FOR THE SOUTH AFRICAN POLICE**

The State President has been pleased in terms of section 33 of the Police Act, 1958 (Act 7 of 1958), to approve the following amendment of the Regulations for the South African Police, as published under Government Notice R. 203 in *Government Gazette Extraordinary* 719 (*Regulation Gazette* 299) of 14 February 1964, and subsequently amended.

*Regulation 32.*—Substitute the following for sub-regulations (3) A and (4):

(4) Notwithstanding the provisions of subregulation (3) the Commissioner may approve that the medical/dental treatment intended in regulations 32 and 33, be rendered to the child of a divorced member if such member, in addition to any amount for maintenance has been ordered by a competent court also to bear the full medical expenses of such child.

(5) For the purposes of this regulation a female member shall be deemed to be unmarried and without children: Provided that if such member is a widow or a divorcee to whom a competent court has awarded the care and custody of her child and such member is caring for her child, this regulation shall apply to such member in relation to such dependent child as if the member were married.

(6) For the purposes of this regulation an examination or treatment by an authorised medical practitioner, dentist or specialist shall be conclusive proof that it was an examination or treatment referred to in this regulation.




