SPECIAL LEVIES ON CERTAIN DAIRY PRODUCTS.—AMENDMENT

In terms of section 79 (a) of the Marketing Act, 1968 (No. 59 of 1968), I, Hendrik Stephanus Johan Schoeman, Minister of Agriculture, hereby make known that the Dairy Board, referred to in section 6 of the Dairy Scheme, published by Proclamation R. 25 of 1972, as amended, has, in terms of section 24 of that Scheme, with my approval and with effect from 15 June 1977, amended the special levies published in Government Notice R. 2036 of 29 October 1976, as amended, as set out in the Schedule hereto.

SCHEDULE

The Schedule to Government Notice R. 2036 of 29 October 1976 is hereby further amended by the substitution for clause 6 thereof, of the following clause:

"6. A special levy at the following rates is hereby imposed on the following dairy products:

- (a) A special levy of 4,4c per kg on factory cheese other than the Cheddar or Gouda type.
- (b) A special levy of 2,00c per kg on condensed milk, including unsweetened condensed milk.
- (c) A special levy of 1,60c per kg on condensed skim-milk.
- (d) A special levy of 7,00c per kg on milk powder.
- (e) A special levy of 5,70c per kg on skim-milk powder."

- (c) 'n Spesiale heffing van 1,60c per kg op gekondenseerde afgeroomdemelk.
- (d) 'n Spesiale heffing van 7,00c per kg op melkpoeier.
- (e) 'n Spesiale heffing van 5,70c per kg op afgeroomde melkpoeier."

SCHEDULE

The Schedule to Government Notice R. 1098 of 2 June 1975, as amended, is hereby further amended by the substitution for clauses 3 and 4 thereof of the following clauses:

"BUTTER PRICES

3. No person shall sell creamery butter of the grade indicated and packed in the unit of mass concerned or portion thereof at prices above the maximum prices specified hereunder:

Provided—

(a) that creamery butter bearing the registered trade mark 'Erica' and packed by the manufacturer thereof in packets containing 50 gram and 100 gram net of such butter, shall not be sold at a price above 8c and 16c per packet, respectively; and

(b) that the maximum selling prices shall not apply to creamery butter packed in packages each containing not more than 25 gram net of such butter.

CHEESE PRICES

4. No person shall sell factory cheese—

(1) of the Cheddar type and the grade indicated at prices above the maximum prices specified hereunder:
