LEBOWA.—DISSOLUTION OF THE LEGISLATIVE ASSEMBLY, FIXING OF DATE FOR THE DESIGNATION OF MEMBERS OF THE LEGISLATIVE ASSEMBLY AND FIXING OF DATE OF GENERAL ELECTION

Under and by virtue of the powers vested in me by sections 3 (1) (a) and 7 of the Lebowa Constitution Proclamation, 1972 (Proclamation R. 225 of 1972—

(a) I hereby dissolve the Lebowa Legislative Assembly with effect from Wednesday, the fifteenth day of March 1978;

(b) I hereby determine—

(i) that the designation of members of the Lebowa Legislative Assembly by the Chiefs mentioned in section 3 (2) (a) of the said Lebowa Constitution Proclamation, 1972, shall take place on or before the ninth day of January 1978; and

(ii) that a general election for the election of members of the Lebowa Legislative Assembly shall be held on Wednesday, the fifteenth day of March 1978.

AMENDMENT OF THE STATUTE OF THE UNIVERSITY OF FORT HARE

The Minister of Bantu Education has, by virtue of the powers vested in him by section 33 (2) of the University of Fort Hare Act, 1969 (Act 40 of 1969), approved the following further amendment of the Statute published under Government Notice R. 2001, dated 5 November 1971, as framed by the Council of the University of Fort Hare in terms of section 33 (1) (a) of the said Act:

1. The following paragraph is substituted for paragraph 6:

"Rector and Registrar

6. (1) Subject to the provisions of the Act, the Rector shall be appointed, after consultation with the Senate, at a meeting of the Council, by a majority of the members holding office at the date of the meeting.

(2) The Registrar of the University shall be the Secretary of the Council and, unless the Council decides otherwise, he shall also be the Secretary of the Senate and the Secretary of the Convocation.

(3) In the absence of the Registrar the Rector may appoint an assistant registrar of the University to be acting registrar."

Botha, Minister van Bantoe-administrasie en -ontwikkeling, hierby—

(a) Woensdag, die 11de dag van Januarie 1978, as die dag waarop nominasiehowe sitting sal hou om nominasies te ontvang van kandidate vir verkiesing tot lid van die Lebowa- Wetgewende Vergadering vir elkeen van die kiesafdelings in die eerste kolom van die Bylae hiervan gemeld;

(b) dat die nominasiehof vir elk van bedoelde kiesafdelings sitting sal hou op die plek in die tweede kolom van genoemde Bylae teenoor die betrokke kiesafdeling aangedui;

(c) dat die getal lede wat in elke kiesafdeling verkies moet word die getal is wat teenoor elke kiesafdeling genoem in die Bylae vermeld word; en

(d) dat indien 'n stemming ingevolge die bepalings van artikel 10 (c) van genoemde Proklamasie op 15 Maart 1978 die datum waarop die verkiesing ingevolge Proklamasie R. 357 van 1977 gehou moet word, moet plaasvind, die stemming om 07h00 moet begin en om 21h00 van gemelde dag moet eindig.

WYSIGING VAN DIE STATUUT VAN DIE UNIVERSITEIT VAN FORT HARE

Die Minister van Bantoe-onderwys het kragtens die bevoegdheid hom verleen by artikel 33 (2) van die Wet op die Universiteit van Fort Hare, 1969 (Wet 40 van 1969), die volgende verdere wysiging van die Statuut, gepubliseer by Goewermentskennisgewing R. 2001 van 5 November 1971, wat deur die Raad van die Universiteit van Fort Hare ingevolge artikel 33 (1) (a) van genoemde Wet opgestel is, goedgekeur:

1. Paragraaf 6 word hierby deur die volgende paragraaf vervang:

"Rector en Registrateur

6. (1) Behoudens die bepalings van die Wet word die Rector na oorlegpleging met die Senaat op 'n vergadering van die Raad aangestel deur 'n meerderheid van die lede wat hulle amp op die datum van die vergadering beklee.

(2) Die Registrateur van die Universiteit is die Sekretaris van die Raad, en tensy die Raad anders besluit, is hy ook die Sekretaris van die Senaat en die Sekretaris van die Konvokasie.

(3) In die afwesigheid van die Registrateur kan die Rector 'n assistent-registrateur van die Universiteit as waarnemende registrateur aanwys."

2. The following paragraph is hereby inserted after paragraph 7:

"Mode of Election: Convocation representatives"

7A. (1) Whenever it is necessary for the Convocation to elect a member of the Council, the Secretary of the Council shall, by written notice posted at least three months before the date fixed for the election, invite each member of the Convocation to nominate, in writing, a number of persons, not exceeding the number of vacancies, to be elected members of the Council.

(2) Each nomination shall be lodged with the Secretary of the Council at least two months before the date fixed for the election and shall be signed by at least five members and countersigned by the nominee to denote his acceptance of nomination.

(3) If the number of persons nominated is not greater than the number of vacancies, the Secretary of the Council shall forthwith declare such person or persons to be duly elected.

(4) If more persons are nominated than are to be elected, the Secretary of the Council shall, at least one month before the date fixed for the election, post to every member of the Convocation a printed ballot paper, in a form approved by the Council, containing in alphabetical order the names of all the candidates.

(5) Any ballot paper which is not completed in accordance with the instructions on such paper shall be invalid.

(6) At any election the Secretary of the Council shall act as returning officer, assisted by two scrutineers appointed by the President of the Convocation or, failing him, by the Rector."

3. The following paragraphs are hereby inserted after paragraph 42:

**"CHAPTER VII A
THE CONVOCATION"**

President

42A. (1) The President of the Convocation shall be elected by the Convocation from among its members at an annual meeting and shall hold office until after the election of a president at the second subsequent annual meeting.

(2) If at the end of a period of office as described in subparagraph (1) no annual meeting of the Convocation has taken place, the President of the Convocation shall hold office for one further year.

(3) In the event of the death or resignation of the President of the Convocation, a successor shall be elected at a meeting of the Convocation called by the Secretary of the Convocation for that purpose.

Chairman

42B. The President shall be chairman at all meetings of the Convocation, but in his absence the members present shall elect one of their number to preside at the meeting.

Roll

42C. (1) The Secretary of the Convocation shall keep the roll of the Convocation and a member shall be required to register his address with the Secretary and to notify him of any change of address or name.

(2) Such roll shall be conclusive evidence that a person whose name appears thereon at the time of an election by the Convocation is entitled to vote thereat and that a person whose name does not appear thereon is not so entitled.

2. Die volgende paragraaf word hierby na paragraaf 7 ingevoeg:

"Wyse van verkiesing: Konvokasieverteenwoordigers"

7A. (1) Wanneer die Konvokasie 'n lid van die Raad moet kies, versoek die Sekretaris van die Raad by wyse van 'n skriftelike kennisgewing wat minstens drie maande voor die vasgestelde verkiesingsdatum gepos word, elke lid van die Konvokasie om hoogstens soveel persone as die getal vakatures skriftelik vir verkiesing tot lede van die Raad te nomineer.

(2) Elke nominasie, geteken deur minstens vyf lede en mede-onderteken deur die genomineerde ter aanduiding van sy aanvaarding van die nominasie, word minstens twee maande voor die vasgestelde verkiesingsdatum by die Sekretaris van die Raad ingedien.

(3) Indien die getal genomineerdes nie meer as die getal vakatures is nie, verklaar die Sekretaris van die Raad onverwyld dat sodanige persoon of persone behoorlik verkies is.

(4) Indien meer persone genomineer word as wat verkies moet word, pos die Sekretaris van die Raad minstens 'n maand voor die vasgestelde verkiesingsdatum 'n gedrukte stembrief, in 'n vorm deur die Raad goedgekeur en met die name van al die kandidate in alfabetiese volgorde daarop, aan elke lid van die Konvokasie.

(5) 'n Stembrief wat nie ingevul word volgens die voorskrifte wat daarop verskyn nie, is ongeldig.

(6) By elke verkiesing tree die Sekretaris van die Raad as kiesbeampte op en word hy bygestaan deur twee stemopnemers wat deur die President van die Konvokasie of, indien nie deur hom nie, deur die Rektor benoem word."

3. Die volgende paragrawe word hierby na paragraaf 42 ingevoeg:

**"HOOFSTUK VII A
DIE KONVOKASIE"**

President

42A. (1) Die President van die Konvokasie word op 'n jaarvergadering deur die Konvokasie uit sy lede gekies en beklee sy amp tot na die verkiesing van 'n president op die tweede daaropvolgende jaarvergadering.

(2) Indien daar aan die einde van 'n ampstermyn soos beskryf in subparagraaf (1) nie 'n jaarvergadering van die Konvokasie plaasgevind het nie, beklee die President van die Konvokasie sy amp nog 'n jaar lank.

(3) In die geval van die dood of bedanking van die President van die Konvokasie word 'n opvolger gekies op 'n vergadering van die Konvokasie wat die Sekretaris van die Konvokasie vir dié doel belê.

Voorsitter

42B. Die President tree op alle vergaderings van die Konvokasie as voorsitter op, maar in sy afwesigheid kies die aanwesige lede iemand uit hulle geledere om op daardie vergadering voor te sit.

Naamlys

42C. (1) Die Sekretaris van die Konvokasie hou die naamlys van die Konvokasie en daar word van 'n lid vereis om sy adres by die Sekretaris te registreer en om hom van enige adres- of naamverandering in kennis te stel.

(2) Sodanige naamlys is afdoende bewys daarvan dat 'n persoon wie se naam ten tyde van 'n verkiesing deur die Konvokasie daarop voorkom, daartoe geregtig is om daar te stem en dat 'n persoon wie se naam nie op die lys voorkom nie, nie daartoe geregtig is nie.

Annual meeting

42D. (1) The Convocation shall hold an annual meeting, to be convened by the Secretary of the Convocation during the academic year.

(2) Notice of any business for discussion at a meeting shall be given to the Secretary of the Convocation, in writing, at least three weeks before the date determined for such meeting.

Special meetings

42E. (1) A special meeting of the Convocation may be called by the President at any time and shall be called by him at the request in writing of at least the number of members forming a quorum at such meeting, the object of the meeting being stated in the requisition.

(2) No business other than that for which the meeting has been called shall be transacted at a special meeting.

Notice of meetings

42F. Notice of a meeting of the Convocation with a statement of the business to be transacted, shall be sent to each member at least 14 days before the date appointed for such meeting.

Quorum and procedure

42G. (1) Twenty-five members of the Convocation shall form a quorum.

(2) In the event of there not being a quorum within 15 minutes of the time for which the meeting was called the meeting may proceed with such formal business as the chairman of the meeting may deem necessary for the continuity of Convocation activities.

(3) Except as provided in paragraphs 42E and 42F, the procedure at any meeting of the Convocation shall *mutatis mutandis* be as prescribed in paragraphs 9 to 18 for a meeting of the Council."

4. The following paragraph is substituted for paragraph 45:

"Degrees and Faculties

45. Subject to the provisions of the Act and this Statute, the University shall have the power to confer the following degrees:

Jaarvergaderings

42D. (1) Die Konvokasie hou 'n jaarvergadering wat gedurende die akademiese jaar deur die Sekretaris van die Konvokasie belê word.

(2) Kennis van sake vir bespreking op 'n vergadering word minstens drie weke voor die datum vir die vergadering bepaal, skriftelik aan die Sekretaris van die Konvokasie gegee.

Buitengewone vergaderings

42E. (1) 'n Buitengewone vergadering van die Konvokasie kan te eniger tyd deur die President belê word en moet deur hom belê word op die skriftelike versoek van minstens die getal lede wat 'n kworum op sodanige vergadering vorm, en die doel van die vergadering moet in die versoek gemeld word.

(2) Geen ander sake as dié waarvoor die vergadering belê word, word op 'n buitengewone vergadering behandel nie.

Kennisgewing van vergadering

42F. Kennis van 'n vergadering van die Konvokasie asook 'n lys van die sake wat daar behandel moet word, word minstens 14 dae voor die datum wat vir sodanige vergadering bepaal is, aan elke lid gestuur.

Kworum en prosedure

42G. (1) Vyf-en-twintig lede van die Konvokasie vorm 'n kworum.

(2) Indien daar 15 minute na die tyd wat vir die vergadering vasgestel is, nie 'n kworum is nie, kan die vergadering voortgaan met sodanige formele sake as wat die voorsitter van die vergadering vir die kontinuïteit van die Konvokasie se werksaamhede nodig ag.

(3) Behoudens die bepalings van paragrafe 42E en 42F, is die prosedure op elke vergadering van die Konvokasie *mutatis mutandis* dieselfde as wat in paragrafe 9 tot 18 vir 'n vergadering van die Raad voorgeskryf word."

4. Paragraaf 45 word hierby deur die volgende paragraaf vervang:

5. The following paragraph is substituted for paragraph 52:

"Ordinary and Honours Bachelor's Degrees"

52. Subject to the provisions of the Act and this Statute, no candidate shall be admitted to the degree of bachelor unless he has—

(a) registered as a matriculated student;
