**STATE AIRPORT REGULATIONS, 1963**

The Minister of Transport has, in terms of section 22 of the Aviation Act, 1962 (Act 74 of 1962), made the regulations contained in the Schedule hereto, with effect from 1 April 1978.

**SCHEDULE 16**

1. In this Schedule, unless the context otherwise indicates, "the Regulations" means the State Airport Regulations, 1963, as promulgated under Government Notice R. 1974 of 20 December 1963, as amended.\*

2. Annex E to the Regulations is hereby amended by the substitution for paragraphs E.1, E.2 and E.4 of the following paragraphs:
