2. Skrap "Natal (Bantoegebiede)" onder die opskrif "Hoofbantoesakekommissaris" en die omskrywing onder die opskrif "Gebied".

3. Vervang "Natal (Blankegebiede)" deur "Natal" onder die opskrif "Hoofbantoesakekommissaris" en vervang die omskrywing onder die opskrif "Gebied" deur die volgende:

"Die provinsie Natal, uitgesonderd die gebiede wat in die gebied van die kwaZulu- Wetgewende Vergadering val."

4. Onder die opskrif "Gebied" teenoor "Transvaal-Middelland":

- (i) Skrap "Ermelo," "Klerksdorp," "Koster," "Marico," "Potchefstroom," "Swartruggens," en "Ventersdorp,";

AREAS OF CHIEF BANTU AFFAIRS COMMISSIONERS

Under and by virtue of the powers vested in me by section 2 (1) of the Bantu Administration Act, 1927 (Act 38 of 1927), I, Cornelius Petrus Mulder, Minister of Plural Relations and Development, hereby give notice that, with effect from 1 April 1978, I further amend the areas in which the Chief Bantu Affairs Commissioners, referred to in the Schedule to Government Notice R. 1191 of 1971, as amended, shall exercise such powers and perform such duties as are prescribed, by the amendment to the said Schedule, in accordance with the accompanying Schedule.

SCHEDULE

1. Delete the following under the heading "Area" opposite "Witwatersrand":

- (i) "Balfour,";
- (ii) "Oberholzer,";
- (iii) "(ii) the area in the District of Potchefstroom in which the Court of the Bantu Affairs Commissioner, Carletonville, has jurisdiction,".

2. Delete "Natal (Bantu Areas)" under the heading "Chief Bantu Affairs Commissioner" and the description under the heading "Area".

3. Substitute "Natal" for "Natal (White Areas)" under the heading "Chief Bantu Affairs Commissioner" and substitute the following for the description under the heading "Area":

"The Province of Natal, excluding the areas which fall within the area of the kwaZulu Legislative Assembly."

4. Under the heading "Area" opposite "Transvaal Midland":

- (i) Delete "Ermelo," "Klerksdorp," "Koster," "Marico," "Potchefstroom," "Swartruggens," and "Ventersdorp,";

(ii) voeg in "Balfour," "Piet Retief," en "Soshanguve,"; en

(iii) skrap "asook dorpe bepaal en afgesonder ingevolge Proklamasie R. 293 van 1962, in enige van voormelde distrikte, en uitgesonderd dié gedeelte van die distrik Potchefstroom waarin die Bantoesakekommissarisshof, Carletonville, regs mag het".

(ii) voeg in "Hofmeyer,".

6. Onder die opskrif "Gebied" teenoor "Noordelike Gebiede":

(i) Voeg in "Ermelo," en "Mathanjana,"; en
(ii) skrap "Sibasa," en "behalwe in die distrikte Barberton en Witrivier".

7. Onder die opskrif "Gebied" teenoor "Westelike Gebiede" skrap:

(i) Paragraaf (a);
(ii) "Taung"; en
(iii) alles wat na "Warrenton;" voorkom.

8. Onder die opskrif "Gebied" teenoor "Wes-Kaap" voeg in "Goodwood," en "Kuilrivier,".

9. Voeg aan die einde onder die opskrifte "Hoofbantoesakekommissaris" en "Gebied" onderskeidelik die volgende in:

"Wes-Transvaal" "In die provinsie Transvaal, die distrikte Bloemhof, Christiana, Coligny, Delareyville, Klerksdorp, Koster, Lichtenburg, Marico, Oberholzer, Potchefstroom, Schweizer-Reneke, Swartruggens, Ventersdorp, Wolmaransstad."

5. Under the heading "Area" opposite "Eastern Cape":

(i) Delete "Glen Grey," "Herschel," "Maraisburg," "Matatiele," "Mount Currie," and "Port St Johns,"; and
(ii) insert "Hofmeyer,".

6. Under the heading "Area" opposite "Northern Areas":

(i) Insert "Ermelo," and "Mathanjana,"; and
(ii) delete "Sibasa," and "except in the Districts of Barberton and White River".

7. Under the heading "Area" opposite "Western Areas" delete:

(i) Paragraph (a);
(ii) "Taung,"; and
(iii) everything appearing after "Warrenton,".

8. Under the heading "Area" opposite "Western Cape" insert "Goodwood," and "Kuil River,".

9. Insert at the end the following under the headings "Chief Bantu Affairs Commissioner" and "Area" respectively:

"Western Transvaal" "In the Province of the Transvaal, the Districts of Bloemhof, Christiana, Coligny, Delareyville, Klerksdorp, Koster, Lichtenburg, Marico, Oberholzer, Potchefstroom, Schweizer-Reneke, Swartruggens, Ventersdorp, Wolmaransstad."
