PRYSBEHEER.—MAKSIMUM PRYSE VAN STEENKOOLO

Ek, Elias George de Beer, Pryscontroleur, handelende kragtens die bevoegdheid my verleen by artikel 4 van die Wet op Prysbeheer, 1964 (Wet 25 van 1964), bepaal hierby, met ingang van 2 Februarie 1979, soos volg:

1. Die maksimum pryse waarteen die produsente van steenkool in Natal asook Spitzkop Steenkoolmyn hulle steenkool (uitgesonderd smidsteenkool, antrasiet, gassteenkool en steenkool wat in metallurgiese en chemiese prosesse gebruik word) aan enigeen mag verkoop, is soos volg:

- (a) Newcastle Platberg Steenkoolmyn: 1 813c per metrieke ton;
- (b) Natal Cambrian Steenkoolmyn: 1 713c per metrieke ton;
- (c) Hlobane Steenkoolmyn: 1 693c per metrieke ton;
- (d) Northfield Steenkoolmyn: 1 754c per metrieke ton;
- (e) Zimbutu Steenkoolmyn: 1 645c per metrieke ton;
- (f) Umgala Steenkoolmyn: 1 653c per metrieke ton;
- (g) Spitzkop Steenkoolmyn: 1 507c per metrieke ton;

Met dien verstande dat—

- (i) wanneer steenkool in ertjegrootte gegradeer word die steenkoolmyn 'n bedrag van hoogstens 45c per metrieke ton kan byvoeg;
- (ii) 'n diskonto van 35c per metrieke ton ten opsigte van stofsteenkool toegelaat word; en
- (iii) wanneer steenkool per spoor aan die koper of aan die order van die koper vervoer word, die maksimum prys vry-op-spoor steenkoolmyn is.

PRICE CONTROL.—MAXIMUM PRICES OF COAL

I, Elias George de Beer, Price Controller, acting under the powers vested in me by section 4 of the Price Control Act, 1964 (Act 25 of 1964), do hereby prescribe, with effect from 2 February 1979, as follows:

1. The maximum prices at which the producers of coal in Natal as well as Spitzkop Colliery may sell their coal (excluding smithy coal, anthracite, gas coal and coal used in metallurgical and chemical processes) to any person, are as follows:

- (a) Newcastle Platberg Colliery: 1 813c per metric ton;
- (b) Natal Cambrian Colliery: 1 713c per metric ton;
- (c) Hlobane Colliery: 1 693c per metric ton;
- (d) Northfield Colliery: 1 754c per metric ton;
- (e) Zimbutu Colliery: 1 645c per metric ton;
- (f) Umgala Colliery: 1 653c per metric ton;
- (g) Spitzkop Colliery: 1 507c per metric ton;

Provided that—

- (i) when coal is graded into pea size, the colliery may add an amount not exceeding 45c per metric ton;
- (ii) a discount of 35c per metric ton is allowed in respect of duff coal; and
- (iii) where any coal is railed to or to the order of the buyer, the maximum price shall be free on rail colliery.

2. Die maksimum prys waarteen 'n produsent (uitgesonderd Spitzkop Steenkoolmyn) van Transvaalse of Oranje-Vrystaatse steenkool sodanige steenkool (uitgesonderd smidsteenkool, antrasiet, gassteenkool en steenkool wat in metallurgiese en chemiese prosesse gebruik word) aan enigeen mag verkoop, is soos volg:

Steenkool met 'n hittewaarde op 'n lugdroë basis van—

- (a) minder as 25,5 MJ/kg (graad D), 817,5c per metrieke ton;
- (b) 25,5 maar minder as 26,5 MJ/kg (graad C), 846c per metrieke ton;
- (c) 26,5 maar minder as 27,5 MJ/kg (graad B), 874,5c per metrieke ton; en
- (d) 27,5 maar minder as 28,5 MJ/kg (graad A), 903c per metrieke ton:

Met dien verstande dat—

- (i) wanneer steenkool in ertjiegrootte gegradeer word die steenkoolmyn 'n bedrag van hoogstens 45c per metrieke ton kan byvoeg;
- (ii) 'n diskonto van 35c per ton ten opsigte van stofsteenkool toegelaat word;
- (iii) wanneer steenkool by die steenkoolmyn op padvoertuie gelaai word, die steenkoolmyn 'n bedrag van hoogstens 11c per metrieke ton by die prys wat by die mynskaghoof gevorder word kan byvoeg; en
- (iv) wanneer steenkool per spoor aan die koper of aan die order van die koper vervoer word, die maksimum prys vry-op-spoor steenkoolmyn is.

3. Die maksimum prys waarteen enigeen wat steenkool by die trokvrag verkoop, sodanige steenkool aldus kan verkoop, is die steenkoolmyn se netto faktuurprys van die steenkool, plus 16c per metrieke ton.

4. Behoudens die bepalings van regulasie 3 hiervan is die maksimum prys waarteen enigeen (uitgesonderd 'n steenkoolprodusent) steenkool aan enigiemand anders mag verkoop—

(a) (i) in die geval van Transvaalse en Oranje-Vrystaatse steenkool (uitgesonderd steenkool van die Spitzkop Steenkoolmyn), die prys per 90 kg wat die verkoper gewoonlik gedurende Januarie 1979 vir steenkool gevra het, plus 9c per 90 kg; en

(ii) in die geval van Natalse steenkool asook steenkool van die Spitzkop Steenkoolmyn, die prys per 40 kg wat die verkoper gewoonlik gedurende Januarie 1979 vir steenkool gevra het, plus 8,5c per 40 kg; of

(b) indien enigiemand nie voor die datum van hierdie kennisgewing steenkool verkoop het nie, die prys wat gewoonlik deur enige verkoper in dieselfde of naaste gebied gevra word.

5. Waar steenkool deur enigeen (uitgesonderd 'n steenkoolprodusent) in hoeveelhede van minder as 90 kg of 40 kg na gelang van die geval, aan enigiemand anders verkoop word, staan die maksimum prys van sodanige kleiner hoeveelhede in verhouding tot—

(a) in die geval van Transvaalse en Oranje-Vrystaatse steenkool (uitgesonderd steenkool van die Spitzkop Steenkoolmyn), in verhouding tot die prys per 90 kg wat kragtens regulasie 4 (a) (i) bepaal word; en

(b) in die geval van Natalse steenkool asook steenkool van die Spitzkop Steenkoolmyn, in verhouding tot die prys van 40 kg wat kragtens regulasie 4 (a) (ii) bepaal word.

2. The maximum price at which any producer (excluding Spitzkop Colliery) of Transvaal or Orange Free State coal may sell such coal (excluding smithy coal, anthracite, gas coal and coal used in metallurgical and chemical processes) to any person is as follows:

Coal of a calorific value on an air dry basis of—

- (a) less than 25,5 MJ/kg (Grade D), 817,5c per metric ton;
- (b) 25,5 but less than 26,5 MJ/kg (Grade C), 846c per metric ton;
- (c) 26,5 but less than 27,5 MJ/kg (Grade B), 874,5c per metric ton; and
- (d) 27,5 but less than 28,5 MJ/kg (Grade A), 903c per metric ton:

Provided that—

(i) when coal is graded into pea size, the colliery may add an amount not exceeding 45c per metric ton;

(ii) a discount of 35c per ton is allowed in respect of duff coal;

(iii) when coal is loaded at the colliery into road vehicles, the colliery may add an amount not exceeding 11c per metric ton to the pithead price of the coal; and

(iv) where any coal is railed to or to the order of the buyer, the maximum price shall be free on rail colliery.

3. The maximum price at which any person who sells coal by the truck-load, may thus sell such coal, is the colliery's net invoiced price of the coal, plus 16c per metric ton.

4. Save as provided in regulation 3 hereof, the maximum price at which any person (other than a producer of coal) may sell any coal to any other person is—

(a) (i) in the case of Transvaal and Orange Free State coal (excluding coal from Spitzkop Colliery), the price per 90 kg ordinarily charged during January 1979 plus 9c per 90 kg; and

(ii) in the case of Natal coal as well as coal from Spitzkop Colliery, the price per 40 kg ordinarily charged during January 1979 plus 8,5c per 40 kg; or

(b) if any person did not sell coal prior to the date of this notice the price ordinarily charged by any seller in the same or nearest locality.

5. Where coal is sold by any person (other than a producer of coal) to any other person in quantities of less than 90 kg or 40 kg, as the case may be, the maximum price of such smaller quantities is proportionate to—

(a) in the case of Transvaal and Orange Free State coal (excluding coal from Spitzkop Colliery), the price per 90 kg determined in terms of regulation 4 (a) (i) hereof; and

(b) in the case of Natal coal as well as coal from Spitzkop Colliery, the price per 40 kg determined in terms of regulation 4 (a) (ii) hereof.

6. Hierdie regulasie is in die Republiek van toe-passing.

7. Goewermentskennisgewings R. 173 van 27 Januarie 1978 en R. 682 van 7 April 1978 word hierby ingetrek.

PRYSBEHEER

MAKSIMUM PRYSE VAN GEBRANDE KLEIBAKSTENE

Ek, Elias George de Beer, Pryscontroleur, bepaal hierby, ingevolge artikel 4 van die Wet op Prysbeheer, 1964 (Wet 25 van 1964), met ingang van 2 Februarie 1979, soos volg:

1. Wanneer enige soort gebrande kleibaksteen wat in kolom 1 van die Bylae hiervan aangegee word, binne die gebied vervaardig word wat in kolom 4 van die genoemde Bylae aangegee word, is die maksimum prys waarteen sodanige bakstene in die betrokke gebied deur enigiemand aan iemand anders verkoop mag word—

(a) die prys wat in kolom 2 van genoemde Bylae aangegee word wanneer sodanige bakstene per spoor versend word of wanneer lewering van sodanige stene deur of ten behoeve van die koper by die fabriek geneem word; of

(b) die prys wat in kolom 3 van genoemde Bylae aangegee word wanneer sodanige bakstene deur of ten behoeve van die verkoper per pad afgelewer word by enige terrein wat binne die gebied wat in kolom 4 van genoemde Bylae aangegee word, geleë is en deur of ten behoeve van die koper vasgestel is: Met dien verstande dat 'n addisionele bedrag van R6 per 1 000 pleisterstene of skoonvlakbakstene by die prys wat in kolom 3 van genoemde Bylae aangegee word, getel mag word indien sodanige bakstene, nadat die koper en verkoper daartoe ooreengekom het, per hand op die terrein van aflewering afgelaai en gepak word.

2. Vir die toepassing van hierdie kennisgewing, tensy die samehang anders aandui, beteken—

(a) "pleisterstene" gewone, pleister- of agterwerkstene wat normaalweg as sodanig in die boubedryf beskryf en gebruik word;

(b) "skoonvlakbakstene" uitgesoekte pleisterstene met een gladde kant en wat ongepleister en sonder beraping in mure gebruik kan word maar sluit nie spesiale bakstene in wat vervaardig word om aan die vereistes van enige bepaalde koper te voldoen nie;

(c) "sierstene" bakstene wat op so 'n wyse vervaardig is om 'n definitiewe gladde of 'n rowwe voorkant of tekstuur te hê wat sonder beraping en ongepleister in enige muur gebruik kan word maar sluit nie spesiale bakstene in wat vervaardig word om aan die vereistes van enige bepaalde koper te voldoen nie.

3. Die bepalinge van Goewermentskennisgewing R. 3935 van 12 Desember 1969 in verband met die maksimum pryse van gebrande kleibakstene is nie van toepassing op gebrande kleibakstene waarvan die maksimum pryse ingevolge hiervan vasgestel word nie.

4. Goewermentskennisgewing R. 172 van 27 Januarie 1978 word hierby ingetrek.

PRICE CONTROL

MAXIMUM PRICES OF BURNT CLAY BRICKS

I, Elias George de Beer, Price Controller, do hereby prescribe in terms of section 4 of the Price Control Act, 1964 (Act 25 of 1964), with effect from 2 February 1979, as follows:

1. When any type of burnt clay brick specified in column 1 of the Schedule hereto is manufactured within the area specified in column 4 of the said Schedule the maximum price at which such bricks may be sold in the area concerned by any person to any other person shall be—

(a) the price specified in column 2 of the said Schedule when such bricks are dispatched by rail or delivery of such bricks is taken at the factory by or on behalf of the purchaser; or

(b) the price specified in column 3 of the said Schedule when such bricks are delivered by road by or on behalf of the seller to any site situated within the area specified in column 4 of the said Schedule and nominated by or on behalf of the purchaser: Provided that an additional amount of R6 per 1 000 stock bricks or fair face bricks may be added to the price specified in column 3 of the said Schedule, if such bricks are unloaded and packed by hand on the site of delivery, after the buyer and the seller have agreed thereto.

2. For the purposes of this notice unless the context otherwise requires—

(a) "stock bricks" mean common, plaster or backing bricks usually described and used as such in the building trade;

(b) "fair face bricks" means selected stock bricks which have one side smooth and which can be used in walls unplastered and unrendered, but shall not include special bricks which are manufactured to conform to the requirements of any specific purchaser;

(c) "face bricks" mean bricks which have been so manufactured as to have a definite smooth or rough face or texture and which can be used unrendered and unplastered in any wall, but shall not include special bricks which are manufactured to conform to the requirements of any specific purchaser.

3. The provisions of Government Notice R. 3935 of 12 December 1969 pertaining to the maximum prices of burnt clay bricks shall not apply in respect of burnt clay bricks the maximum prices of which are fixed in terms hereof.

4. Government Notice R. 172 of 27 January 1978 is hereby withdrawn.
