NASIONALE VAKLEERLINGSKAPKOMITEE VIR DIE METAALNYWERHEID. — VRYSTELLING (TEGNIESE STUDIES EN LOGBOEK)

Ek, Stephanus Petrus Botha, Minister van Mannekragbenutting, stel hierby, ingevolge artikel 46 (1) van bogemelde Wet, alle werkgewers wat betrokke is by die Nywerheid en in die gebied waarvoor die Nasionale Vakleerlingskapkomitee vir die Metaalnywerheid ingestel is by Goewermenskennisgewing 1554 van 17 Julie 1953, soos herpubliseer by Goewermenskennisgewing R. 2060 van 8 November 1968, vry van—

(a) die bepalings van artikel 16 (11) van bogemelde Wet en klousule 4 (7) van die Leervoorwaardes vir die genoemde Nywerheid, gepubliseer by Goewermenskennisgewing R. 1312 van 22 Junie 1979, soos toegepas by Goewermenskennisgewing R. 1853 van 17 Augustus, 1979, in dié mate dat 'n vakleerling in sy vierde jaar van vakleerlingskap of 'n vakleerling wie se leertydperk ingevolge klousule 6 (3) van die Leervoorwaardes verleng is, nie geregtig is om tegniese klasse by te woon soos bedoel in genoemde klousule 4 (7) gedurende sy gewone werkure nie tensy die onderkomitee benoem deur bogenoemde Komitee vir die betrokke gebied so besluit; en

(b) die vereistes van artikel 32 (1) (b) van gemelde Wet en regulasie 11 van die regulasies kragtens die Wet uitgevaardig op voorwaarde dat elke werkewer aan sy vakleerling en minderjarige wat by hom in 'n aangewese ambag in diens is, 'n logboek verskaf in die vorm voorgeskryf in die Aanhansel op bladsy 2.

APPRENTICESHIP ACT, 1944

NATIONAL APPRENTICESHIP COMMITTEE FOR THE METAL INDUSTRY.—EXEMPTION (TECHNICAL STUDIES AND LOGBOOKS)

I, Stephanus Petrus Botha, Minister of Manpower Utilisation, hereby, in terms of section 46 (1) of the above-mentioned Act, exempt all employers who are engaged in the Industry and area for which the National Apprenticeship Committee for the Metal Industry was established under Government Notice 1554 of 17 July 1953, as republished by Government Notice R. 2060 of 8 November 1968, from—

(a) the provisions of section 16 (11) of the above-mentioned Act and clause 4 (7) of the Conditions of Apprenticeship for the said Industry published under Government Notice R. 1312 of 22 June 1979, as applied by Government Notice R. 1853 of 17 August 1979, to the extent that an apprentice in his fourth year of apprenticeship or an apprentice whose period of apprenticeship has been extended in terms of clause 6 (3) of the said Conditions, shall not be entitled to attend technical classes as contemplated in the said clause 4 (7) during his ordinary hours of work, unless the subcommittee appointed by the above-mentioned Committee for the area concerned so decides; and

(b) the requirements of section 32 (1) (b) of the said Act and regulation 11 of the regulations framed under the said Act, on condition that every employer shall furnish to his apprentice and every minor employed by him in a designated trade, a logbook in the form prescribed in the Annexure on page 2.
