“(1) A member of the Board shall, subject to the provisions of section 28A of the Act, be appointed by the Minister for such period, not exceeding three years, as he may determine.”.

Met dien verstande dat die Raad nie sodanige bystand aan so 'n komitee of organisasie verleen nie, tensy die Komitee of organisasie deur middel van en met die goedkeuring van genoemde Suid-Afrikaanse Landbou-unie vertoe daarvoor tot die Raad gerig het;”.

FACTORIES, MACHINERY AND BUILDING WORK ACT, 1941

EXEMPTION. — MANAGERS, SUBMANAGERS, SENIOR MANAGERIAL, PROFESSIONAL, TECHNICAL AND ADMINISTRATIVE PERSONNEL AND FOREMEN
