**WET OP WYN, ANDER GEGISTE DRANK EN
SPIRITUALIEË, 1957 (WET NO. 25 VAN 1957).**

Kragtens artikel 39 van die Wet op Wyn, Ander Gegiste Drank en Spiritualieë, 1957 (Wet No. 25 van 1957) wysig ek, PIETER THEUNIS CHRISTIAAN DU PLESSIS, Minister van Landbou en Visserie hierby die regulasies uitgevaardig by Goewermenskennisgewing R.2544 van 19 Desember 1980, deur subregulasie (3) van regulasie 22 deur die volgende subregulasie te vervang:

„(3) Indien die eienaar van 'n landgoed wat ingevolge artikel 22 (1) van die Wet omskryf is, ook die geregistreerde eienaar is van een of meer ander stukke grond waarop druiwe gekweek word wat vir die produksie of vervaardiging van wyn beoog word, kan die raad na oorweging van 'n skriftelike aansoek deur sodanige eienaar gelas dat skriftelike toestemming aan hom verleen word om die druiwe wat op een van voormelde ander stukke grond wat die raad bepaal, gekweek is, in 'n kelder in subregulasie (1) (a) (ii) bedoel, te pars en om wyn van sodanige druiwe in die betrokke kelder te produseer of te vervaardig: Met dien verstande dat die raad ook kan gelas dat so 'n skriftelike toestemming verleen word in verband met druiwe wat voor 30 Junie 1981 ge-oes is van wingerdstokke wat op 'n stuk grond gekweek is waarvan die eienaar van die bedoelde landgoed nie die geregistreerde eienaar is nie.”

**WINE, OTHER FERMENTED BEVERAGES AND
SPIRITS ACT, 1957 (ACT NO. 25 OF 1957).**

By virtue of section 39 of the Wine, Other Fermented Beverages and Spirits Act, 1957 (Act No. 25 of 1957) I, PIETER THEUNIS CHRISTIAAN DU PLESSIS, Minister of Agriculture and Fisheries hereby amend the regulations published under Government Notice R.2544 dated 19 December 1980 by the substitution for subregulation (3) of regulation 22 of the following subregulation:

“(3) If the owner of an estate which has been defined in terms of section 22 (1) of the Act, is also the registered owner of one or more other pieces of land on which grapes intended for the production or manufacture of wine are grown, the board may after consideration of a written application by such owner, direct that written permission be granted to him to press the grapes grown on one of the said other pieces of land determined by the board, in a cellar referred to in subregulation 1 (a) (ii), and to produce or manufacture wine from such grapes in the cellar concerned: Provided that the board may also direct that such a written permission be granted in respect of grapes which are harvested before 30 June 1981 from vines which are cultivated on a piece of land of which the owner of the said estate is not the registered owner.”
