WYSIGING VAN VERKIESINGSREGULASIES

Die Staatspresident het kragtens die bevoegdheid hom verleen by artikel 198 van die Kieswet, 1979 (Wet 45 van 1979), die regulasies in die Bylae uiteengesit, uitgevaardig.

BYLAE

1. In hierdie Bylae beteken die uitdrukking “die Regulasies” die Verkiegingsregulasies afgekondig by Goewermentskennisgewing R. 155 van 25 Januarie 1980.

2. Regulasie 2 van die Regulasies word hierby deur die volgende regulasie vervang:

“2. 'n Verwysing in die Regulasies na 'n vorm of 'n stempel is 'n verwysing na 'n vorm of stempel wat behalwe in die geval van vorm VE 2/1, in wese met die vorm of stempel in Bylae A uiteengesit, ooreenkom. In die geval van vorm VE 2/1 mag slegs die voorgeskrewe vorm wat deur die Departement van Binnelandse Aangeleenthede beskikbaar gestel word, gebruik word. 'n Verwysing in die Regulasies na 'n vorm met 'n bepaalde nommer word geag 'n verwysing te wees na die vorm met daardie nommer in Bylae B uiteengesit”.

3. Regulasie 5 (1) van die Regulasies word hierby deur die volgende regulasie vervang:

“5 (1) Elke nominasie ingevolge artikel 41 (2) en elke verklaring ingevolge artikel 41 (4) (b) (ii) moet op 'n aparte vorm VE 2/1 ingedien word”.

AMENDMENT OF ELECTION REGULATIONS

The State President has, under the powers vested in him by section 198 of the Electoral Act, 1979 (Act 45 of 1979), made the following regulations as set out in the Annexure.

ANNEXURE

1. In this Annexure the expression "the Regulations" means the Election Regulations published under Government Notice R. 155 of 25 January 1980.

2. Regulation 2 of the Regulations is hereby substituted by the following regulation:

"2. A reference in the Regulations to a form or stamp shall be a reference to a form or stamp which, except in the case of form VE 2/1, in essence corresponds with the form or stamp as set out in Annexure A. In the case of form VE 2/1 only the prescribed form made available by the Department of Internal Affairs shall be used. A reference in the Regulations to a form with a specific number shall be deemed to be a reference to the form with that number as set out in Annexure B".

3. Regulation 5 (1) of the Regulations is hereby substituted by the following regulation:

“5 (1) Each nomination in terms of section 41 (2) and each declaration in terms of section 41 (4) (b) (ii) shall be submitted on a separate form VE 2/1”.
