THE ANIMAL DISEASES AND PARASITES ACT, 1956  
(ACT 13 OF 1956)

DISEASES TO WHICH CERTAIN PROVISIONS OF  
THE ACT SHALL APPLY

By virtue of the powers vested in me by sections 7, 8 and 10 of the Animal Diseases and Parasites Act, 1956 (Act 13 of 1956), I, Pieter Theunis Christiaan du Plessis, Minister of Agriculture and Fisheries, hereby declare—

(a) that the provisions of sections 7 and 8 of the said Act shall apply to an animal infected with a disease indicated in Schedule A;

(b) that the provisions of section 10 of the said Act shall apply to an animal infected with a disease indicated in Schedule B; and

(c) that Government Notices 1537, 1538 and 1539 of 4 October 1963, and the amendments thereof published by Government Notices 1555, 1556 and 1557 of 6 October 1967 are repealed with effect of the date of publication of this notice.

*Wysiging van regulasie 3 (2) van Deel VI van die Vaste Regulasies*

1. Regulasie 3 (2) van Deel VI van die Vaste Regulasies betreffende Dieresiektes en -parasiete, gepubliseer by Goewermentskennisgewing R. 1531 van 4 Oktober 1963, soos verbeter by Goewermentskennisgewing R. 552 van 10

The Minister of Agriculture and Fisheries made the following regulations under section 27 (1) of the Animal Diseases and Parasites Act, 1956 (Act 13 of 1956):

## AMENDMENT AND REPEAL OF CERTAIN REGULATIONS MADE UNDER THE ANIMAL DISEASES AND PARASITES ACT, 1956 (ACT 13 OF 1956)

*Amendment of regulation 3 (2) of Part VI of the Standing Regulations*

1. Regulation 3 (2) of Part VI of the Standing Regulations relating to Animal Diseases and Parasites, published by Government Notice R. 1531 of 4 October 1963, as corrected by Government Notice R. 552 of 10 April 1964, and

April 1964, en gewysig deur Goewermentskennisgewings R. 428 van 26 Maart 1965, R. 1688 van 29 Oktober 1965, R. 957 van 24 Junie 1966, R. 702 van 26 April 1968, R. 1116 van 28 Junie 1968, R. 1327 van 2 Augustus 1968, R. 55 van 17 Januarie 1969, R. 947 van 13 Junie 1969, R. 532 van 24 April 1971, R. 858 van 28 Mei 1971, R. 442 van 7 Maart 1975, 1389 van 25 Julie 1975, R. 2028 van 14 September 1979 en R. 1684 van 15 Augustus 1980, (hierna die Vaste Regulasies genoem) word hierby gewysig deur die uitdrukking "Aanhangsel E" waar dit daarin voorkom deur die uitdrukking "Aanhangsel D" te vervang.

*Vervanging van regulasie 11 van Deel VI van die Vaste Regulasies*

2. Regulasie 11 van Deel VI van die Vaste Regulasies word hierby deur die volgende regulasie vervang:

**"VERWYDERINGSPERMIT VIR BESMETLIKE DING"**

11. Behalwe op die gesag van 'n permit deur 'n Staatsveearsts uitgereik en ooreenkomsdig die voorwaardes in sodanige permit gestel, mag niemand 'n besmetlike ding vanaf die eiendom [soos omskryf in Regulasie 18 (b) van Deel XI van hierdie regulasies] waarop 'n dier dood is of vermoedelik dood is aan 'n siekte in Aanhangsel E aangedui of waarop so siekte voorkom of vermoedelik voorkom, verwyder laat verwyder of toelaat dat so 'n besmetlike ding verwyder word nie.'".

*Invoeging van regulasie 15A in Deel VIII van die Vaste Regulasies*

3. Die volgende regulasie word hierby in die Vaste Regulasies na regulasie 15 van Deel VIII ingevoeg:

**"VERBOD OP DIE BEWEGING VAN BEESTE EN BUFFELS WAT MET BOSLUISE BESMET IS"**

15A. (1) Behoudens enige ander voorwaardes wat met betrekking tot die beweging van beeste en buffels deur kragtens die Wet opgelê word, mag niemand enige beeste of buffels wat nie sigbaar vry van lewende bosluise is nie van die eiendom [soos omskryf in regulasie 18 (b) van Deel XI van hierdie regulasies] waarop sodanige beeste of buffels gehou word na 'n ander bestemming beweeg, laat beweeg of toelaat dat sodanige beeste of buffels beweeg word nie.

(2) Dit is 'n afdoende verweer teen 'n aanklag kragtens subregulasie (1) as die beskuldigde bewys lewer dat die betrokke beeste of buffels binne 'n tydperk van drie dae voordat hulle beweeg is, met 'n goedgekeurde dipstof gedip of bespuit is ooreenkomsdig die metodes onderskeidelik in regulasie 5 of 6 van hierdie Deel uiteengesit, of dat die betrokke beeste of buffels beweeg was na die dipbak of sputtoestel waarin of waarmee hulle gewoonlik gedip of bespuit word met die doel om gedip of bespuit te word.'".

*Herroeping van regulasies 2, 3, 4 en 5 van Deel XI van die Vaste Regulasies*

4. Regulasies 2, 3, 4 en 5 van Deel XI van die Vaste Regulasies word hierby herroep.

*Wysiging van regulasie 19 van Deel XI van die Vaste Regulasies*

5. Regulasie 19 van Deel XI van die Vaste Regulasies word hierby gewysig deur subregulasie (2) deur die volgende subregulasie te vervang:

"(2) Gedurende die tydperk in Bylae 2 by regulasie 21 van hierdie Deel aangedui, mag niemand behalwe op gesag van 'n permit en ooreenkomsdig die voorwaardes daarin gestel, enige ongedippe skape binne die Republiek, uitgesondert die gebied, van enige eiendom na enige ander eiendom beweeg, laat beweeg of toelaat dat hulle beweeg word nie.'".

amended by Government Notices R. 428 of 26 March 1965, R. 1688 of 29 October 1965, R. 957 of 24 June 1966, R. 702 of 26 April 1968, R. 1116 of 28 June 1968, R. 1327 of 2 August 1968, R. 55 of 17 January 1969, R. 947 of 13 June 1969, R. 532 of 24 April 1971, R. 858 of 28 May 1971, R. 442 of 7 March 1975, 1389 of 25 July 1975, R. 2028 of 14 September 1979 and R. 1684 of 15 August 1980, (herein after referred to as the Standing Regulations) is hereby amended by the substitution for the expression "Annexure E" where it appears therein, of the expression "Annexure D".

*Substitution of regulation 11 of Part VI of the Standing Regulations*

2. The following regulation is hereby substituted for regulation 11 of Part VI of the Standing Regulations:

**"REMOVAL PERMIT FOR INFECTIOUS THING"**

11. Except upon the authority of a permit issued by a State veterinarian, and in accordance with the conditions specified in such permit, no person shall move any infectious thing from a property [as defined in regulation 18 (b) of Part XI of these regulations] on which an animal died or is suspected of having died of a disease indicated in Annexure E or on which such a disease occurs or is suspected of occurring, or cause or permit such infectious thing to be moved.'".

*Insertion of regulation 15A in Part VIII of the Standing Regulations*

3. The following regulation is hereby inserted in the Standing Regulations after regulation 15 of Part VIII:

**"PROHIBITION ON THE MOVEMENT OF CATTLE AND BUFFALO INFECTED WITH TICKS"**

15A. (1) Subject to any other conditions relating to the movement of cattle and buffalo which are imposed by or under the Act, no person shall move any cattle or buffalo which are not visibly free from live ticks from the property [as defined in regulation 18 (b) of Part XI of these regulations] on which such cattle or buffalo are kept to another destination, or cause or permit such cattle or buffalo to be moved.

(2) It shall be a sufficient defence to any charge under subregulation (1), if the accused proves that the cattle or buffalo concerned were dipped or sprayed with an approved dip in accordance with the methods respectively set out in regulation 5 or 6 of this Part, within a period of three days prior to them being moved, or that the cattle or buffalo concerned were being moved to a dipping tank or spraying appliance in or by means of which they are normally dipped or sprayed for the purpose of being dipped or sprayed.'".

*Repeal of regulations 2, 3, 4 and 5 of Part XI of the Standing Regulations*

4. Regulations 2, 3, 4 and 5 of Part XI of the Standing Regulations are hereby repealed.

*Amendment of regulation 19 of Part XI of the Standing Regulations*

5. Regulation 19 of Part XI of the Standing Regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:

"(2) During the period specified in Schedule 2 to regulation 21 of this Part, no person shall, except under the authority of a permit and in accordance with the conditions specified therein, move undipped sheep or cause or permit them to be moved within the Republic, excluding the territory, from any property to any other property.'".

*Wysiging van regulasie 21 van Deel XI van die Vaste Regulasies*

## 6. Regulasie 21 van Deel XI van die Vaste Regulasies word hierby gewysig—

(a) deur subregulasie (1) deur die volgende subregulasie te vervang:

“21. (1) (a) Elke eienaar of bewoner van 'n eiendom in die Republiek, uitgesonderd die gebied, moet gedurende die tydperk in Bylae 2 by hierdie regulasie aangedui, alle skape wat gedurende sodanige tydperk op sodanige eiendom gehou word of wei, dip of laat dip.

(b) Ondanks die bepalings van paragraaf (a), kan 'n Staatsveearts na oorweging van 'n aansoek en indien hy oortuig is dat—

(i) omstandighede en geriewe op 'n eiendom aan die vereistes vir doeltreffende afsondering voldoen, skriftelike magtiging verleen ingevolge waarvan die skape op sodanige eiendom as 'n uitsonderlike geval voor die aanvangsdatum van die tydperk in paragraaf (a) vermeld, gedip mag word; of

(ii) skape op 'n bepaalde eiendom waarskynlik nie voor die sluitingsdatum van daardie tydperk gedip sal word nie as gevolg van 'n tekort aan water of swak kondisie van sodanige skape wat deur droogte of gebrek aan weiding veroorsaak word, oorvloedige reën onmiddellik voor daardie sluitingsdatum, of hulle nie geskeer is nie omdat skeerders nie beskikbaar was nie, skriftelike magtiging verleen ingevolge waarvan die skape op sodanige eiendom as 'n uitsonderlike geval na sodanige sluitingsdatum gedip mag word.

(c) 'n Aansoek bedoel in paragraaf (b) moet skriftelik gedaan word deur die eienaar of bewoner van die eiendom waarop die betrokke skape gehou word of wei en so 'n aansoek moet—

(i) die redes met stawende feite verstrek waarom die betrokke skape voor of na die tydperk in paragraaf (a) bedoel, gedip moet word; en

(ii) in die geval van skape wat voor die aanvangsdatum van daardie tydperk gedip moet word, die betrokke Staatsveearts minstens 14 dae voor die datum waarop daardie skape gedip sal word, bereik; of

(iii) in die geval van skape wat na die sluitingsdatum van daardie tydperk gedip sal word, die betrokke Staatsveearts minstens 14 dae voor sodanige sluitingsdatum bereik.

(d) 'n Magtiging kragtens paragraaf (b) (i) word verleen slegs op voorwaarde dat die skape wat ingevolge daarvan gedip word doeltreffend afgesonder word van enige ander skape wat op die betrokke eiendom gehou word of daarop wei totdat sodanige ander skape ook ingevolge hierdie regulasie gedip is.

(e) 'n Magtiging kragtens paragraaf (b) (ii) word verleen slegs op voorwaarde dat—

(i) die bepalings van regulasie 19 (2) van hierdie Deel op die betrokke skape van toepassing sal wees totdat hulle soos in paragraaf (a) beoog, gedip is; en

(ii) die betrokke skape gedip word op 'n datum wat die betrokke Staatsveearts na oorlegpleging met die eienaar of bewoner van die betrokke eiendom bepaal het.”; en

(b) deur Bylae 2 deur die volgende Bylae te vervang:

*Amendment of regulation 21 of Part XI of the Standing Regulations*

## 6. Regulation 21 of Part XI of the Standing Regulations is hereby amended—

(a) by the substitution for subregulation (1) of the following subregulation:

“21. (1) (a) Every owner or occupier of a property in the Republic excluding the territory shall, during the period specified in Schedule 2 to this regulation, dip or cause all sheep which are kept or depastured on such property during such period to be dipped.

(b) Notwithstanding the provisions of paragraph (a), a State veterinarian may after consideration of an application and if he is satisfied that—

(i) the circumstances and facilities on a property comply with the requirements for efficient isolation, grant written authority in terms of which the sheep on such property may, as an exceptional case, be dipped prior to the commencing date of the period referred to in paragraph (a); or

(ii) sheep on a particular property are not likely to be dipped prior to the closing date of that period due to insufficient water or poor condition of such sheep caused by drought or insufficient grazing, excessive rain immediately prior to that closing date or them not being sheared since shearers were not available, grant written authority in terms of which the sheep on such property may, as an exceptional case, be dipped after such closing date.

(c) An application referred to in paragraph (b) shall be made in writing by the owner or occupier of the property on which the sheep concerned are kept or depastured and shall—

(i) furnish reasons and substantiating facts why the sheep concerned have to be dipped prior to or after the period referred to in paragraph (a); and

(ii) in the case of sheep to be dipped prior to the commencing date of that period, reach the State veterinarian concerned at least 14 days prior to the date on which the sheep concerned are to be dipped; or

(iii) in the case of sheep to be dipped after the closing date of that period, reach the State veterinarian concerned at least 14 days prior to such closing date.

(d) An authority under paragraph (b) (i) shall be granted only on condition that the sheep dipped in terms thereof are being isolated from any other sheep which are kept or depastured on the property concerned until such other sheep have also been dipped in terms of this regulation.

(e) An authority under paragraph (b) (ii) shall be granted only on condition that—

(i) the provisions of regulation 19 (2) of this Part shall apply to the sheep concerned until they have been dipped as contemplated in paragraph (a); and

(ii) the sheep concerned be dipped on a date which the State veterinarian concerned may determine after consultation with the owner or occupier of the property concerned.”; and

(b) by substituting the following Schedule for Schedule 2:

**"BYLAE 2"****TYDPERK WAARTYDENS DIE DIP VAN SKAPE  
VERPLIGTEND IS**

1 September 1981 tot 28 Februarie 1982.”.

**Wysiging van regulasie 22 van Deel XI van die Vaste Regulاسies**

7. Regulasie 22 van Deel XI van die Vaste Regulاسies word hierby gewysig deur subregulasie (2) deur die volgende subregulasie te vervang:

“(2) (a) Op die datum waarop skape ingevolge subregulasie (1) (a) beweeg word, moet die eienaar of bewoner van die eiendom waarvandaan hulle aldus beweeg word ’n skriftelike verklaring waarin die besonderhede vermeld in subregulasie (3) vervat is aan die persoon in beheer van die vervoermiddel waarmee daardie skape vervoer sal word, voorseen.

## (b) So ’n verklaring moet—

(i) vir die duur van die beweging van die skape daarin vermeld, beskikbaar wees by die vervoermiddel waarmee die betrokke skape vervoer word; en

(ii) onmiddellik op die versoek van ’n beampte, gemagtigde persoon of polisiebeampte deur die persoon in beheer van die betrokke vervoermiddel getoon word.”.

**Invoeging van opskrif en regulasie 30 in Deel XI van die Vaste Regulاسies**

8. Die volgende opskrif en regulasie word hierby in die Vaste Regulاسies na regulasie 29 van Deel XI ingevoeg:

**"MILTSIEKTE  
VERPLIGTE INENTINGS**

30. (1) Elke eienaar van beeste moet sodanige diere een keer elke 12 maande teen miltsiekte inent of laat inent met ’n entstof wat vir die doel deur die direkteur goedgekeur is.

(2) ’n Staatsveearsts kan wanneer hy dit nodig ag en nadat hy die eienaar van diere wat vir miltsiekte vatbaar is, geraadpleeg het, die plek, datum en tyd vasstel vir die inenting van sodanige diere teen miltsiekte met ’n entstof wat vir dié doel deur die direkteur goedgekeur is.”.

9. Aanhangsels D, E, F en G van die Vaste Regulاسies word onderskeidelik deur Aanhangsels D, E, F en G hiervan vervang:

**Amendment of regulation 22 of Part XI of the Standing Regulations**

7. Regulation 22 of Part XI of the Standing Regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:

“(2) (a) On the date on which sheep are moved in terms of subregulation (1) (a), the owner or occupier of the property from which they are thus moved, shall furnish a written statement in which the particulars referred to in subregulation (3) are stated to the person in charge of the conveyance with which those sheep are to be transported.

## (b) Such statement shall—

(i) for the duration of the movement of the sheep stated therein, be available at the conveyance with which the sheep concerned are transported; and

(ii) immediately on demand by an officer, authorised person or police officer be produced by the person in charge of the conveyance concerned.”.

**Insertion of heading and regulation 30 in Part XI of the Standing Regulations**

8. The following heading and regulation are hereby inserted in the Standing Regulations after regulation 29 of Part XI:

**"ANTHRAX****COMPULSORY VACCINATIONS**

30. (1) Each owner of cattle shall vaccinate such animals or cause them to be vaccinated once every 12 months against anthrax with a vaccine approved for this purpose by the director.

(2) A State veterinarian may whenever he considers it necessary, and after he has consulted the owner of animals susceptible to anthrax, fix the place, date and time for the vaccination of such animals with a vaccine approved for this purpose by the director.”.

(b) binne 'n tydperk van 12 maande na die inenting in paragraaf (a) bedoel en daarna minstens een keer in elke tydperk van drie jaar.

(2) Indien iemand 'n hond besit of in sy bewaring of onder sy toesig het—

(a) wat nie soos in subregulasie (1) (a) beoog, ingeënt is nie, moet hy dit so spoedig moontlik aldus laat inent; of

(b) ten opsigte waarvan skriftelike bevestiging dat sodanige hond ingeënt is soos in subregulasie (1) (a) beoog, nie aan 'n Staatsveearts, beampete of gemagtigde persoon voorgelê kan word nie, word dit geag dat sodanige hond nie aldus ingeënt is nie en moet dit onmiddellik ingeënt word:

Met dien verstande dat die bepalings van subregulasie (1) (b) *mutatis mutandis* op 'n hond wat ingevolge hierdie subregulasie ingeënt is, van toepassing is.

*Repeal of regulations relating to the movement of cattle*

11. The regulations relating to a particular prohibition on the movement of cattle published by Government Notice R. 959 of 24 June 1966, as amended by Government Notices 1549 of 6 October 1967 and R. 1094 of 21 June 1968, are hereby repealed.

*Amendment of regulations relating to rabies*

12. The regulations relating to Rabies—Restrictions on the Movement of Certain Animals in Certain Areas and the Compulsory Vaccination of Dogs, published by Part IX of Government Notice R. 1924 of 25 October 1974, are hereby amended—

(a) by the substitution for regulation 13 of the following regulation:

“13. (1) No person shall introduce, or cause or permit any dog, cat, wild carnivore or ground squirrel to be introduced into the area defined in Schedule 6, or move, or cause or permit any such animal to be moved from any landed property in the defined area to any other landed property, whether within or outside the defined area, except by virtue of a written permit issued by a State veterinarian and subject to the conditions specified in such a permit: Provided that no permit shall be necessary for the movement of a dog, cat, wild carnivore or ground squirrel within the urban area of jurisdiction of a local authority in the defined area.

(2) A person to whom a permit was issued in terms of subregulation (1) shall, during the validity thereof and during each movement of the animal specified in that permit, have such permit upon request, available for inspection by a State veterinarian, officer, police officer or authorised person.

(3) Whenever application is made for a permit referred to in subregulation (1) for the movement of a dog or cat to, within or from the area defined in Schedule 6, a valid certificate of vaccination referred to in regulation 15 shall be submitted.”;

(b) by the substitution for regulation 14 of the following regulation:

“14. (1) Each person who possesses a dog or who has a dog in his custody or under his control in the area defined in Schedule 6 shall cause such a dog to be vaccinated with a rabies vaccine approved by the director—

(a) before such a dog has attained the age of seven months but not before it is three months old; and

(b) within a period of 12 months after the vaccination referred to in paragraph (a) and thereafter at least once within every period of three years.

(2) If a person possesses or has in his custody or under his control a dog—

(a) which has not been vaccinated as contemplated in subregulation (1) (a), he shall cause it to be thus vaccinated as soon as possible; or

(b) in respect of which written proof that such dog has been vaccinated as contemplated in subregulation (1) (a), cannot be submitted to a State veterinarian, officer or authorised person, it shall be deemed that such dog has not been thus vaccinated and it shall then forthwith be vaccinated:

Provided that the provisions of subregulation (1) (b) shall *mutatis mutandis* apply to a dog vaccinated in terms of this subregulation.

(f) die datum verstrek waarop die betrokke hond of kat ingeënt of heringeënt is;

Met dien verstande dat op sodanige sertifikaat van inenting voorsiening gemaak kan word vir die eerste en die daaropvolgende herinentings van die hond of kat wat op sodanige sertifikaat beskryf word asook vir die name en woonadresse van agtereenvolgende persone wat die betrokke hond of kat mag besit of in hulle bewaring of onder hulle toesig mag hê.

(3) 'n Sertifikaat van inenting wat uitgereik word ten opsigte van—

(a) 'n hond of 'n kat ouer as drie maande wat vir die eerste keer ingeënt word of waarvan die sertifikaat van inenting, soos in hierdie subreglasie beoog, verval het—

(i) wat buite die gebied in Bylae 6 omskryf, gehou word, is geldig vir 11 maande vanaf 30 dae na die datum waarop die betrokke hond of kat ingeënt is; of

(ii) wat binne die gebied in Bylae 6 omskryf, gehou word, is geldig vir 10 maande vanaf 60 dae na die datum waarop die betrokke hond of kat ingeënt is;

(b) 'n hond wat heringeënt is, is geldig vir drie jaar vanaf die datum waarop die betrokke hond heringeënt is; of

(c) 'n kat wat heringeënt is, is geldig vir 12 maande vanaf die datum waarop die betrokke kat heringeënt is.''; en

(d) deur regulasie 16 deur die volgende regulasie te vervang:

"16. (1) Ondanks die bepalings van regulasie 14, kan 'n Staatsveearts deur 'n kennisgewing bestel op die wyse voorgeskryf in artikel 32 van die Wet of by kennisgewing in 'n nuusblad wat in die betrokke gebied in omloop is, elke eienaar of bewoner van grond in die gebied in Bylae

(3) It shall be sufficient defence to any charge under subregulation (1), if the accused proves that the dog concerned was vaccinated with a rabies vaccine approved by the director, by submitting a valid certificate of vaccination referred to in regulation 15, which relates to the dog concerned.'';

(c) by the substitution for regulation 15 of the following regulation:

"15. (1) A State veterinarian, veterinarian, officer or authorised person who, in terms of these regulations or for any other purpose whatever, vaccinates a dog or cat with a rabies vaccine approved by the director, shall issue to the person who owns such a dog or cat or who has such a dog or cat in his custody or under his control a certificate of vaccination on which the particulars referred in subregulation (2), are stated.

(2) A certificate of vaccination referred to in subregulation (1) shall—

(a) indicate whether the dog or cat concerned is a male, a female, castrated or spayed;

(b) furnish the name, age, breed, colour and distinguishing marks of the dog or cat concerned;

(c) include the name and residential address of the person who, at such vaccination, owns the dog or cat concerned or has the custody or control thereof;

(d) state the type and batch number of the vaccine used for the vaccination concerned;

(e) indicate whether that vaccination is the first vaccination or a re-vaccination of the dog or cat concerned;

(f) furnish the date on which the dog or cat concerned was vaccinated or re-vaccinated;

(g) state the name and address of the person who administered the vaccine concerned; and

(h) include any other particulars which the director may determine:

Provided that provision may be made on such certificate of vaccination for the first and subsequent re-vaccinations of the dog or cat described on such certificate as well as for the names and residential addresses of successive persons who may own or have the custody or control of the dog or cat concerned.

(3) A certificate of vaccination issued in respect of—

(a) a dog or cat older than three months which is vaccinated for the first time or of which the certificate of vaccination has lapsed as contemplated in this subregulation—

(i) which is kept outside the area defined in Schedule 6, shall be valid for 11 months from 30 days of the date on which the dog or cat concerned was vaccinated; or

(ii) which is kept within the area defined in Schedule 6, shall be valid for 10 months after 60 days of the date on which the dog or cat concerned was vaccinated;

(b) a dog which is re-vaccinated, shall be valid for three years of the date on which the dog concerned was re-vaccinated; or

(c) a cat which is re-vaccinated, shall be valid for 12 months of the date on which the cat concerned was re-vaccinated.''; and

(d) by the substitution for regulation 16 of the following regulation:

"16. (1) Notwithstanding the provisions of regulation 14, a State veterinarian may, through a notice served in the manner described in section 32 of the Act or by notice in a newspaper circulating in the area concerned, order

each owner or occupier of land in the area defined in Schedule 6 or such portion of the defined area as the State veterinarian determines, that all dogs and cats on the land owned or occupied by him shall be—

(a) kept isolated, secured or confined for such a period as the State veterinarian fixed in such a notice; and

(b) produce to a State veterinarian, officer or authorised person for inspection and vaccination at a place, date and time fixed in such a notice.

(2) A state veterinarian may order that any dog or cat in respect of which an order issued in terms of subregulation (1) (a), is not being complied with, be destroyed.

(3) Any person who refuses or fails to comply with a notice referred to in subregulation (1) shall be deemed to have contravened these regulations and shall be guilty as contemplated in section 28 (1) of the Act.”.

#### *Repeal of regulation relating to Anthrax*

13. Regulation 17 of Part X of the regulations published at Government Notice R. 1924 of 25 October 1974 relating to Anthrax—Compulsory Vaccinations, is hereby repealed.

#### *Application in South West Africa*

14. These regulations shall not apply in the territory of South West Africa.

#### *Commencement*

15. These regulations shall come into operation on 1 August 1981.
