BYLAE*Woordomskrywing*

1. In hierdie Bylae het enige woord of uitdrukking waarvan 'n betekenis in die Skema geheg is, daardie betekenis en beteken—

“die Aanhangsel” die Aanhangsel tot die Bylae van Goewermenskennisgewing R. 2095 van 1 Oktober 1982; en

“die Skema” die Wintergraanskema gepubliseer by Proklamasie R. 162, 1974, soos gewysig.

Wysiging van klousule 2

2. Klousule 2 van die Aanhangsel word hierby gewysig—

(a) deur paragraaf (a) van subklousule (1) deur die volgende paragraaf te vervang:

MARKETING ACT, 1968 (ACT 59 OF 1968)

WINTER CEREAL SCHEME.—BREAD PRICES
AMENDMENT

I, Jacob Johannes Greyling Wentzel, Minister of Agriculture, hereby make known under section 79 (b) of the Marketing Act, 1968 (Act 59 of 1968), that I have under section 37 of the Winter Cereal Scheme published by Proclamation R. 162, 1974, as amended, read with section 60 (2A) of the said Act, amended the prohibition published in Government Notice R. 2095 of 1 October 1982, as set out in the Schedule.

SCHEDULE*Definitions*

1. Any word or expression in this Schedule to which a meaning has been assigned in the Scheme shall have that meaning and—

“the Annexure” means the Annexure to the Schedule of Government Notice R. 2095 of 1 October 1982; and

“the Scheme” means the Winter Cereal Scheme published by Proclamation R. 162, 1974, as amended.

Amendment of clause 2

2. Clause 2 of the Annexure is hereby amended—

(a) by the substitution for paragraph (a) of subclause (1) of the following paragraph:

“(a) the minimum selling prices of white bread, brown bread and whole-wheat bread sold by or on behalf of a baker shall be as follows:

<i>Class bread</i>	<i>Per 900 g</i>
White bread	54 cents
Brown bread	37 cents
Whole-wheat bread	37 cents;”;

(b) deur in paragraaf (b) van subklousule (1) die woorde wat die voorbehoud voorafgaan, deur die volgende woorde te vervang:

“(b) die maksimum verkoopprijs van witbrood, bruinbrood en volkoringbrood as volg:

<i>Klas brood</i>	<i>Per 900 g</i>
Witbrood	56 sent
Bruinbrood	39 sent
Volkoringbrood	39 sent;” en

(c) deur paragraaf (c) van subklousule (1) deur die volgende paragraaf te vervang:

“(c) die prys van kampongbrood R20,00 per 50 kg.”.

Wysiging van klousule 3

3. Klousule 3 van die Aanhangsel word hierby gewysig deur in paragraaf (a) van subklousule (1) die woorde wat die voorbehoud voorafgaan, deur die volgende woorde te vervang:

“(a) die maksimum verkoopprijs van witbrood, bruinbrood en volkoringbrood wat anders as vir kontant op die verkoper se perseel verkoop word, as volg:

<i>Klas brood</i>	<i>Per 900 g</i>
Witbrood	58 sent
Bruinbrood	41 sent
Volkoringbrood	41 sent;”.

4. Hierdie kennisgewing tree op 20 Februarie 1984 in werking.

(b) by the substitution in paragraph (b) of subclause (1) for the words preceding the proviso of the following words:

“(b) the maximum selling prices of white bread, brown bread and whole-wheat bread shall be as follows:

<i>Class bread</i>	<i>Per 900 g</i>
White bread	56 cents
Brown bread	39 cents
Whole-wheat bread	39 cents;” and

(c) by the substitution for paragraph (c) of subclause (1) of the following paragraph:

“(c) the price of compound bread shall be R20,00 per 50 kg.”.

Amendment of clause 3

3. Clause 3 of the Annexure is hereby amended by the substitution in paragraph (a) of subclause (1) for the words preceding the proviso of the following words:

“(a) the maximum prices for white bread, brown bread and whole-wheat bread sold otherwise than for cash at the seller's premises, shall be as follows:

<i>Class bread</i>	<i>Per 900 g</i>
White bread	58 cents
Brown bread	41 cents
Whole-wheat bread	41 cents;”.

Date of commencement

4. This notice shall come into operation on 20 February 1984.
