TRADE PRACTICES ACT, 1976

I, Dawid Jacobus de Villiers, Minister of Industries and Commerce, do hereby, in terms of the provisions of section 4D of the Trade Practices Act, 1976 (Act 76 of 1976), promulgate the regulations contained in the Schedule.

SCHEDULE

1. In these regulations any word or expression defined in the Act shall bear the meaning so assigned to it.

2. A subpoena to appear before the committee shall be served on the person concerned by delivering or tendering it to him personally or by sending it to him by prepaid registered post at his business address or at his address last known to the committee.
