- Notes.*—1. The rate of duty on S-ethyl dipropylthiocarbamate is increased from 10% to 20% or 660c per kg less 80%.
 2. The rates of duty on herbicides, plant-growth regulators and anti-sprouting products with S-ethyl dipropylthiocarbamate as active ingredient, are increased to 20% or 820c per kg less 80%.
 3. Goods which comply with the conditions of item 460.22 may be entered under rebate of duty under that item and for this purpose the Board of Trade and Industries has certified that the increase in the rates of duty is as a result of an application for tariff protection not previously published in the Government Gazette for general information.
