1. In this Schedule "the Scheme" means the Bana Scheme published by Proclamation R. 109, 1976, as amended.

Substitution for section 5

2. The following section is hereby substituted for section 5 of the Scheme:

"5. (1) This Scheme shall apply to—

- (a) all producers of bananas; or
- (b) all persons dealing in the course of trade with bananas.

(2) An agricultural or special farmers' co-operative that packs bananas on behalf of its members for sale through the Board, is in the application of the applicable provisions of the Scheme a producer of bananas."

Amendment of section 7

3. Section 7 of the Scheme is hereby amended by the substitution for subsection (2) of the following subsection:

"(2) The Board may with the approval of the Minister and for any particular purpose co-opt one person as an advisory member of the Board."

Amendment of section 31

4. Section 31 of the Scheme is hereby amended by the substitution of subsection (1) of the following subsection:

"31. (1) The Board may on the conditions determined by it appoint such agent or agents as it may consider necessary for the proper performance of such of its functions as it may determine, with the approval of the Minister."

Amendment of section 34

5. Section 34 of the Scheme is hereby amended by the substitution for subsection (1) of the following subsection:

"34. (1) The Board may with the approval of the Minister prohibit from time to time any person or any person belonging to any class or group of persons, or any person other than a person belonging to any class or group of persons, from acquiring, selling or disposing of any quantity of bananas or any class or grade thereof, at a price other than or below or above a price fixed by the Board with the approval of the Minister, or calculated in accordance with a basis determined by the Board with the approval of the Minister for such bananas, or for such class, grade of quantity thereof."
