 CERTAIN AGRICULTURAL PRODUCTS DECLARED
 AS PRODUCTS UNDER THE AGRICULTURAL PRO-
 DUCE EXPORT ACT, 1971 (ACT 51 OF 1971).—
 AMENDMENT

The Minister of Agricultural Economics has under sec-
 tion 4 of the Agricultural Produce Export Act, 1971 (Act 51
 of 1971), made the regulations in the Schedule.

SCHEDULE

1. In this Schedule "the regulations" means the regula-
 tions published by Government Notice R. 1005 of 13 May
 1983, as amended by Government Notice R. 592 of 30
 March 1984 (and the correction thereof published by
 Government Notice R. 1577 of 27 July 1984).

Amendment of regulation 1

2. Regulation 1 of the regulations is hereby amended—

(a) by the substitution for the definition of "carcase"
 of the following definition:

" 'carcase' means the remainder of an animal after the
 blood has been drained, and the hide, skin, hair, entrails,
 pluck, head, trotters, cowheels, hooves, tail, diaphragm,
 genitals and udder have been removed as the custom or
 requirements may be in respect of the relevant species of
 animal;";

(b) by the substitution for the definition of "Depart-
 ment" of the following definition:

" 'Department' means the Department of Agricultural
 Economics and Marketing;";

(c) by the substitution for the definition of "Director"
 of the following definition:

" 'Director' means the Director of the Directorate
 Agricultural Product Standards of the Department;"; and

BYLAE

1. In die Bylae beteken "die regulasies" die regulasies
 gepubliseer by Goewermenskennisgewing R. 1005 van 13
 Mei 1983, soos gewysig deur Goewermenskennisgewing
 R. 592 van 30 Maart 1984 (en die verbetering daarvan soos
 gepubliseer by Goewermenskennisgewing R. 1577 van 27
 Julie 1984).

Wysiging van regulasie 1

2. Regulasie 1 van die regulasies word hierby gewysig—

(a) deur die omskrywing van "Departement" deur die
 volgende omskrywing te vervang:

" 'Departement' die Departement van Landbou-
 ekonomie en -bemarking;";

(b) deur die omskrywing van "Direkteur" deur die
 volgende omskrywing te vervang:

" 'Direkteur' die Direkteur van die Direktoraat Land-
 boupprodukstandaarde van die Departement;";

(c) deur die volgende omskrywing na die omskrywing
 van "Direkteur" in te voeg:

(d) by the insertion of the following definition after the definition of "full-side bacon":

"'half carcass' means one of the parts of a carcass after such a carcass has been bisected lengthwise along the middle of the spine;"

Substitution of regulation 2

SCHEDULE

DEFINITIONS

1. In these by-laws, unless the context otherwise indicates—

“Act” shall mean the Black Local Authorities Act, 1982 (Act 102 of 1982);

“drainlaying work” shall mean any work performed in connection with the laying, repair or removal of earthenware drains or drains of other approved material, excluding cast-iron drains, and in connection with the construction of gullies, silt and greas traps, manholes, chambers, conserving tanks and septic tanks;

“engineer” shall mean the employee appointed or authorised by a local authority to perform the duties of the engineer, and shall include the duly authorised employees of the Engineering Services Section of such local authority;

“plumbing work” shall mean any work performed in connection with the construction, fixing, repair or removal of soil-water and waste-water fittings, soil-water and waste-water pipes, ventilation pipes, flushing cisterns and flushing valves and in connection with the laying of cast-iron drains or drains of other approved material, excluding earthenware drains;

“regulation” shall mean a by-law;

and any other word or expression to which a meaning has been assigned in the Act shall have such meaning.

APPLICATION

2. These by-laws shall apply in the area of each local authority until such local authority, in terms of section 27 (1) of the Act, has made its own by-laws relating to the licensing of plumbers and drainlayers.

LICENCE REQUIRED

3. No person shall carry out or cause or allow any other person to carry out any plumbing or drainlaying work relating to the installation, alteration or repair of any sewage system connected or to be connected with any sewer of a local authority for the drainage of soil-water or waste-water other than stormwater, unless such person is in possession of a valid licence issued by such local authority permitting him to perform such work.

ISSUING OF LICENCE

4. A local authority shall issue the appropriate licence to a plumber or a drainlayer, provided—

- (a) he has passed Parts I and II of the Examination for Plumbers and Drainlayers of the local authority concerned; or
- (b) he is an artisan in possession of a plumber's or drainlayer's licence issued by another local authority recognised by the local authority concerned, and has passed Part II of the Examination for Plumbers and Drainlayers of the Local authority concerned.

EXAMINATION FOR LICENCE

- 5. (a) Any person wishing to obtain a licence under these by-laws shall prove to the local authority concerned that he has successfully laid down the examinations mentioned in Annexure A hereto.
- (b) The subjects for such examination shall be as listed in Annexure A hereto and shall be passed in both of the sections mentioned below:
 - (i) Part I: Practical Trade Test;
 - (ii) Part II: Regulations and Theoretical Test;

BYLAE

WOORDOMSKRYWING

1. In hierdie verordeninge, tensy uit die samehang anders blyk, beteken—

“ingenieur” die werknemer wat deur 'n plaaslike bestuur aangestel of gemagtig is om die pligte van 'n ingenieur uit te voer, en dit omvat die behoorlik gemagtigde werknemers van sodanige plaaslike bestuur se Afdeling: Ingenieursdienste;

“loodgieterswerk” alle werk in verband met die konstruksie, bevestiging, herstel of verwydering van drekwatervuilewater- en vuilwatertoehore, drekwatervuilewaterpype, ventilasiepype, spoelbakke en spoelkleppe en in verband met die aanlê van gietysterriole of rirole van ander goedgekeurde materiaal, uitgesonderd erderirole;

“regulasie” beteken verordening;

“rioolaanlêwerk” alle werk in verband met die aanlê, herstel of verwydering van erderirole of rirole van ander goedgekeurde materiaal, uitgesonderd gietysterriole en in verband met die konstruksie van rioolputte, slik- en vetvangers, mangate, kamers, riooltenks en septiese tenks;

“Wet” die Wet op Swart Plaaslike Besture, 1982 (Wet 102 van 1982);

en het enige ander woord of uitdrukking waaraan in die Wet 'n betekenis geheg is, daardie betekenis.

TOEPASSING

2. Hierdie verordeninge is van toepassing in die gebied van elke plaaslike bestuur tot tyd en wyl sodanige plaaslike bestuur sy eie verordeninge kragtens artikel 27 (1) van die Wet gemaak het betreffende die lisensiëring van loodgieters en rioolaanlêers.

BENODIGDE LISENSIE

3. Niemand mag in verband met die installering, verandering of herstel van enige rioleringsstelsel wat by 'n plaaslike bestuur se riool aangesluit is of aangesluit gaan word vir die afvoer van drek- of vuilwater, uitgesonderd stormwater, loodgieters- of rioolaanlêwerk doen, of iemand anders dit laat doen of toelaat dat hy dit doen nie, tensy hy in besit is van 'n geldige lisensie deur sodanige plaaslike bestuur uitgereik wat hom toelaat om sodanige werk te doen.

UITREIKING VAN LISENSIE

4. 'n Plaaslike bestuur reik die toepaslike lisensie aan 'n loodgieter of 'n rioolaanlêer uit, mits hy—

- (a) in Dele I en II van die betrokke plaaslike bestuur se Eksamen vir Loodgieters en Rioolaanlêers geslaag het; of
- (b) 'n ambagsman is wat in besit is van 'n loodgieters- of rioolaanlêerslisensie wat deur 'n ander plaaslike bestuur uitgereik is en deur die betrokke plaaslike bestuur erken word en in Deel II van die betrokke plaaslike bestuur se Eksamen vir Loodgieters en Rioolaanlêers geslaag het.

LISENSIE-EKSAMEN

- 5. (a) Iemand wat 'n lisensie ingevolge hierdie verordeninge wil bekom moet aan die betrokke plaaslike bestuur bewys lewer dat hy die Eksamen in Aanhangel A hiervan bedoel, met goeie gevolg afgelê het.
- (b) Die vlakke vir sodanige eksamen verskyn in Aanhangel A hierby, en moet met goeie gevolg in altwee ondergenoemde gedeeltes afgelê word:
 - (i) Deel I: Praktiese Ambagstoets;
 - (ii) Deel II: Toets oor Regulasies en die Teorie.

PROVISIONAL LICENCE

6. A local authority may issue a provisional licence permitting a person to perform work as a plumber or drainlayer within such local authority's area of jurisdiction for a period of three months on the express condition that such person shall complete the entry forms and pay the fee required to enable him to take the said Examination for Plumbers and Drainlayers within the said period and on the further express condition that all such work shall be performed under the control of a person in possession of the appropriate licence referred to in regulation 4.

LICENCE TO BE PRODUCED

7. When called upon to do so by any duly authorised employee of the local authority concerned, any person engaged in plumbing or drainlaying work referred to in regulation 3 shall produce his licence.

PENALTY

8. Any person contravening the provisions of these by-laws shall be guilty of an offence and liable on conviction to a fine not exceeding R100.

CANCELLATION OF LICENCE

9. A local authority may at any time cancel any plumber's licence or drainlayer's licence if it is satisfied that the licensee has performed any plumbing or drainlaying work in a negligent or unworkmanlike manner to the injury of any person or property or contrary to any of such local authority's by-laws: Provided that prior to such cancellation such licensee shall be afforded the opportunity of appearing before a committee of such local authority and being heard in his own defence: Provided further that such licence, in the event of being cancelled, shall be returned forthwith to the engineer.

DUPLICATE LICENCE

10. The original of a plumber's or drainlayer's licence shall be issued free of charge but duplicates thereof shall be issued at a charge of 50 cents each.

EXAMINATION FOR DRAINLAYERS

Part I: Practical Test.

- (a) Setting out and levelling of drains.

PROMULGATION OF SMOKE CONTROL REGULATIONS IN TERMS OF SECTION 18 (5) OF THE ATMOSPHERIC POLLUTION PREVENTION ACT, 1965 (ACT 45 OF 1965)

In terms of section 18 (5) of the Atmospheric Pollution Prevention Act, 1965 (Act 45 of 1965), and after consultation with the National Air Pollution Advisory Committee, I, George de Villiers Morrison, Deputy Minister of Health and Welfare, hereby promulgate the following regulations, which shall apply to the area of jurisdiction of the Municipality of Lydenburg from the date of publication hereof:

MUNICIPALITY OF LYDENBURG.—SMOKE
CONTROL REGULATIONS

1. In these regulations, unless the context otherwise indicates—

“Council” shall mean the Town Council of Lydenburg;

“Act” shall mean the Atmospheric Pollution Prevention Act, 1965 (Act 45 of 1965);

and any other word or expression to which a meaning has been assigned in the Act shall bear such meaning.

2. (1) Save as provided in subregulation (2), no owner or occupier of any premises shall, except for an aggregate period not exceeding three minutes during any continuous period of 30 minutes, permit the emission or emanation from such premises of smoke of such density or content as will obscure light to an extent greater than 40 per cent.

(2) The provisions of subregulation (1) shall not apply to smoke emanating or emitted in contravention of the said subregulation from a fuel-burning appliance during the start-up period or, if such emanation or emission could not reasonably have been prevented, while such appliance is being overhauled or during the period of any breakdown or stoppage of such appliance.

3. No person shall install or cause or permit to be installed or alter or extend or cause or permit to be altered or extended any fuel-burning appliance designed to burn solid or liquid fuel in or on any premises, unless the plans and specifications in respect of such installation, alteration or extension have been approved by the Council.

MUNISIPALITEIT VAN LYDENBURG.—REGULA-

1. In hierdie regulasies, tensy uit die samehang anders blyk, beteken—

“Wet” die Wet op Voorkoming van Lugbesoedeling, 1965 (Wet 45 van 1965);

2. (1) Behoudens die bepalings van subregulasie (2), mag geen eienaar of okkupeerder van enige perseel toelaat dat rook wat so 'n digtheid of inhoud het dat dit lig in groter mate as 40 persent verdonker, uit so 'n perseel uitgelaat of afgegee word nie, behalwe vir 'n totale tydperk van hoogstens drie minute gedurende elke aaneenlopende tydperk van 30 minute.

(2) Die bepalings van subregulasie (1) is nie van toepassing nie op rook wat strydig met daardie subregulasie uit 'n brandstofverbruikende toestel afgegee of uitgelaat word terwyl dit aan die gang gesit word of, indien sodanige afgee of uitlating nie redelikerwys verhoed kon geword het nie, terwyl sodanige toestel nagegaan word of gedurende die tydperk wanneer bedoelde toestel tot stilstand kom of onklaar raak.

3. Niemand mag 'n brandstofverbruikende toestel wat ontwerp is om vaste of vloeibare brandstof in of op 'n perseel te verbruik, inrig of laat inrig of toelaat dat dit ingerig word of dit verander of uitbrei of laat verander of uitbrei of toelaat dat dit verander of uitgebrei word nie, tensy die planne en spesifikasies ten opsigte van sodanige inrigting, uitbreiding of verandering deur die raad goedgekeur is.

4. If any fuel-burning appliance has been installed, altered or extended in contravention of regulation 3, the Council may by notice in writing require the owner or occupier of the premises in question to remove such fuel burning appliance from such premises at his own expense and within a period specified in such notice.

5. The owner or occupier of any premises in or on which any fuel-burning appliance is used shall, if so requested by the Council in writing, install, maintain and use at his own expense such apparatus as may be determined by the Council, for the purpose of indicating or recording or both indicating and recording the density or colour of the smoke emitted by such appliance or for the purpose of facilitating the observance of such smoke with a view to determining the density or colour thereof, and shall make available to the Council at all reasonable times any information recorded or ascertained by means of such apparatus.

6. The provisions of these regulations shall not apply to smoke emitted from any dwelling-house or to the installation, alteration or extension of any fuel-burning appliance in any dwelling-house.

7. (1) No person shall burn any waste material, rubbish or garden refuse, including grass cuttings, prunings or any similar material, in or on any premises or part thereof, and no owner, occupier or person in control of any premises or part thereof shall allow any waste material, rubbish or garden refuse, including grass cuttings, prunings or any similar material, to be burnt in or on such premises or part thereof, except in an incinerator duly approved for such purpose in terms of these regulations.

(2) In any proceedings under this regulation it shall not be a defence to prove that the accused did not know of, was not aware of, did not permit or prohibited any of the acts mentioned herein.

8. Any person may apply in writing to the Council for temporary exemption of any fuel-burning appliance or any premises from the provisions of regulation 2. If the Council is satisfied that there are adequate reasons for such exemption it may, by notice in writing to the applicant, grant such exemption for a specific period.

9. Any person who contravenes any provision of these regulations shall be guilty of an offence and liable on a first conviction to a fine not exceeding R200 or, in default of payment, to imprisonment for a period not exceeding six months, and, on a second or subsequent conviction, to a fine not exceeding R1 000 or, in default of payment, to imprisonment for a period not exceeding twelve months.

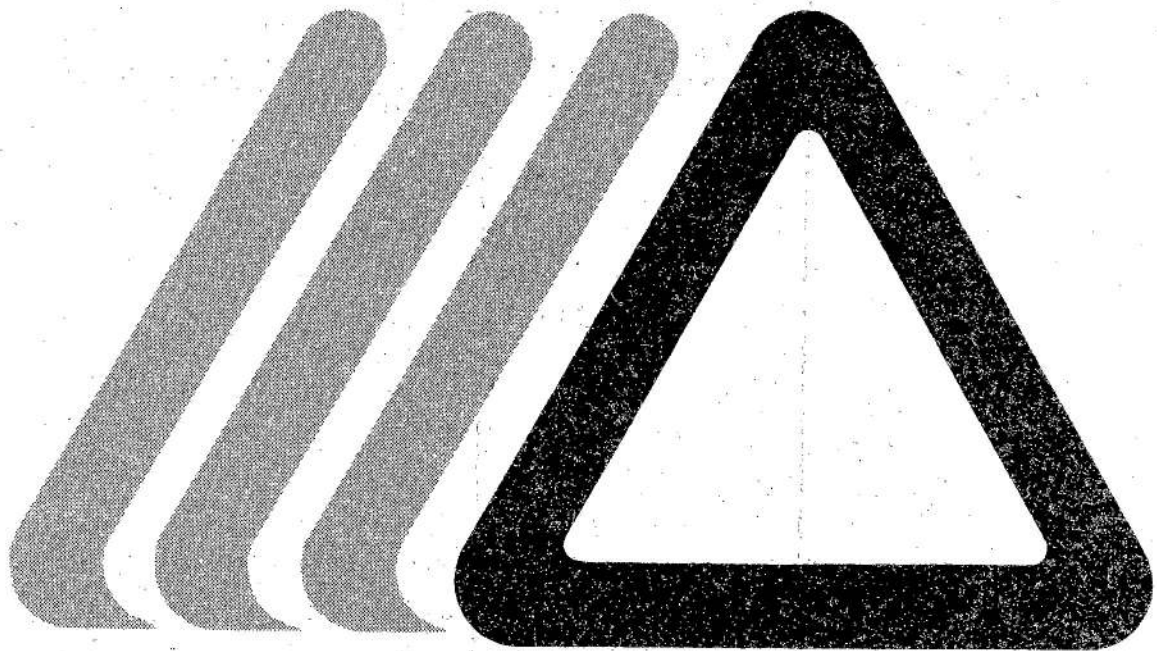
