**WINE AND SPIRIT CONTROL ACT, 1970
(ACT 47 OF 1970)**

MINIMUM PRICE FOR WINE INTENDED FOR DISTILLATION PURPOSES, PERIOD WITHIN WHICH PURCHASE PRICE SHALL BE PAID AND THE INTEREST PAYABLE ON ARREAR PAYMENTS

In terms of section 5 (1) of the Wine and Spirit Control Act, 1970 (Act 47 of 1970), I Gert Jeremias Kotzé, Deputy Minister of Agricultural Economics, acting on behalf of the Minister of Agricultural Economics, hereby make known that the Ko-operatiewe Wijnbouwers Vereniging van Zuid-Afrika, Beperkt, has, under the powers vested in it by the said section, determined in respect of the year commencing on 1 January 1985—

(a) the fixed minimum price to be charged by it to wholesale traders for wine intended for distillation purposes at R27,50 per hectolitre, calculated at a strength of 10 per cent alcohol by volume;

(b) the period within which the purchase price of such wine shall be paid, viz on the last day of the month immediately succeeding the month in which delivery was made; and

(c) the interest which shall be paid on all arrear payments (including interest), at the rate of 26 per cent per annum, calculated from the day following the date on which a payment becomes due until the date of payment.

In this notice the word "strength" shall have the meaning assigned to it in section 14 of the said Act.

Ingevolge artikel 5 (1) van die Wet op Beheer oor Wyn en Spiritus 1970 (Wet 47 van 1970) maak ek Gert Jeremias Kotzé, Adjunk-minister van Landbou-ekonomie, handelende namens die Minister van Landbou-ekonomie, hierby bekend dat die Ko-operatiewe Wijnbouwers Vereniging van Zuid-Afrika, Beperkt, kragtens die bevoegdheid hom verleen by gemelde artikel, ten opsigte van die jaar wat begin op 1 Januarie 1985—

(a) die vasgestelde minimum prys wat groothandelaars deur hom gevra gaan word vir wyn wat vir distillerings-doeleindes bestem is, bepaal het op R27,50 per hektoliter, bereken teen 'n sterkte van 10 persent alkohol volgens volume;

(b) die tydperk bepaal het waarin die koopprys van sodanige wyn betaal moet word, naamlik op die laaste dag van die maand wat onmiddellik volg op die maand waarin aflewering plaasgevind het; en

(c) die rente wat op alle agterstallige betalings (insluitend rente) betaal moet word, bepaal het teen 26 persent per jaar, bereken vanaf die dag wat volg op die datum waarop 'n betaling opeisbaar word tot op die datum waarop die betaling geskied.

In hierdie kennisgewing het die woord "sterkte" die betekenis in artikel 14 van die genoemde Wet daaraan geheg.

AMENDMENT OF THE REGULATIONS FOR THE ADMINISTRATION AND CONTROL OF TOWNSHIPS IN BLACK AREAS

I, Samuel Johannes de Beer, Deputy Minister of Education and Co-operation, acting on behalf and by direction of the Minister of Co-operation, Development and Education, do hereby, by virtue of the powers vested in him by section 30 (2) of the Black Administration Act, 1927 (Act 38 of 1927), read with section 2 (2) of the Laws on Co-operation and Development Amendment Act, 1984 (Act 83 of 1984), amend, with effect from the date of publication hereof, the Regulations for the Administration and Control of Townships in Black Areas, published under Proclamation R. 293 of 1962, to the extent set out in the accompanying Schedule.

SCHEDULE

CHAPTER 1: GENERAL

1. Regulation 1:

Substitute the following definition for the definition of "general plan":

"general plan" means a plan of the township or of a portion thereof approved by the Minister, indicating the relative positions and dimensions of the streets, blocks, parks and sites situated within such township and signed by a land surveyor where such plan was drawn from a survey done by the land surveyor personally or under his personal supervision or, where such plan is compiled from particulars obtained from a survey or surveys done by any other land surveyor or land surveyors;"

CHAPTER 2: TOWNSHIP ADMINISTRATION

2. Regulation 3:

Substitute the following regulation for regulation 3 of Chapter 2:

"Demarcation of sites"

3. The commissioner may cause sites in a township to be demarcated by a surveyor in accordance with a lay-out plan approved by the Director-General."

In regulation 4 (2) (a) of the Afrikaans text substitute for the word "opmeter" the word "landmeter".

4. Regulation 12:

In regulation 12 of Chapter 2 delete the expressions "or grantee", "or deed of grant" and "or of the Director-General in the case of a site held under a deed of grant".

5. Regulation 23:

Regulation 23 of Chapter 2 is amended—

(a) by the deletion of subregulation (2);

(b) by the deletion in subregulation (3) of the expressions "or of a deed of grant", "or (2)", "or (2)", "or grantee, as the case may be" and "or grantee";

(c) by the deletion of subregulation (5);

(d) by the deletion in subregulation (6) of the expression "declared forfeited under subregulation (2) or is".

1. Definitions.

In these regulations "the Act" shall mean the Health Act, 1977 (Act 63 of 1977), and any expression to which a meaning has been assigned in the Act shall have such meaning and, unless the context otherwise indicates—

"birth" shall mean the birth of a live-born child, including the birth of a still-born child from a gestation of not less than 26 weeks;

"midwife" shall mean a person registered or enrolled as such in terms of section 16 of the Nursing Act, 1978 (Act 50 of 1978), including an accoucheur.

2. (a) Any medical practitioner or midwife who is present at the birth of a child in the area of jurisdiction of the local authority mentioned in Annexure A of these regulations shall notify the particulars required by Annexure B hereof to the office of the health department, or an appropriate section of such local authority, in accordance with the provisions of these regulations.

(b) Subject to the provisions of paragraph (c), such notification shall—

(i) if verbal or in writing by hand, be furnished not later than the first working day of the local authority concerned following the birth; or

(ii) if furnished by post, be posted within 24 hours after the birth.

(c) Where circumstances prevail that prevent such notification within the time limit prescribed in paragraph (b), it shall be furnished forthwith when circumstances do permit.

3. In the event of no medical practitioner or midwife being present at the birth of a child, it shall be the duty of the father of such child or, in the event of the death or absence or other inability of the father, the mother of such child or, in the event of the death or inability of the mother, any person present at the birth or the occupier of the dwelling in which such child is born or, in the event of the death or absence or other inability of such occupier, the person having charge of such child to act *mutatis mutandis* in terms of the provisions of regulation 2.

4. (a) The provisions of these regulations shall be in addition to and not in substitution for any provisions of another law relating to the registration of births.

(b) A registrar or assistant registrar of births and deaths referred to in the Births, Marriages and Deaths Registration Act, 1963 (Act 81 of 1963), or a person authorised in writing by such registrar or assistant registrar may at all reasonable time examine and extract or copy any notification received by a local authority in terms of these regulations or any register in which such notifications are recorded.

PETROLEUM PRODUCTS ACT, 1977

REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS

The Minister of Mineral and Energy Affairs has, under section 4A of the Petroleum Products Act, 1977 (Act 120 of 1977), made the regulations in the Schedule.

SCHEDULE

1. In these regulations, unless the context otherwise indicates, "the Act" means the Petroleum Products Act, 1977 (Act 120 of 1977), and any expression to which a meaning has been assigned in that Act bears, when used in these regulations, the meaning so assigned thereto.

2. No person shall, except with the written permission of the Minister, publish, release, announce, disclose or convey information or make comment regarding—

(a) the taking place and particulars of negotiations in respect of the acquisition of petroleum products for the Republic;

(b) any other business transaction in connection with any such petroleum product for the Republic;

(c) the source of any petroleum product acquired or manufactured or being acquired or manufactured for or in the Republic;

(d) the transportation or destination of petroleum products for the Republic;

(e) the storage or stocklevel of any petroleum products acquired or manufactured or being acquired or manufactured for or in the Republic;

(f) the consumption of any petroleum product acquired or manufactured or being acquired or manufactured for or in the Republic;

(g) the quantity of any petroleum product acquired or manufactured or being acquired or manufactured for or in the Republic.

3. Government Notice R. 1129, dated 24 May 1985, is hereby repealed.

(e) die opberging of voorraadpeil van enige petroleumprodukte wat vir of in die Republiek verkry of vervaardig is of word;

(f) die verbruik van enige petroleumprodukt wat vir of in die Republiek verkry of vervaardig is of word;

(g) die hoeveelheid van enige petroleumprodukt wat vir of in die Republiek verkry of vervaardig is of word;

publiseer, beskikbaar stel, bekend maak, medeel of oordra of kommentaar met betrekking daartoe lewer nie.

TRADE PRACTICES ACT, 1976

DECLARATION OF TRADE PRACTICE (MILK CULTURE SCHEME) AS A REVOLVING SCHEME.— SEQUESTRATION OF ESTATE OF A. A. NIEUWOUDT

I, David Jacobus de Villiers, Minister of Trade and Industry, by virtue of the powers vested in me by section 15A of the Trade Practices Act, 1976 (Act 76 of 1976)—

(a) hereby declare the trade practice generally known as a milk culture scheme and conducted by Kubus Kwekery (Edms.) Bpk. and whereby—

(i) goods are sold by a seller subject to a condition that those goods, or any product or derivative thereof are to be resold to the seller;

(ii) the goods, or any product or derivative thereof resold as contemplated in subparagraph (i) are again sold by the seller in accordance with subparagraph (i);

(iii) the price for which the goods, or any product or derivative thereof are resold, as contemplated in subparagraph (i), is determined, or in effect determined, by the seller;

(iv) the goods, or any product or derivative thereof are also to be intended for export or for the manufacture of any product, or derivative, or are either directly or indirectly purported to be so intended;

(v) purchasers of goods which have been resold to a seller as contemplated in subparagraph (i) are being paid by the seller either directly or indirectly from the proceeds of—

(aa) the sale of such goods, or any product or derivative thereof to that purchaser or other purchasers; or

(bb) the sale or manufacture of any portion, product or derivative of the goods contemplated in subparagraph (iv), or it is purported either directly or indirectly that such purchasers are to be so paid; and

(vi) the price of the goods, or any product or derivative thereof in the case of any sale thereof as contemplated herein, exceeds a reasonable price taking into consideration the market value thereof,

be declared a revolving scheme in accordance with the intention of the aforementioned Act.

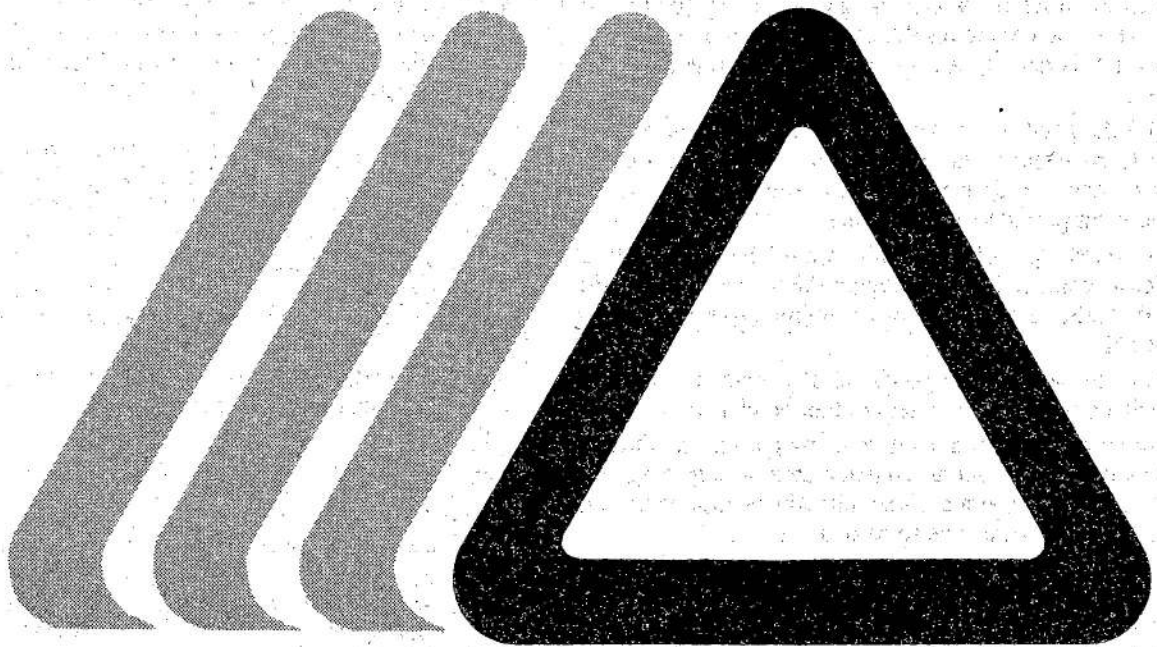
