#### BYLAE

PETROLEUM PRODUCTS ACT, 1977

REGULATIONS IN RESPECT OF  
PETROLEUM PRODUCTS

The Minister of Mineral and Energy Affairs has, in terms of section 2 (1) (d) of the Petroleum Products Act, 1977 (Act 120 of 1977), made the regulations set out in the Schedule.

#### SCHEDULE

1. In these regulations any word or expression to which a meaning has been assigned in the Petroleum Products Act, 1977 (Act 120 of 1977) shall bear such meaning and, unless the context otherwise indicates—
  - 1.1 "outlet", in relation to petrol, means any place where petrol is sold, or is offered for sale to consumers;
  - 1.2 "petrol" includes any mixture of petrol with any other substance, which can be used as fuel for the operation of a spark ignition engine;
  - 1.3 "reseller", in relation to the supply of petrol, means any person who, whether or not he operates a petrol pump by arrangement with a wholesale distributor, obtains petrol directly or indirectly from a wholesale distributor and sells it in the course of or as part of the activities of a business carried on by him;
  - 1.5 "wholesale distributor" means any of the following companies:
    - 1.6.1 BP Southern Africa (Pty) Ltd;
    - 1.6.2 BP South West Ltd;
    - 1.6.3 Caltex Oil (SA) (Pty) Ltd;
    - 1.6.4 Caltex Oil (SWA) (Pty) Ltd;
    - 1.6.5 Esso South Africa (Pty) Ltd;

No wholesale distributor of petrol shall supply petrol to any business or undertaking conducted at any outlet if petrol is supplied at such outlet in a manner prohibited in paragraph 2.</p> |
