AMENDMENT OF THE KANGWANE CONSTITUTION
PROCLAMATION, 1977 (PROCLAMATION R. 214 OF
1977), AS AMENDED

Under and by virtue of the powers vested in me by section 1 (2) of the National States Constitution Act, 1971 (Act 21 of 1971), I hereby amend Schedule I to the KaNgwane Constitution Proclamation, 1977 (Proclamation R. 214 of 1977), as amended, by the additioning of the area described in paragraph (d) of the attached Schedule, after paragraph (c) thereof.

SCHEDULE

(d) The area in the Nsikazi Reserve in the White River District bounded as follows:

From the cement beacon situated on the boundary of the Kruger National Park and approximately 15 metre to the north of the Provincial bitumenized road at Numbi Gate; thence in a general north-westerly direction approximately 15 metre from the northern edge of the said road and parallel to it to the point where it joins the bitumenized road from Bosbokrand to White River; thence across the last-mentioned bitumenized road to the cement beacon situated 15 metre to the west of it; thence along the road from Bosbokrand to White River and parallel to it in a general southerly direction for approximately 4 285 metre to the cement beacon which is also situated 15 metre to

(d) Die gebied in die Nsikazireserwe in die distrik Witrivier soos volg begrens:

Vanaf die sementbaken wat op die grens van die Nasionale Krugerpark en ongeveer 15 meter ten noorde van die Provinciale teerpad by Numbihek geleë is; daarvandaan ongeveer 15 meter vanaf die noordelike kant van genoemde pad en parallel daarmee in 'n algemeen noordwestelike rigting tot waar dit aansluit by die teerpad tussen Bosbokrand en Witrivier; daarvandaan oor laasgenoemde teerpad tot by die sementbaken wat 15 meter wes daarvan geleë is; daarvandaan parallel met die kant van die teerpad tussen Bosbokrand en Witrivier in 'n algemeen suidelike rigting oor ongeveer 4 285 meter tot by die sementbaken wat ook 15 meter ten weste van genoemde pad

the west of the said road; thence in a straight line in a westerly direction for approximately 1 800 metre to the cement beacon situated on the eastern boundary of the farm Burger's Hall No. 21-JU; thence in a north-easterly direction along the eastern boundary of the farm Burger's Hall No. 21-JU to a cement beacon on the bank of the North Sand River; thence along the North Sand River to a point 200 metre south of the southern road reserve boundary of the Hazyview-Skukuza bitumenized road; thence eastwards along a straight line to a point on the east boundary of Lot 146 Kaapsche Block E, 200 metre south of the said southern road reserve boundary situated also on the boundary of the Kruger National Park; thence in a general southerly direction along the boundary of the Kruger National Park to the point of commencement.

LIVESTOCK IMPROVEMENT ACT, 1977 (ACT 25 OF 1977)

LIVESTOCK IMPROVEMENT REGULATIONS.—AMENDMENT

The Deputy Minister of Agriculture, acting on behalf of the Minister of Agriculture under section 34 of the Livestock Improvement Act, 1977 (Act 25 of 1977), has made the regulations set out in the Schedule.

SCHEDULE

Definitions

1. In this Schedule "the Regulations" means the regulations published by Government Notice R. 1181 of 20 June 1986.

Institution of Table A of the Regulations

2. The following table is hereby substituted for Table A of the regulations:
