DECLARATION OF PEACE OFFICERS IN TERMS OF SECTION 334 OF THE CRIMINAL PROCEDURE ACT, 1977 (ACT 51 OF 1977)

Under and by virtue of the powers vested in me by section 334 (1) (a) of the Criminal Procedure Act, 1977, I, Hendrik Jacobus Coetsee, Minister of Justice, hereby amend the Schedule to Government Notice R. 159 of 2 February 1979, as amended, as follows:

By the insertion after item (v) in column 3, opposite item (a) in column 1 of Part 5, of the following items:

- "(vi) the Machinery and Occupational Safety Act, 1983 (Act 6 of 1983);
- (vii) the National Building Regulations and Building Standards Act, 1977 (Act 103 of 1977), in respect of which section 24 of the said Act applies."
