The Minister of Home Affairs has, in terms of section 40 of the South African Citizenship Act, 1949 (Act 44 of 1949), made the regulations as set out in the Schedule hereto.

Definitions

1. (1) In these regulations, unless the context otherwise indicates, a word or an expression to which a meaning has been assigned in the Act shall have that meaning, and—

- (a) "Director-General" shall mean the Director-General of Home Affairs or any person acting by virtue of delegation or by direction of the Director-General of Home Affairs;
- (b) "South African Consulate" shall mean a Union consulate, the office of any South African consular official and also the office of a Diplomatic Mission, Ambassador, Minister, Commissioner, Vice-Consul or Trade Commissioner;

Woordoms krywing

1. (1) In hierdie regulasies, tensy uit die samehang anders blyk, het 'n woord of uitdrukking waaraan daar in die Wet 'n betekenis geheg is, daardie betekenis, en beteken—

- (a) "die Wet" die Wet op Suid-Afrikaanse Burgerskap, 1949 (Wet 44 van 1949);
- (b) "Direkteur-generaal" die Direkteur-generaal van Binnelandse Sake of iemand wat kragtens 'n delegasie of in opdrag van die Direkteur-generaal van Binnelandse Sake optree;

(c) "the Act" shall mean the South African Citizenship Act, 1949 (Act 44 of 1949).

(2) Unless the context otherwise indicates, a reference in these regulations—

- (a) to a section by a specific number shall be interpreted as a reference to the section of that number in the Act; and
- (b) to a form by a specific number shall be interpreted as a reference to the form which in essence corresponds to the form of that number in the Annexure to these regulations.

Registration of a birth that occurred abroad

2. (1) An application for the registration of the birth of a child referred to in section 6 (1) (a) shall be submitted to the office of a South African Consulate (for forwarding to the Director-General, Private Bag X114, Pretoria, 0001) or to any office of the Department of Home Affairs in the Republic or to the office of the Director-General in Pretoria.

(2) If a birth is registered in terms of section 17A of the Registration of Births, Marriages and Deaths Act, 1963 (Act 81 of 1963), the Director-General shall on application issue a certificate of acknowledgement of South African citizenship in terms of regulation 10 (4), and mail or hand it to the parent or guardian of the child concerned.

Certificate of naturalisation

3. (1) Application for a certificate of naturalisation as a South African citizen in terms of section 10 shall be made on form B-I 63.

(2) Application for a certificate of naturalisation as a South African citizen with regard to a minor child in terms of section 10 (4) shall be made on Part II of form B-I 63.

(3) A certificate of naturalisation as a South African citizen in terms of section 10 shall be issued on form B-I 64.

Oath of allegiance

4. The oath of allegiance as prescribed in the First Schedule to the Act shall be taken before a Commissioner of Oaths or Justice of the Peace on form B-I 75.

Declaration of renunciation of South African citizenship

5 (1) A declaration of renunciation of South African citizenship in terms of section 16 (1) shall be made on form B-I 246.

(2) The completed declaration form referred to in sub-regulation (1) shall be forwarded in duplicate to the Director-General, Private Bag X114, Pretoria, 0001.

(3) On receipt of the declaration form referred to in sub-regulation (1) the Director-General shall record the fact that it has been duly registered, forward one copy to the person who made the declaration and file the other copy with his records.

Declaration of resumption of South African citizenship

6. (1) A declaration of intention of resuming South African citizenship in terms of sections 16 (4), 19bis (3) and 20bis (2) shall be made on Form B-I 151.

(c) "Suid-Afrikaanse Konsulaat" 'n Unie-konsulaat, die kantoor van enige Suid-Afrikaanse konsulêre beampte en ook die kantoor van 'n diplomatieke Missie, Ambassadeur of Minister, Kommissaris, Visekonsul of Handelskommissaris.

(2) Tensy uit die samehang anders blyk, word 'n verwysing in hierdie regulasies—

- (a) na 'n artikel met 'n bepaalde nommer uitgelê as 'n verwysing na die artikel met daardie nommer in die Wet; en
- (b) na 'n vorm met 'n bepaalde nommer uitgelê as 'n verwysing na die vorm wat in wese ooreenstem met die vorm met daardie nommer in die Aanhangsel van hierdie regulasies.

Registrasie van 'n geboorte wat in die buiteland plaasgevind het

2. (1) 'n Aansoek om die registrasie van die geboorte van 'n kind soos bedoel in artikel 6 (1) (a) moet by die kantoor van 'n Suid-Afrikaanse Konsulaat (vir deursending aan die Direkteur-generaal, Privaatsak X114, Pretoria, 0001) of by enige kantoor van die Departement van Binnelandse Sake in die Republiek of by die kantoor van die Direkteur-generaal in Pretoria ingedien word.

(2) Indien 'n geboorte ingevolge artikel 17A van die Wet op die Registrasie van Geboortes, Huwelike en Sterfgevallen, 1963 (Wet 81 van 1963), geregistreer word, reik die Direkteur-generaal op aansoek 'n sertifikaat van erkenning van Suid-Afrikaanse burgerskap ooreenkomstig regulasie 10 (4) uit en pos of oorhandig dit aan die ouer of voog van die betrokke kind.

Sertifikaat van naturalisasie

3. (1) Aansoek om 'n sertifikaat van naturalisasie as 'n Suid-Afrikaanse burger ingevolge artikel 10 moet op vorm B-I 63 gedoen word.

(2) Aansoek om 'n sertifikaat van naturalisasie as 'n Suid-Afrikaanse burger ten opsigte van 'n minderjarige kind ingevolge artikel 10 (4) moet op Deel II van vorm B-I 63 gedoen word.

(3) 'n Sertifikaat van naturalisasie as 'n Suid-Afrikaanse burger ingevolge artikel 10 moet op vorm B-I 64 uitgereik word.

Eed van getrouheid

4. Die eed van getrouheid soos voorgeskryf in die Eerste Bylae van die Wet moet afgelê word voor 'n Kommissaris van Ede of Vrederegter op vorm B-I 75.

Verklaring van afstanddoening van Suid-Afrikaanse burgerskap

5. (1) 'n Verklaring van afstanddoening van Suid-Afrikaanse burgerskap ingevolge artikel 16 (1) moet op vorm B-I 246 afgelê word.

(2) Die ingevulde verklaringsvorm bedoel in subregulasie (1) moet in tweevoud aan die Direkteur-generaal, Privaatsak X114, Pretoria, 0001, gestuur word.

(3) By ontvangs van die verklaringsvorm bedoel in subregulasie (1) teken die Direkteur-generaal die feit aan dat dit behoorlik geregistreer is en stuur een kopie aan die persoon wat die verklaring afgelê het en liasseer die ander kopie by sy rekords.

Verklaring van herneming van Suid-Afrikaanse burgerskap

6. (1) 'n Verklaring van voorneme om Suid-Afrikaanse burgerskap te herneem ingevolge artikels 16 (4), 19bis (3) en 20bis (2) moet op vorm B-I 151 afgelê word.

(2) The completed declaration form referred to in subregulation (1) shall be forwarded in duplicate to the Director-General, Private Bag X114, Pretoria, 0001.

(3) On receipt of the declaration form referred to in subregulation (1) the Director-General shall record the fact that it has been duly registered, forward one copy to the person who made the declaration and file the other copy with his records.

Application for resumption of South African citizenship

7. Application for resumption of South African citizenship in terms of section 25*bis*, shall be made on Form B-I 175.

Declaration not to become a South African citizen automatically

8. (1) A declaration not to become a South African citizen in terms of section 11A (1)/11A (1A) shall be made on Form B-I 334.

(2) The completed declaration form referred to in subregulation (1) shall be forwarded in duplicate to the Director-General, Private Bag X114, Pretoria, 0001, or handed in at his office.

(3) On receipt of the declaration referred to in subregulation (1) the Director-General shall record the fact that it has been duly registered, forward one copy to the person who made the declaration and file the other copy with his records.

Declaration of intention of becoming a South African citizen

9. (1) A declaration of intention of becoming a South African citizen in terms of section 11 A (4), shall be made on Form B-I 327.

(2) The completed declaration form referred to in subregulation (1) shall be forwarded in duplicate to the Director-General, Private Bag X114, Pretoria, 0001, or handed in at his office.

(3) On receipt of the declaration referred to in subregulation (1) the Director-General shall record the fact that it has been duly registered, forward one copy to the person who made the declaration and file the other copy with his records.

Certificates with regard to South African citizenship

10. (1) A certificate of confirmation of South African citizenship issued in terms of section 25 shall be issued on Form B-I 66.

(2) A certificate of resumption of South African citizenship granted in terms of section 25 *bis* shall be issued on Form B-I 237.

(3) A certificate of South African citizenship issued in terms of section 27 shall be issued on Form B-I 66.

(4) A certificate of acknowledgement of South African citizenship in terms of section 6 shall be issued on Form B-I 270.

(2) Die ingevulde verklaringvorm bedoel in subregulasie (1) moet in tweevoud aan die Direkteur-generaal, Privaatsak X114, Pretoria, 0001, gestuur word.

(3) By ontvangs van die verklaringvorm bedoel in subregulasie (1) teken die Direkteur-generaal die feit aan dat dit behoorlik geregistreer is en stuur een kopie aan die persoon wat die verklaring afgelê het en liasseer die ander kopie by sy rekords.

8. (1) 'n Verklaring om nie 'n Suid-Afrikaanse burger ingevolge die bepalings van artikel 11A (1)/11A (1A) te word nie, moet op vorm B-I 334 afgelê word.

(2) Die ingevulde verklaringvorm bedoel in subregulasie (1) moet in tweevoud aan die Direkteur-generaal, Privaatsak X114, Pretoria, 0001, gestuur word of by sy kantoor ingedien word.

(2) Die ingevulde verklaringvorm bedoel in subregulasie (1) moet in tweevoud aan die Direkteur-generaal, Privaatsak X114, Pretoria, 0001, gestuur word of by sy kantoor ingedien word.

(3) By ontvangs van die verklaring bedoel in subregulasie (1) teken die Direkteur-generaal die feit aan dat dit behoorlik geregistreer is en stuur een kopie aan die persoon wat die verklaring afgelê het en liasseer die ander kopie by sy rekords.

Sertifikate ten opsigte van Suid-Afrikaanse burgerskap

10. (1) 'n Sertifikaat van bevestiging van Suid-Afrikaanse burgerskap wat ingevolge artikel 25 uitgereik word, moet op vorm B-I 66 uitgereik word.

(2) 'n Sertifikaat van herneming van Suid-Afrikaanse burgerskap wat ingevolge artikel 25*bis* toegeken word, moet op vorm B-I 237 uitgereik word.

(3) 'n Sertifikaat van Suid-Afrikaanse burgerskap wat ingevolge artikel 27 uitgereik word, moet op vorm B-I 66 uitgereik word.

(4) 'n Sertifikaat van erkenning van Suid-Afrikaanse burgerskap ingevolge artikel 6 moet op vorm B-I 270 uitgereik word.

Certifying of copies of certificates, affidavits and annotations in registers

11. Any copy of a certificate, affidavit or annotation in a register shall be certified in the following manner:

- (3) 'n Suid-Afrikaanse burger wat onmiddellik voor 2 September 1949 'n Unie-staatsburger of Britse onderdaan was ten gevolge van die anneksasie van die Zuid-Afrikaansche en Oranje-Vrystaatse Republieke;

IMPORTANT

RETENTION OF CITIZENSHIP

In terms of section 17 of the South African Citizenship Act, 1949, South African citizens by registration or naturalisation may in certain circumstances lose their citizenship by residence outside South Africa and South-West Africa for a continuous period of at least seven years. When these persons are sojourning abroad they are advised to ascertain from the nearest South African Representative or the Department of Home Affairs, Pretoria, whether they will lose their citizenship and if so, when.

N.B.—The provision that certain persons may lose their South African citizenship by residence outside South Africa, does not apply to—

- (1) a South African citizen by birth or descent;
- (2) a South African citizen who, immediately before 2 September 1949, was a Union national or British subject by virtue of two years' domicile after entry into South Africa or South-West Africa;
- (3) a South African citizen who, immediately before 2 September 1949, was a Union national or British subject in consequence of the annexation of the former Zuid-Afrikaansche and Orange Free State Republics;
- (4) a woman who became a South African citizen by reason of her marriage to a person who, immediately prior to 2 September 1949, was a Union national or a British subject.
