BYLAE

1. In hierdie Bylae beteken "die Regulasies" die regulasies afgekondig by Goewermentskennisgewing R. 2316 van 3 Desember 1976, soos gewysig by Goewermentskennisgewing R. 1733 van 14 Augustus 1981.

2. Regulasie 1 van die Regulasies word hierby gewysig deur na die omskrywing van "beroepsraad" die volgende omskrywings in te voeg:

THE SOUTH AFRICAN MEDICAL AND DENTAL COUNCIL

**REGULATIONS RELATING TO THE CONSTITUTION,
FUNCTIONS, POWERS AND DUTIES OF THE PRO-
FESSIONAL BOARD FOR MEDICAL ORTHOTISTS
AND PROSTHETISTS.—AMENDMENT**

The Minister of National Health and Population Development has, in terms of section 15 (5) of the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), and on the recommendation of the South African Medical and Dental Council, made the regulations contained in the Schedule hereto.

SCHEDULE

1. In this Schedule "the Regulations" shall mean the regulations published under Government Notice R. 2316 of 3 December 1976, as amended by Government Notice R. 1733 of 14 August 1981.

2. Regulation 1 of the Regulations is hereby amended by the insertion of the undermentioned definitions after the definition of "professional board":

"'medical orthotist and prosthetist' means a person whose name appears in the register of medical orthotists and prosthetists kept under section 32 of the Act;

'orthopaedic footwear technician' a person whose name appears in the register of orthopaedic footwear technicians kept under section 32 of the Act;".

3. Regulation 2 of the Regulations is hereby amended by the substitution for subregulation (2) of the following subregulation:

"(2) (a) five medical orthotists and prosthetists elected by medical orthotists and prosthetists;

(b) one orthopaedic footwear technician or a registered medical orthotist and prosthetist who prior to his registration as such had been registered as an orthopaedic mechanician and surgical appliance maker in the branch of surgical bootmaker elected by orthopaedic footwear technicians or medical orthotists and prosthetists who prior to their registration as such had been registered as orthopaedic mechanicians and surgical appliance makers in the branch of surgical bootmaker;".

4. The following regulation is hereby inserted in the Regulations after regulation 2:

"2A. (1) The elections in terms of regulation 2 (2) shall be conducted by the council and, subject to the provisions of subregulation (2), members shall be elected for a period of five years at the end of which period they shall vacate office: Provided that such members shall be eligible for re-election.

(2) Should the initial election of a member referred to in regulation 2 (2) (b) not coincide with an election in terms of regulation 2 (2) (a) the member concerned shall be elected for the unexpired portion of the term of office of the members referred to in regulation 2 (2) (a)."

RULES SPECIFYING THE ACTS OR OMISSIONS IN
RESPECT OF WHICH DISCIPLINARY STEPS MAY BE
TAKEN BY THE PROFESSIONAL BOARD FOR
OPTOMETRY AND THE COUNCIL.—AMENDMENT

The Minister of National Health and Population Development has, in terms of section 50 (2) of the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), approved the rules made by the South African Medical and Dental Council in terms of section 50 (1) of that Act and set out in the Schedule hereto.

SCHEDULE

1. In this Schedule "the Rules" means the rules published under Government Notice R. 2314 of 3 December 1976, as amended by Government Notice R. 2614 of 29 December 1978.

2. The rules are hereby amended by the insertion of the following before "1. Advertising":

"DEFINITION

In these rules 'the Act' means the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), and unless inconsistent with the context—

'practice name' means a practice name as referred to in rule 3, Notes (viii) or (ix), as the case may be."

3. Rule 3 of the Rules is hereby amended—

- (a) by the deletion of the proviso to Note (vii); and
- (b) by the insertion of the following under the heading "Notes":

"(viii) Subject to the provisions of Note (ix) a practice name of an optometric practice of which a registered optometrist—

(aa) is the sole owner shall consist only of one or more first names or initials, or any combination thereof, and the surname of such optometrist, or only the surname of such optometrist and, optionally, together therewith the word 'optometrist'; and

(bb) is not the sole owner shall consist only of one or more first names or initials or any combination thereof and the surnames of some of or all of the registered optometrists associated with such practice and, optionally, together therewith the word 'optometrists' and, as the case may be, the expression 'and partner' or 'fellow-worker' in the singular or plural.

(ix) A practice name which that does not comply with the provisions used at a practice of Note (viii) and that is being used as practice name at a practice immediately prior to the date of commencement of those provisions may, with effect from that date be used as practice name at such practice—

(aa) for a period not exceeding five years without amendment or substitution; or
