(ACT 53 OF 1976)

SOUTH AFRICAN SEED CERTIFICATION
SCHEME.—AMENDMENT

I, André Isak van Niekerk, Deputy Minister of Agricul-
ture, acting on behalf of the Minister of Agriculture under
section 23 of the Plant Improvement Act, 1976 (Act 53 of
1976), hereby amend the South African Seed Certification
Scheme published by Government Notice R. 2566 of 25
November 1983, as amended, to the extent set out in the
Schedule.

SCHEDULE

Definition

1. In this Schedule "the Scheme" means the South Afri-
can Seed Certification Scheme published by Government
Notice R. 2566 of 25 November 1983, as amended by Go-
vernment Notices R. 1196 of 30 May 1985, R. 1660 of 26
July 1985 and R. 2352 of 14 November 1986.

Wysiging van Tabel 2 van die Skema

2. Tabel 2 van die Skema word hierby gewysig deur na die uitdrukkings "*Sorghum bicolor* (L.) Moench—Graansorghum/Grain sorghum" in kolom 1 en "35" in kolom 2, die volgende inskrywings in te voeg:

- (a) in kolom 1: "*Trifolium repens* L.—Witklawer/White clover"; en
- (b) in kolom 2: "40".

Invoeging van Aanhangsel 40 in die Skema

3. Die volgende aanhangsel word hierby na Aanhangsel 39 van die Skema ingevoeg:

"AANHANGSEL 40**VEREISTES BETREFFENDE WITKLAWER
(TRIFOLIUM REPENS L.)****1. Grondvereistes**

1.1 Behoudens die bepalinge van paragraaf 1.2, kan 'n stuk grond slegs as 'n eenheid geregistreer word indien—

- 1.1.1 geen plante van 'n spesie van *Trifolium* gedurende die twee groeiseisoene wat die registrasie daarvan voorafgaan, vir saadproduksie of andersins daarop gevestig was nie; of
- 1.1.2 die plante wat reeds daarop gevestig is, ook gedurende die voorafgaande groeiseisoen vir die produksie van basisaad of gesertifiseerde saad, na gelang van die geval, gebruik is.

1.2 'n Stuk grond wat vir die produksie van saad van 'n bepaalde witklawervariëteit beoog word, mag—

- 1.2.1 in die geval van die beoogde produksie van basisaad, vir hoogstens twee agtereenvolgende groeiseisoene as 'n eenheid geregistreer word indien telersaad van dieselfde variëteit jaarliks daarop gevestig word; en
- 1.2.2 in die geval van die beoogde produksie van gesertifiseerde saad, vir hoogstens drie agtereenvolgende groeiseisoene as 'n eenheid geregistreer word indien basisaad van dieselfde variëteit jaarliks daarop gevestig word: Met dien verstande dat sodanige stuk grond ook as 'n eenheid geregistreer kan word indien basisaad van dieselfde variëteit gedurende die voorafgaande groeiseisoen daarop geproduseer is.

2. Aanplantingsvereistes

- 2.1 Plante moet in rye op 'n eenheid gevestig word.
- 2.2 Alle plantegroei binne 'n afstand van drie meter rondom 'n eenheid moet kort gehou word totdat saad van die plante op die betrokke eenheid geoes is.

3. Isolasiereisies

3.1 'n Eenheid moet deur 'n isolasiegebied omring wees wat—

- 3.1.1 in die geval van die beoogde produksie van basisaad—
 - 3.1.1.1 minstens 200 meter wyd is waar die oppervlakte van die betrokke eenheid twee hektaar of minder is; en
 - 3.1.1.2 minstens 100 meter wyd is waar die oppervlakte van die betrokke eenheid meer as twee hektaar is; en
- 3.1.2 in die geval van die beoogde produksie van gesertifiseerde saad—
 - 3.1.2.1 minstens 100 meter wyd is waar die oppervlakte van die betrokke eenheid twee hektaar of minder is; en
 - 3.1.2.2 minstens 50 meter wyd is waar die oppervlakte van die betrokke eenheid meer as twee hektaar is.

3.2 So 'n isolasiegebied moet vry wees van plante van 'n witklawervariëteit wat op dieselfde tyd as die plante op die betrokke eenheid blom, tensy dit—

- 3.2.1 in die geval van die beoogde produksie van basisaad, van telersaad van dieselfde variëteit gevestig is; en
- 3.2.2 in die geval van die beoogde produksie van gesertifiseerde saad, van basisaad van dieselfde variëteit gevestig is.

Amendment of Table 2 of the Scheme

2. Table 2 of the Scheme is hereby amended by inserting the following entries after the expression "*Sorghum bicolor* (L.) Moench—Graansorghum/Grain sorghum" in column 1 and "35" in column 2:

- (a) in column 1: "*Trifolium repens* L.—Witklawer/White clover"; and
- (b) in column 2: "40".

Insertion of Annexure 40 in the Scheme

3. The following annexure is hereby inserted after Annexure 39 of the Scheme:

"ANNEXURE 40**REQUIREMENTS RELATING TO WHITE CLOVER
(TRIFOLIUM REPENS L.)****1. Land requirements**

1.1 Subject to the provisions of paragraph 1.2, a piece of land may be registered as a unit only if—

- 1.1.1 no plants of any species of *Trifolium* have been established thereon for seed production or otherwise during the two growing seasons preceding the registration thereof; or
- 1.1.2 the plants which are already established thereon have also during the preceding growing season been used for the production of basic seed or certified seed, as the case may be.

1.2 A piece of land which is intended for the production of seed of a particular white clover variety may—

- 1.2.1 in the case of the intended production of basic seed, not be registered as a unit for more than two consecutive growing seasons if breeder seed of the same variety is annually established thereon; and
- 1.2.2 in the case of the intended production of certified seed, not be registered as a unit for more than three consecutive growing seasons if basic seed of the same variety is annually established thereon: Provided that such piece of land may also be registered as a unit if basic seed of the same variety has been produced thereon during the preceding growing season.

2. Planting requirements

- 2.1 Plants shall be established in rows on a unit.
- 2.2 All vegetation within a distance of three meters around a unit shall be kept short until seed has been harvested from the plants on the unit concerned.

3. Isolation requirements

3.1 A unit shall be surrounded by an isolation area which—

- 3.1.1 in the case of the intended production of basic seed—
 - 3.1.1.1 is at least 200 metres wide where the area of the unit concerned is two hectares or less; and
 - 3.1.1.2 is at least 100 metres wide where the area of the unit concerned is more than two hectares; and
- 3.1.2 in the case of the intended production of certified seed—
 - 3.1.2.1 is at least 100 metres wide where the area of the unit concerned is two hectares or less; and
 - 3.1.2.2 is at least 50 metres wide where the area of the unit concerned is more than two hectares.

3.2 Such isolation area shall be free of plants of any white clover variety which flower at the same time as the plants on the unit concerned, unless—

- 3.2.1 in the case of the intended production of basic seed, they have been established from breeder seed of the same variety; and
- 3.2.2 in the case of the intended production of certified seed, they have been established from basic seed of the same variety.

4. Vereistes vir plante

- 4.1 Plante wat op 'n eenheid gevestig is, mag jaarliks vandat die saadoes daarvan verwyder is, tot 15 Oktober van die daaropvolgende groeiseisoen bewei word.
- 4.2 Die aantal afwykende plante op 'n eenheid mag—
- 4.2.1 in die geval van die beoogde produksie van basissaad, nie een plant per 15 vierkante meter oorskry nie; en
- 4.2.2 in die geval van die beoogde produksie van gesertifiseerde saad, nie een plant per 10 vierkante meter oorskry nie.

5. Inspeksievereistes

Plante wat op 'n eenheid gevestig is, moet gedurende die volsaadstadium daarvan geïnspekteer word.

6. Fisiese vereistes

Saad moet—

- 6.1 'n ontkiemingspersentasie van minstens 70 persent hê;
- 6.2 vry van verbode onkruid wees; en
- 6.3 hoogstens—
- 6.3.1 0,2 persent ander saad; en
- 6.3.2 2,0 persent ander materiaal, bevat."

4. Requirements for plants

- 4.1 Plants which are established on a unit may annually be grazed from the time of removal of the seed crop therefrom until 15 October of the following growing season.
- 4.2 The number of deviating plants on a unit shall—
- 4.2.1 in the case of the intended production of basic seed, not exceed one plant per 15 square metres; and
- 4.2.2 in the case of the intended production of certified seed, not exceed one plant per 10 square metres.

5. Inspection requirements

Plants which are established on an unit shall be inspected during the full seed stage thereof.

6. Physical requirements

Seed shall—

- 6.1 have a germination percentage of at least 70 per cent;
- 6.2 be free or prohibited seed; and
- 6.3 not contain more than—
- 6.3.1 0,2 per cent other seed; and
- 6.3.2 2,0 per cent other material."
