REGULATIONS RELATING TO ESTABLISHMENTS, VARIETIES, PLANTS AND PROPAGATING MATE- RIAL.—AMENDMENT

The Deputy Minister of Agriculture, acting on behalf of the Minister of Agriculture under section 34 of the Plant Improvement Act, 1976 (Act 53 of 1976), has made the regulations in the Annexure.

ANNEXURE

Definition

1. In this Annexure "the Regulations" means the regulations published by Government Notice R. 1064 of 23 May 1980, as amended by the regulations published by Government Notices R. 1621 of 22 July 1983, R. 2173 of 28 September 1984, R. 1287 of 14 June 1985 (as corrected by Government Notice R. 1524 of 12 July 1985), R. 1522 of 12 July 1985, R. 256 of 14 February 1986, R. 1489 of 11 July 1986, R. 1903 of 12 September 1986, R. 1389 of 26 June 1987 and R. 1700 of 7 August 1987.

Amendment of regulation 22 of the Regulations

2. Regulation 22 of the Regulations is hereby amended by the substitution for the words preceding paragraph (a) of the following words:

"22. Subject to the provisions of regulation 24, seed of a kind of plant specified in column 1 of Table 4, which has not been certified or prepacked, may be sold without an authority referred to in section 13 of the Act if—".

Insertion of regulation 24 in the Regulations

3. The following regulation is hereby inserted after regulation 23 of the Regulations:

"Certification of seed of certain varieties required

24. Seed of a kind of plant specified in column 1 of Table 8, which is of a variety the designation of which is specified in column 2 of the said Table opposite thereto, may as from the date specified in column 3 of the said Table opposite thereto, be sold without an authority referred to in section 13 of the Act only if that seed is certified in terms of the South African Seed Certification Scheme established under section 23 of the Act."

Amendment of regulation 25 of the Regulations

4. Regulation 25 of the Regulations is hereby amended by the substitution for the words preceding paragraph (a) of the following words:

"25. Subject to the provisions of regulation 24, seed of a kind of plant specified in column 1 of Table 4, which has been prepacked, may be sold without an authority referred to in section 13 of the Act at the establishment where it was prepacked if, at the time of its sale—".

Amendment of regulation 31 of the Regulations

5. Regulation 31 of the Regulations is hereby amended by the substitution for subparagraph (ii) of paragraph (c) of subregulation (2) of the following subparagraph:

"(ii) the bole of such plant up to a height of at least 500 mm above the ground is developed in such a way that it is round;"
